## **Objectives and Investment Policy**

The Fund is a feeder fund of the Luxembourg master fund PARVEST Equity Best Selection World (the «»Master Fund «»). The Fund seeks to increase the value of its assets over the medium term by investing at least 85% of its assets in the Master Fund which invests in shares issued by companies from all over the world with a solid financial structure and/or potential for earnings growth.

The Master Fund may be invested in Mainland China shares restricted to foreign investors such as China A shares which can be listed on a Stock Connect or through a use of a specific license granted by the Chinese authorities.

The Master Fund is actively managed and as such may invest in securities that are not included in the index which is MSCI AC World (NR).

The Fund and Master Fund performance may differ due to ancillary assets held by the Fund, and potential discrepancies in operating expenses across both structures.

A dividend may be distributed.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) unless the net asset value of the Master are not calculated.

- Why is the Fund in this specific category? The risk category is justified by the investment, through the fund's Master, mainly in Stocks and Shares, the value of which can fluctuate considerably. These fluctuations are often amplified in the short term.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- Liquidity Risk: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- <u>Counterparty Risk</u>: This risk is associated with the ability of a counterparty in an Over The Counter financial transaction to fulfil its commitments like payment, delivery and reimbursement.
- <u>Operational and Custody Risk</u>: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- <u>Derivatives Risk</u>: When investing in over the counter or listed derivatives, the Fund aims to hedge and/or to leverage the yield of its position. The attention of the investor is drawn to the fact that leverage increases the volatility of the subfund.
- <u>Risks related to Shanghai Hong Kong Stock Connect:</u> This risk relates to securities trading and clearing through the Stock Connect.Stock Connect is subject to quota limitation which may restrict the fund's ability to invest in China A-Shares on a timely basis. In addition, the Stock Connect is novel in nature, the regulations are untested and there is no certainty as to how they will be applied, which may affect the fund's ability to enforce its rights and interests in the China A-Shares.
