

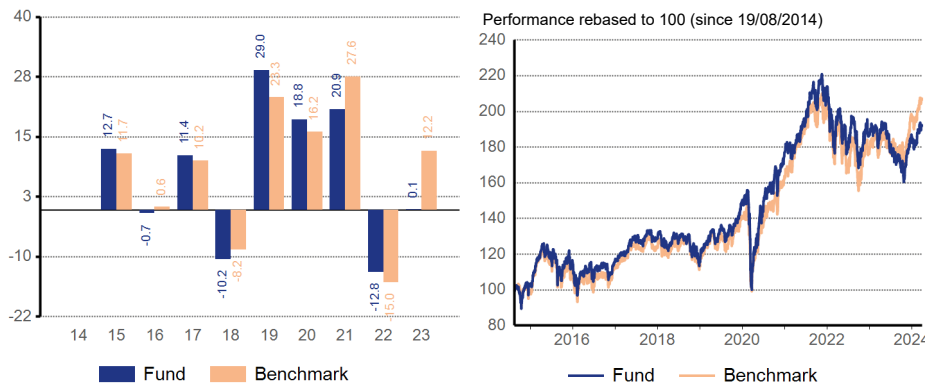

Investment strategy

This Sub-fund aims to achieve long-term capital growth by investing mainly in a diversified portfolio of equity or Equities Related Securities of companies, which are domiciled or exercise the predominant part of their economic activity in the Nordic countries. The fund is managed by the Nordic, Finnish and Swedish Equities Team, based in Stockholm, focusing on fundamental bottom-up research. Alpha is generated through stock selection and by actively incorporating an ESG based analysis as part of the investment process. Actively managed. Benchmark used for performance comparison only. Risk characteristics of the fund's portfolio may bear some resemblance to those of the benchmark.

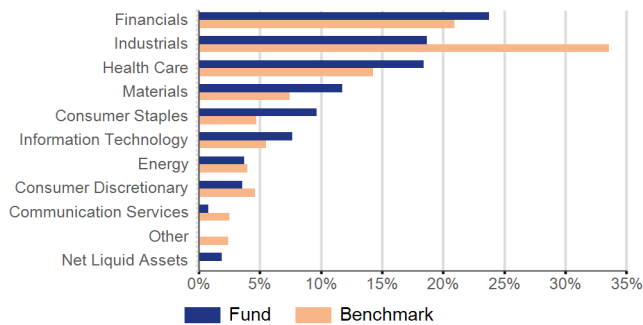

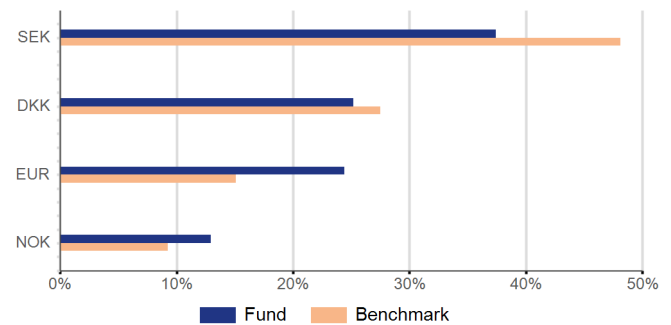

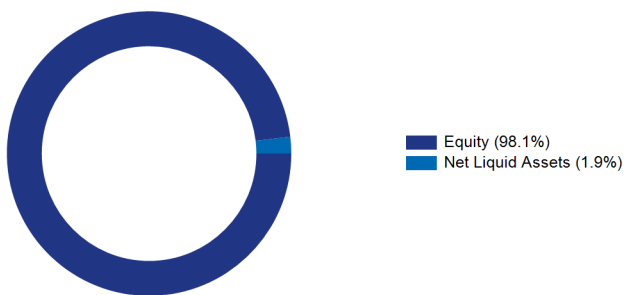
Sector breakdown (in %)



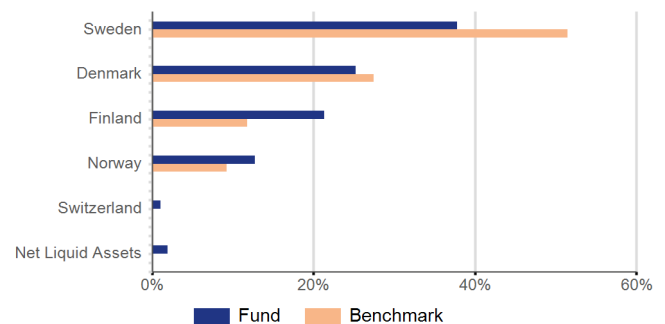
Currency exposure (post-hedge) (in %)



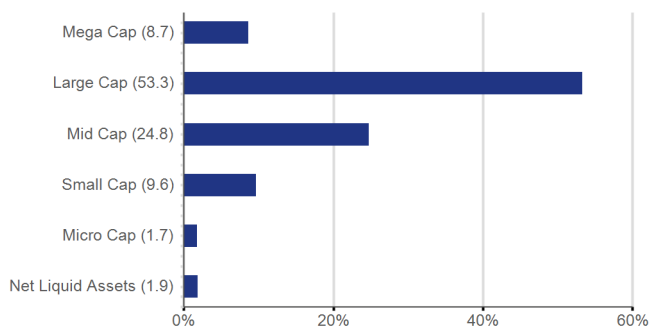
Asset allocation

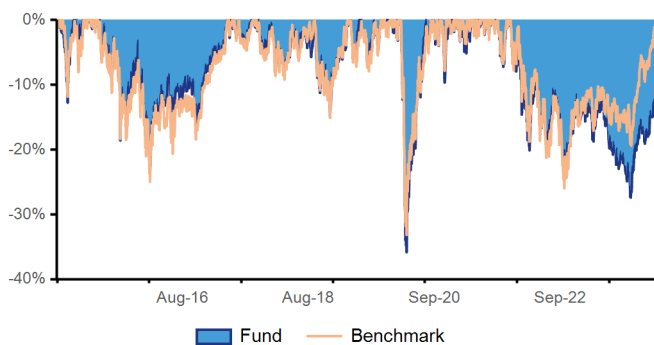

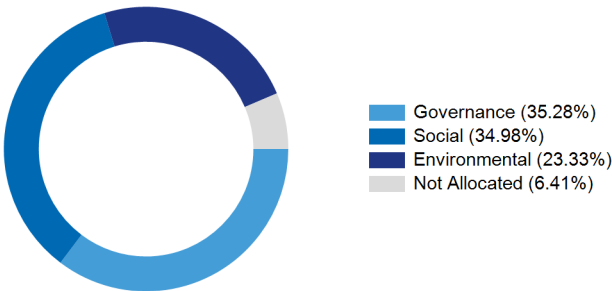

ESG Investment Strategy Summary

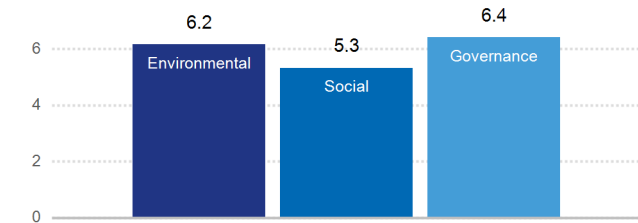
The fund is managed according to the Stars investment strategy which includes a commitment to analyse and select investments that epitomise the ESG characteristics of the fund. The analysis is performed via an enhanced due diligence on material ESG issues that are relevant to the investee company. Furthermore, each company's business model alignment with relevant UN SDGs is taken into consideration as well as the company's approach to managing ESG risks. Depending on the outcome of the analysis, the company will be assigned an ESG score from C to A. Stars eligible investments must have an ESG score in the A or B range.

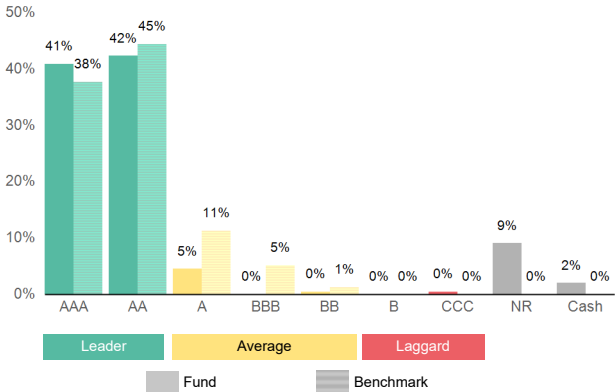

Benchmark: MSCI Nordic 10/40 - Net Return Index

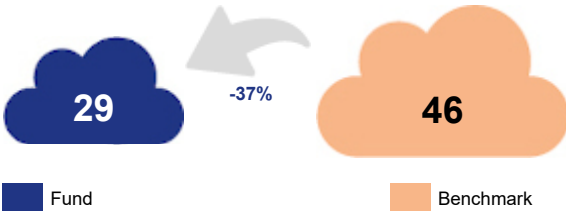
