
Objectives and Investment Policy

- The Compartment seeks capital growth by investing primarily in UCITS funds and other UCIs that pursue alternative asset management strategies.
- The eligible financial instruments are mainly UCITS and/or other regulated UCIs primarily managed by independent investment managers worldwide and pursuing Long/Short Equity and/or Event Driven strategies, as well as transferable securities linked or offering an exposure to the performance of these funds.
- The Compartment may use financial derivative instruments for investment and hedging purposes. The compartment may also invest in structured products.
- The compartment is actively managed by allocating its wealth to selected funds, whose managers may allocate mainly to equity, but also

bond, currency and commodity instruments worldwide, with an absolute return approach.

- The Share class does not in principle distribute a dividend.
- The price of the Share class is calculated on a weekly basis. Investors
 may redeem shares of the Compartment on any Monday that is a
 Luxembourg Business Day with a notice sent on the Monday preceding
 this Redemption Day (or the preceding Business Day if this Monday is
 not a Business Day).
- The price of the Share class may be adjusted to ensure that rebalancing costs caused by subscriptions or redemptions are borne by investors responsible for those flows.
- Recommendation: the Compartment may not be appropriate for investors who plan to withdraw their money within 5 years.

Risk and Reward Profile

- This value is affected by various factors, including:
- The Compartment offers no capital guarantee or asset protection measures.
- The Compartment is actively managed, meaning the investment universe of underlying funds is wide, although the main objective is centred on short/equity and or event driven funds.

- This asset class is subject to political and economic risks which may have an impact on the Compartment's performance and volatility.
- The Compartment may be exposed to currency risk.
- The Compartment may be exposed to concentration risk.
- The underlying funds may employ derivatives exposing the fund indirectly.
- The Compartment's performance should benefit from the active management across asset classes and instruments of the underlying funds.
- The Share class also bears the following risks that are not explained by the synthetic risk indicator:
- Liquidity risk: when market conditions are unusual or a market is characterised by particularly low volumes, the Compartment may encounter difficulties in valuing and/or trading some of its assets, particularly to satisfy large redemption requests.
- Operational risk: the Compartment is subject to the risk of material losses resulting from human error or system failures or incorrect valuation of the underlying securities.
- Counterparty risk: the use of derivatives in the form of contracts with counterparties may imply losses if a counterparty defaults and cannot honour its liabilities.

Charges

One-off charges taken before or after you invest


