Objectives and investment policy

- ▶ The aim is to provide capital growth and income on your investment over time.
- ▶ The fund seeks a portfolio volatility which is lower than that of the MSCI AC World Net. The fund will invest in a combination of both lower and higher volatility equity securities.
- ▶ The fund will invest normally at least 90% of its assets in equity securities (i.e. shares) of companies of any size that are based in developed or emerging markets.
- ▶ Investments in Chinese equities include China A-shares and China B-shares with a maximum exposure of 20% of the fund's assets. The fund may invest up to 10% of its assets in China A-shares through the Shanghai-Hong Kong Stock Connect and have up to 10% of its assets exposed to China A-shares indirectly through China A-shares Access Products ("CAAP").
- ▶ At times the fund may also invest in fixed income securities, money market instruments, cash instruments and cash.
- ▶ The fund may invest up to 10% of its assets in participation notes and convertible securities.
- ▶ The fund may invest no more than 10% of its assets in lower quality debt securities, issued or guaranteed by any single sovereign issuer.
- ▶ The fund may invest up to 10% of its assets in real estate investment trusts ("REITS").
- ▶ The fund may invest up to 10% of its assets in other open-ended funds, including other funds of HSBC.
- ▶ The fund may use derivatives to meet its investment objectives.
- ▶ The fund may also use derivatives for hedging purposes.
- ▶ The fund is actively managed and does not track a benchmark. Consideration may be given to a reference benchmark when selecting investments. The reference benchmark for the fund is MSCI AC World Net.
- ▶ The reference currency of the fund is USD. The reference currency of this share class is USD.
- ▶ Income is rolled up into the value of your investment.
- ▶ You may sell your investment on any working day by submitting an application to the Administrator before the dealing deadline.
- ▶ Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

More about this rating

Why is this fund in category 5?

Equity prices tend to fluctuate more than other asset classes as investors directly participate in underlying companies and their earnings.

Risks materially relevant not adequately captured by the SRRI

- ▶ **Exchange rate risk** Investing in assets denominated in a currency other than that of the investor's own currency perspective exposes the value of the investment to exchange rate fluctuations.
- ▶ **Liquidity risk** Liquidity is a measure of how easily an investment can be converted to cash without a loss of capital and/or income in the process. The value of assets may be significantly impacted by liquidity risk during adverse market conditions.
- ▶ **Emerging market risk** Emerging economies typically exhibit higher levels of investment risk. Markets are not always well regulated or efficient and investments can be affected by reduced liquidity.
- ▶ **Derivative risk** The value of derivative contracts is dependent upon the performance of an underlying asset. A small movement in the value of the underlying can cause a large movement in the value of the derivative. Unlike exchange traded derivatives, over-the-counter (OTC) derivatives have credit risk associated with the counterparty or institution facilitating the trade.
- ▶ **Counterparty risk** The insolvency of any institutions acting as counterparty to derivatives or other instruments or providing security lending services, may expose the fund to financial loss.
- ▶ **Real estate risk** Cost of acquisition and disposal, taxation, planning, legal, compliance and other factors can materially impact real estate valuation.
- ▶ **Operational risk** The main risks are related to systems and process failures. Investment processes are overseen by independent risk functions which are subject to independent audit and supervised by regulators.

Charges for this fund

The charges you pay are used to pay the running costs of the fund, including the marketing and distribution costs. These charges reduce the potential growth of the investment.

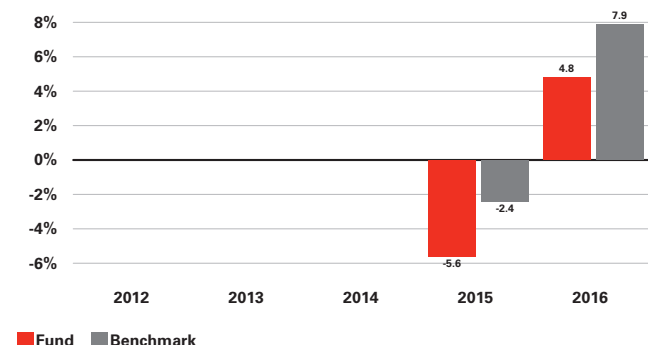
A conversion charge of up to 1% of the Net Asset Value of the Shares which are being converted may be payable to the relevant distributor.
