## Objectives and investment policy

- The aim is to provide capital growth and income on your investment over time.
- The fund seeks a portfolio volatility which is lower than that of the MSCI AC World Net. The fund will invest in a combination of both lower and higher volatility equity securities.
- The fund will invest normally at least 90% of its assets in equity securities (i.e. shares) of companies of any size that are based in developed or emerging markets.
- Investments in Chinese equities include China A-shares and China B-shares with a maximum exposure of 20% of the fund's assets. The fund may invest up to 10% of its assets in China A-shares through the Shanghai-Hong Kong Stock Connect and have up to 10% of its assets exposed to China A-shares indirectly through China A-shares Access Products ("CAAP").
- At times the fund may also invest in fixed income securities, money market instruments, cash instruments and cash.
- The fund may invest up to 10% of its assets in participation notes and convertible securities.
- The fund may invest no more than 10% of its assets in lower quality debt securities, issued or guaranteed by any single sovereign issuer.
- The fund may invest up to 10% of its assets in real estate investment trusts ("REITS").
- The fund may invest up to 10% of its assets in other open-ended funds, including other funds of HSBC.
- The fund may use derivatives to meet its investment objectives.
- The fund may also use derivatives for hedging purposes
- The fund is actively managed and does not track a benchmark. Consideration may be given to a reference benchmark when selecting investments. The reference benchmark for the fund is MSCI AC World Net
- The reference currency of the fund is USD. The reference currency of this share class is USD.
- Income is rolled up into the value of your investment.
- You may sell your investment on any working day by submitting an application to the Administrator before the dealing deadline.
- Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

#### More about this rating

# Risks materially relevant not adequately captured by the SRRI

- **Exchange rate risk** Investing in assets denominated in a currency other than that of the investor's own currency perspective exposes the value of the investment to exchange rate fluctuations.
- Liquidity risk Liquidity is a measure of how easily an investment can be converted to cash without a loss of capital and/or income in the process. The value of assets may be significantly impacted by liquidity risk during adverse market conditions.
- **Emerging market risk** Emerging economies typically exhibit higher levels of investment risk. Markets are not always well regulated or efficient and investments can be affected by reduced liquidity.
- Derivative risk The value of derivative contracts is dependent upon the performance of an underlying asset. A small movement in the value of the underlying can cause a large movement in the value of the derivative. Unlike exchange traded derivatives, over-the-counter (OTC) derivatives have credit risk associated with the counterparty or institution facilitating the trade.

- Real estate risk Cost of acquisition and disposal, taxation, planning, legal, compliance and other factors can materially impact real estate valuation.
- Operational risk The main risks are related to systems and process failures. Investment processes are overseen by independent risk functions which are subject to independent audit and supervised by regulators.


A conversion charge of up to 1% of the Net Asset Value of the Shares which are being converted may be payable to the relevant distributor.
