(ISIN:IE00BMBMM132) Man GLG Cred-Eq Alternative (the 'Fund') is a sub-fund of Man Funds VI plc (the 'Company').

Man Asset Management (Ireland) Limited, part of Man Group plc, is the Manager of the Company.

Objectives and investment policy

- The Fund seeks to provide investors with absolute returns over the medium term through investment in convertible, credit and equity asset classes globally. The Fund will invest in a wide range of opportunities globally based on a fundamental analysis of convertible bond issuers. This analysis will result in the Investment Manager identifying assets that it considers to be over- or undervalued which will then determine the relevant investment exposure that the Investment Manager wishes to achieve. The Investment Manager may then obtain such exposure through convertible bonds, or where no suitable convertible bond can be identified, through credit or equity investments.
- The Fund will pursue a 'long-short strategy' whereby, in addition to buying and holding assets, it may use financial derivative instruments (ie instruments whose prices are dependent on one or more underlying assets, 'FDI') to take 'short' positions where the Fund may make money in respect of issuers whose securities the Investment Manager believes to be overvalued or expects to fall in value.
- In addition to investment in convertible bonds, the Fund may also invest in a number of other assets, including listed shares, debt securities, currencies, interest rates and other funds.
- Debt securities can be issued by any government, company or international agency which will not be subject to any rating requirement.

- The Fund may actively use FDI to achieve the investment objective, for hedging a given instrument or against anticipated movements in a market or other sector or where it is more cost effective than directly holding the underlying asset. The use of FDI may multiply the gains or losses made by the Fund on a given instrument or on its investments generally. FDI may allow the Fund to obtain market exposure in excess of the value of the Fund's assets (leverage).
- The Fund may also invest in FDI in order to obtain a return which represents the performance of a representative basket of shares and other instruments.
- The Fund will use FDI to provide investors with a similar return to any share class issued in the working currency of the Fund (EUR).
- Any income earned on investments will be added to the value of investors' shares and investors can buy and sell their shares on each dealing day of the Fund.


