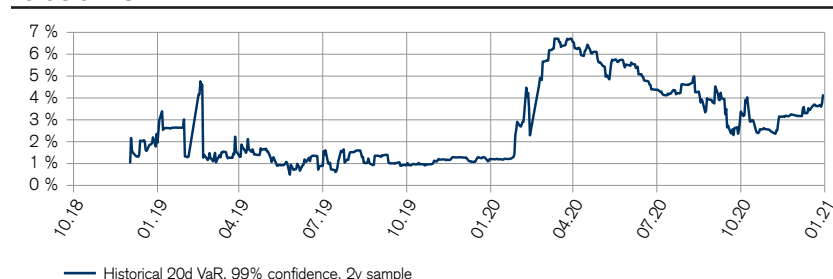
### Net performance in USD (rebased to 100) and yearly performance <sup>2)</sup>



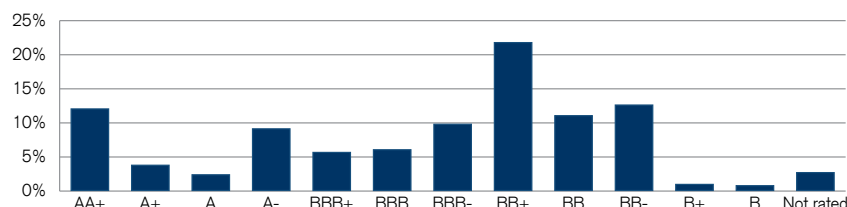

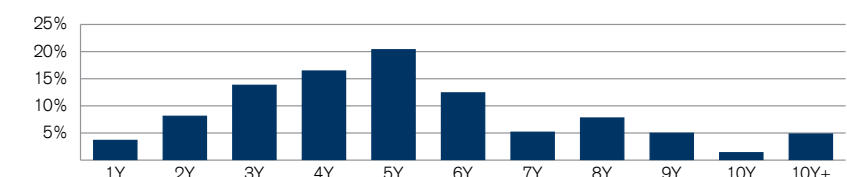
### Value at risk



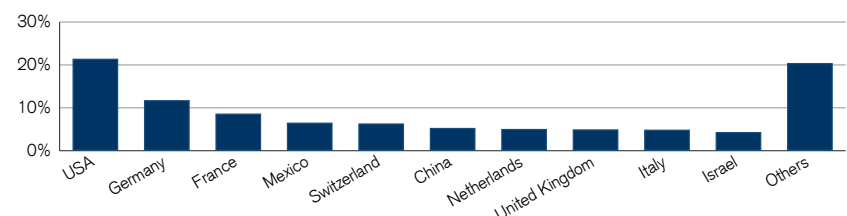
### Rating distribution

## Potential risks
