## Audit report

To the Shareholders of  
**CS Investment Funds 1**

### Our opinion

In our opinion, the accompanying financial statements give a true and fair view of the financial position of CS Investment Funds 1 (the "Fund") and of each of its sub-funds as at 31 October 2019, and of the results of their operations and changes in their net assets for the year then ended in accordance with Luxembourg legal and regulatory requirements relating to the preparation and presentation of the financial statements.

#### *What we have audited*

The Fund's financial statements comprise:

- the Combined Statement of Net Assets for the Fund and the Statement of Net Assets for each of the sub-funds as at 31 October 2019;
- the Combined Statement of Operations / Changes in Net Assets for the Fund and the Statement of Operations / Changes in Net Assets for each of the sub-funds for the year then ended;
- the Statement of Investments in Securities for each of the sub-funds as at 31 October 2019; and
- the notes to the financial statements, which include a summary of significant accounting policies.

### Basis for opinion

We conducted our audit in accordance with the Law of 23 July 2016 on the audit profession (Law of 23 July 2016) and with International Standards on Auditing (ISAs) as adopted for Luxembourg by the "Commission de Surveillance du Secteur Financier" (CSSF). Our responsibilities under the Law of 23 July 2016 and ISAs as adopted for Luxembourg by the CSSF are further described in the "Responsibilities of the "Réviseur d'entreprises agréé" for the audit of the financial statements" section of our report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

We are independent of the Fund in accordance with the International Ethics Standards Board for Accountants' Code of Ethics for Professional Accountants (IESBA Code) as adopted for Luxembourg by the CSSF together with the ethical requirements that are relevant to our audit of the financial statements. We have fulfilled our other ethical responsibilities under those ethical requirements.

### Other information

The Board of Directors of the Fund is responsible for the other information. The other information comprises the information stated in the annual report but does not include the financial statements and our audit report thereon.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information identified above and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit, or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report that fact. We have nothing to report in this regard.

#### **Responsibilities of the Board of Directors of the Fund for the financial statements**

The Board of Directors of the Fund is responsible for the preparation and fair presentation of the financial statements in accordance with Luxembourg legal and regulatory requirements relating to the preparation and presentation of the financial statements, and for such internal control as the Board of Directors of the Fund determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Board of Directors of the Fund is responsible for assessing the Fund's and each of its sub-funds' ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Board of Directors of the Fund either intends to liquidate the Fund or close any of its sub-funds or to cease operations, or has no realistic alternative but to do so.

#### **Responsibilities of the “Réviseur d’entreprises agréé” for the audit of the financial statements**

The objectives of our audit are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an audit report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Law of 23 July 2016 and with ISAs as adopted for Luxembourg by the CSSF will always detect a material misstatement when it exists. Our conclusions are based on the audit evidence obtained up to the date of our audit report. However, future events or conditions may cause the Fund or any of its sub-funds to cease to continue as a going concern;
- evaluate the overall presentation, structure and content of the financial statements, including the disclosures, and whether the financial statements represent the underlying transactions and events in a manner that achieves fair presentation.

We communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit and significant audit findings, including any significant deficiencies in internal control that we identify during our audit.

**General**

CS Investment Funds 1 (the "Company") is an undertaking for collective investment in transferable securities in the legal form of an investment company with variable capital (société d'investissement à capital variable, SICAV) subject to Part I of the Law of December 17, 2010, as amended on undertakings for collective investment ("Law of December 17, 2010") transposing Directive 2009/65/EC of the European Parliament and of the Council of July 13, 2009 on the coordination of laws, regulations and administrative provisions relating to undertakings for collective investment in transferable securities.

As of 31.10.2019 the Company had 13 Subfunds.

**Changes:**

Credit Suisse (Lux) Latin America Corporate Bond Fund was launched on 07.10.2019.

**Summary of significant accounting policies****a) Presentation of financial statements**

The financial statements are presented in accordance with Luxembourg legal and regulatory requirements concerning Undertakings for Collective Investment in Transferable Securities. The financial statements are presented on the basis of the latest net asset value calculated during the financial year (i.e. 31.10.2019).

**b) Computation of the net asset value of each Subfund**

The net asset value of the Shares of each Subfund shall be calculated in the reference currency of the respective Subfund and shall be determined under the responsibility of the Company's Board of Directors in Luxembourg on each banking day in Luxembourg (each such day being referred to as a "Valuation Day"). A banking day is defined as being a day on which banks are normally open for business in Luxembourg. The financial statements reflect the net asset values as of 31.10.2019 based on the market prices of the investments as of 31.10.2019.

The Investment Manager needs to undertake transactions in order to maintain the desired asset allocation as a result of subscriptions or redemptions, which may generate additional costs for the Subfund and its shareholders. As a consequence, in order to protect the existing investors' interest, from these capital movements, when net capital movements exceed a threshold pre-defined by the Board of Directors, an adjustment of the NAV per share used is applied. This adjustment reflects the estimated tax and dealing costs that may be incurred by the Subfund as a result of these transactions, and the estimated bid-off spread of the assets in which the fund invests. A periodical review is undertaken in order to verify the appropriateness of the swing factor being applied.

For the active Subfunds, the Net Asset Value calculated will be increased by up to a maximum of 2% per Share in the event of a net surplus of subscription applications or reduced by up to a maximum of 2% per Share in the event of a net surplus of redemption applications in respect of the applications received on the respective Valuation Day.

The NAV per share as disclosed in the statistical information is the published NAV per share whereas the total net assets disclosed in the statement of net assets is the total net asset value excluding year end swing adjustment.

As per 31.10.2019, no swing pricing was applied on the Subfunds.

**c) Valuation of investment securities of each Subfund**

Securities which are listed on a stock exchange shall be valued at the last traded price. If such a price is not available for a particular trading day, the closing bid price may be taken as a basis for the valuation. If a security is traded on several stock exchanges, the valuation shall be made by reference to the exchange on which it is primarily traded.

In the case of securities for which trading on a stock exchange is not significant although a secondary market with regulated trading among securities dealers does exist, the valuation may be based on this secondary market. Securities traded on a regulated market shall be valued in the same way as securities listed on a stock exchange.

Securities that are not listed on a stock exchange and are not traded on a regulated market shall be valued at their last available market price. If no such price is available, the Company shall value these securities in accordance with other criteria to be established by the Board of Directors and on the basis of the probable sales price, the value of which shall be estimated with due care and in good faith.

Shares and units in UCIs shall be valued on the basis of their most recently calculated net asset value, taking due account of the redemption fee where necessary. Where no net asset value and only buy and sell prices are available, the shares or units in such UCIs may be valued at the mean of such buy and sell prices.

The amounts resulting from such valuations shall be converted into the reference currency of each Subfund at the prevailing mid-market rate.

If a valuation in accordance with the above rules is rendered impossible or incorrect owing to special or changed circumstances, then the Board of Directors of the Company shall be entitled to use other generally recognised and auditable valuation principles in order to value the Subfund's assets. Because of the inherent uncertainty, these estimated values may significantly differ from the values that would have been used had a readily market for the securities existed, and from the values that may be ultimately recovered.

**d) Cash at banks and at brokers**

Cash at banks and at brokers includes cash in hand, margin calls and deposits held at call with banks and bank overdrafts.

**e) Net realised gain/loss on sales of investments of each Subfund**

The realised gains or losses on the sales of securities are calculated on the basis of the average acquisition cost.

**f) Foreign exchange conversion**

The financial statements are kept in the reference currency of each Subfund and the combined financial statements are kept in CHF.

Cash at banks, other net assets and the value of portfolio securities in currencies other than the reference currency of each Subfund are converted into the reference currency at the foreign exchange rate prevailing on the date of valuation. Income and expenses in currencies other than the reference currency of each Subfund are converted into the reference currency at the foreign exchange rate applicable at the date they accrue to the Subfund.

Realised gains or losses on foreign currencies are accounted for in the statement of operations / changes in net assets.

The acquisition cost of securities in currencies other than the reference currency of each Subfund is converted into the reference currency at the foreign exchange rate valid at the date of acquisition.

**g) Transactions on investments in securities of each Subfund**

The transactions on investments in securities are booked on a trade date basis.

**h) Formation expenses of each Subfund**

Formation expenses are amortised over a period of five years.

**i) Valuation of financial futures contracts of each Subfund**

Unmatured financial futures contracts are valued at valuation date at market rates prevailing at this date and resulting changes in unrealised gains or losses are posted to the statement of operations / changes in net assets and are shown under "net unrealised gain/loss on financial futures contracts" in the statement of net assets.

**j) Valuation of forward foreign exchange contracts of each Subfund**

Unmatured forward foreign exchange contracts are valued at valuation date at forward exchange rates prevailing at this date and resulting changes in unrealised gains or losses are posted to the statement of operations / changes in net assets and are shown under "net unrealised gain/loss on forward foreign exchange contracts" in the statement of net assets.

**k) Valuation of swap contracts of each Subfund**

On each valuation day, swap agreements are valued at the net present value of the future cash flows, using the relevant interest rate yield curve on valuation day.

Assets swaps and the securities linked to the assets swaps are not revalued as the security and the asset swap are considered for the purpose of the valuation as a single instrument and unrealised results are posted to the statement of operations / changes in net assets and are shown under "net unrealised gain/loss on swaps contracts" in the statement of net assets.

**l) Allocation of accrued expenses**

Accrued expenses which can be allocated directly to a Subfund are charged to this Subfund. Accrued expenses which cannot be allocated directly are divided among the Subfunds in proportion to the net assets of each Subfund.

**m) Securities Lending**

The Company can practise lending of securities included in its portfolios of its Subfunds. The Company may only lend securities within a standardized system of securities lending organised by a recognised institution of securities compensation or by first class financial institutions specialised in this type of operations.

**n) Income recognition**

Dividends are recorded on ex-dividend date, net of withholding tax. Interests are accrued on a daily basis.

**o) Valuation of options of each Subfund**

Unmatured options are valued at valuation date at market rates prevailing at this date and resulting changes in unrealised gains or losses are posted to the statement of operations / changes in net assets.

**Management fee**

(see detail at Subfund level)

As remuneration for its services and reimbursement of its expenses, the Management Company is entitled to a monthly management fee, payable at the end of each month and calculated on the basis of the average of the daily net asset value of the relevant share class during that month.

Class DA, DAH, DB and DBH Shares are not subject to a management fee but only to an all-in management service fee, payable to the Management Company covering all fees and expenses excluding the fees payable to the Depositary Bank, of at least 0.03% p.a. but not more than 0.15% p.a.

Class DAP, DAHP, DBP and DBHP Shares are not subject to a management fee but only to an all-in management service fee, payable to the Management Company covering all fees and expenses excluding the fees payable to the Depositary Bank, of at least 0.03% p.a. but not more than 0.15% p.a., and a performance fee, payable to the Management Company.

**Performance fee**

For Credit Suisse (Lux) Absolute Return Bond Fund, Credit Suisse (Lux) AgaNola Global Convertible Bond Fund, Credit Suisse (Lux) AgaNola Global Value Bond Fund, Credit Suisse (Lux) Credit Special Situation Fund, Credit Suisse (Lux) Global High Yield Bond Fund and Credit Suisse (Lux) High Yield USD Bond Fund, in addition to the Management fees, the Subfunds are subject to a fee linked to the performance of the assets that the relevant Investment Manager is managing ("Performance Fee").

For Credit Suisse (Lux) AgaNola Global Convertible Bond Fund and Credit Suisse (Lux) AgaNola Global Value Bond Fund, the Performance Fee shall be payable equally between the Investment Manager and the Co-Investment Manager.

The Performance Fee shall be payable for each Reference Period. The Reference Period corresponds to an Accounting Year.

A detailed calculation method of the performance fees can be found in the Prospectus of the Company.

**"Taxe d'abonnement"**

Under the prevailing laws and regulations, the Fund is subject in Luxembourg, on the basis of its investments, to a "taxe d'abonnement" at the annual rate of 0.05%, payable quarterly and calculated on the basis of the net assets of each Subfund at the end of each quarter. In the case of Share Classes that may only be acquired by institutional investors, this annual tax rate is 0.01%.

This tax does not apply for those assets of the Fund which are invested in other undertakings for collective investment under Luxembourg law.

**Total Expense Ratio (TER)**

(see detail at Subfund level)

The TER expresses the sum of all costs and commissions charged on an ongoing basis to the fund's assets, taken retrospectively as a percentage of the average assets.

If a Subfund invests at least 10% of its net assets as a fund of fund in target funds, a composite TER of the fund of funds is to be calculated as follows:

The prorated TER of the individual target funds including a performance related remuneration, weighted according to the share they represent in the overall assets of the fund of funds as of the closing date and the TER of the fund of funds minus

the retroceded commissions received from the target funds during the reporting year. The TER is calculated following the SFAMA guideline.

No TER is disclosed for share classes launched less than 6 months before closing or closed during the year.

**Exchange Rates**

**Credit Suisse (Lux) Absolute Return Bond Fund**

Interest rates trends completely reversed their direction in 2019. While 2018 saw interest rates rise to over 3% for US 10y Treasuries as the Fed hiked interest rates, they experienced a slide to as low as 1.4% in August to 2019 after the US Federal Reserve reversed policy to correct what markets perceived as an overtightening of financial conditions.

In the meantime the Fed has cut interest rates three times and effectively restarted quantitative easing. Other central banks kept their monetary policy loose as well. As a result risk markets experienced one of the strongest year-to-date rallies in history with stock markets rallying to all time highs and credit spreads tightening. The ongoing trade dispute between China and the US however resulted in short-term market corrections appearing more frequently, keeping overall market sentiment fragile and uncertainty high.

The subfund comprises three main performance drivers: Risk is predominantly allocated to a directional portfolio which takes long or short positions in rates, credit and currencies based on a systematic momentum approach. This portfolio is complemented by relative value trades, carry positions and a cash bond portfolio which provide yield enhancement in side-ways markets. A portfolio of tactical trades helps to steer risk of the overall portfolio. Diversification through efficient portfolio construction is one of the key attributes of the strategy in the current market environment. The strong rally in government bond markets was beneficial to the fund's systematic momentum approach. Volatility created by the ongoing trade dispute on the other hand was negatively impacting momentum investing in equity and currency markets. Tactical risk management helped to smooth performance during period of high volatility. The fund's underlying bond portfolio had a strong contribution to performance, mainly coming from its exposure to short-dated US Treasury bonds.

**Credit Suisse (Lux) AgaNola Global Convertible Bond Fund**

The reporting period started with a dramatic sell-off in both credit and equities in late Q4:2018 in what proved to be the worst quarter for risky assets in nearly 100 years. The market rebounded quickly in early 2019 before rallying to new highs later in the year. Despite the strong performance over the 12-month period, dark clouds began gathering on the horizon in the form of global economic slowdown coupled with the need to reintroduce accommodative monetary policy in both the US and the Euro area.

The period under review saw Credit Suisse (Lux) AgaNola Global Convertible Bond Fund generate a solid absolute return of 3.1% (net of all costs). The fund was positioned with a minimal long delta relative to the benchmark in Q4:2018. We started to gradually increase our delta in early 2019 when the sell-off appeared to have reached extremes. From a sector perspective we followed a two-pronged approach: selectively adding quality names from the Technology and Healthcare sectors which had repriced while the same time building our materials exposure. A couple of special situations (Wirecard, Inmarsat) as well as individual security selection in Real Estate, Materials and Industrials contributed the most to performance.

The period under review saw a number of changes in the market environment. The most notable development was the decline of the average delta of the global Investment Grade convertible bond universe following the conversion of a number of high-delta securities. At the end of the reporting period the average delta stood at below 34%, its lowest level in more than 10 years. We see this as a major positive for the asset class in that it ensures superior convexity going forward. In addition, we see considerable potential for increased primary market activity, a hypothesis supported by the robust volumes seen not only in the US but more recently in Europe as well.

**Credit Suisse (Lux) AgaNola Global Value Bond Fund**

The reporting period started with global credit spreads widening in late 2018, reaching the highest level since 2016, and inflation expectations dropping globally. The FED sharply reversed its interest rate policy and has cut the interest rate three times by 0.25% in July, September and October 2019. Consequently, interest rates dropped globally and credit spreads tightened significantly. Furthermore, the ECB eased its monetary policy by extending its assets purchasing program and cutting the deposit rate in September. Especially in Europe, the reporting period was characterized by weakening economic indicators, such as slowing growth and inflation persistently below trend.

During the last 12 months the Fund showed a positive performance in absolute terms, and outperformed its benchmark on a relative basis. On the rate side, the portfolios duration has been gradually increased during the reporting period and thus increasing its interest rate sensitivity. Despite a few macroeconomic and geopolitical uncertainties, the fund remains relatively constructive on the near-term outlook of corporate credit heading into the last quarter of 2019 and for

2020. Specifically, suppressed yield levels, central bank easing and tame inflation should keep demand for credit elevated. Further, the backdrop for creditworthiness remains supported by US fundamentals, healthy corporate profits and low borrowing costs.

**Credit Suisse (Lux) Contingent Capital Euro Fund**

Contingent capital instruments and subordinated debt of European banks and insurers performed very strongly in 2019. This was driven by further improvement in credit profiles, reduction in political risk in Europe as well as abated international trade tensions. The change in the Italian government in September as well as reduced likelihood of a Brexit scenario without a withdrawal agreement had a positive effect on the risk premia of European assets. Economic growth remained anemic which facilitated a continued accommodative central bank policy of lower rates and a recommendation of asset purchases, both supportive for valuation of bank credit instruments.

Pieter Fyfer joined Roger Wyss as co-manager of the subfund from April 2019 and with continued strong performance, the fund more than quadrupled in size. The portfolio management team shifted from a defensive into a more constructive positioning, correctly anticipating a strong performance of the asset class. The implementation was carried out across several parameters including increased allocation into contingent convertibles, increase in spread duration and shifts into securities with lower backend spreads. The team increased allocation to Italy and the UK in advance of periods of strong outperformance by the banks of these countries. The strategy provided strong returns and the subfund could considerably outperform its benchmark.

**Credit Suisse (Lux) Credit Special Situation Fund**

Interest rates concerns, escalating trade and tariff tensions and Brexit fears remained the dominant risk factors for financial markets during the reporting period. But while the latter two concerns stayed high on the agenda for the entire year, interest rate concerns began to abate abruptly in early 2019. After risk assets had posted one of the worst December results in decades, they began to turn around with a vengeance in early 2019 as financial conditions improved swiftly against a very dovish U-turn in the US Federal Reserve's communication with regards to the future path of US monetary policy, which suggested rate cuts rather than rate hikes. Broad credit markets trended higher smoothly over the entire reporting period without any major setbacks and delivered some of the best results for investors in a long time.

The Credit Suisse (Lux) Credit Special Situation Fund with its relatively short duration did benefit from this increasingly constructive environment in 2019 after it could barely escape the challenging end to 2018. While the fund was able to outperform almost all comparable credit market asset classes in the previous year, it did again outperform global high yield markets during the latest reporting period, but underperformed both EM credit as well as low Investment grades corporates, which with their longer duration not only benefitted more from tightening credit spreads but also from falling interest rates. After a very strong performance in the first half of CY2019 the fund bought some credit protection around mid-year as a hedge against a possible market setback, but the hedge did not positively add to performance as markets remained broadly unaffected by the numerous risks occurring over the course of the year. August was a very difficult month during which the fund got negatively affected by the political events in Argentina, in the wake of which the fund reduced its exposure to the country noticeably. Overall the risk exposure of the fund has grown over the course of the year in an attempt to reflect the more constructive global credit market environment, with a key focus on subordinated financials and large restructuring stories.

**Credit Suisse (Lux) Euro Corporate Bond Fund**

The reporting period started with global credit spreads widening in late 2018, reaching the highest level since 2016, and inflation expectations dropping globally. The FED sharply reversed its interest rate policy and has cut the interest rate three times by 0.25% in July, September and October 2019. Consequently, interest rates dropped globally and credit spreads tightened significantly. Furthermore, the ECB eased its monetary policy by extending its assets purchasing program and cutting the deposit rate in September. Especially in Europe, the reporting period was characterized by weakening economic indicators, such as slowing growth and inflation persistently below trend.

During the last 12 months the Fund showed a positive performance in absolute terms, but underperformed its benchmark relative due to an underweights in lower-rated corporates and credits. On the rate side, the fund's duration was mostly longer compared to the benchmark which contributed positively to the relative performance.

### Credit Suisse (Lux) European Sovereign Plus Bond Fund

With markets under pressure and inflation expectations moving sharply lower by the end of 2018, accompanied by global economies losing momentum and weakening industrial indicators, global central banks turned dovish – sparking a financial rally for almost all asset classes during 2019. At its September meeting, the ECB announced a broad monetary easing package, including a 10 bp cut to the deposit rate, a resumption of net asset purchases. Overseas, the FED cut interest rates in July, September, and October. As a direct result from central bank easing, the decline in yield was substantial: 10y Bund yields dropped from about 0.4% early November 2018 to -0.4% by the end of October 2019. With European core yields trading negative and financial conditions backed-up by central banks, spreads of European peripheral countries have consistently moved lower due to strong demand from yield-seeking investors.

During the review period, the fund was generally long peripheral risks (Portugal, Spain, Italy) and underweight in the more core countries (Ireland, Belgium). As such and given the above mentioned market developments, the Credit Suisse (Lux) European Sovereign Plus Bond Fund generated strong positive returns during the reporting period, driven by both generally falling interest rates as well as spread compression of peripheral countries. For the time being, the fund is still maintaining an overweight towards European peripheral countries, hence achieving a slightly higher running yield as compared to the benchmark, while we keep closely monitoring the economic environment in Europe as well as country specific developments and idiosyncratic risks.

### Credit Suisse (Lux) Floating Rate Credit Fund

The reporting period was rather eventful and started with global credit spreads widening in late 2018, reaching the highest level since 2016, and inflation expectations dropping globally. As a result, the FED sharply reversed its interest rate policy and has cut the interest rate three times by 0.25% in July, September and October 2019. Consequently, interest rates dropped globally and credit spreads tightened significantly. Furthermore, the ECB eased its monetary policy by extending its assets purchasing program and cutting the deposit rate by -0.1% to -0.5% in September. Especially in Europe, the reporting period is characterized by weakening economic indicators, such as slowing growth and inflation persistently below trend. However, the trend has not yet manifested in credit valuations as company earnings stay resilient and default rates remain low.

After a mixed start into the investment year 2019, the fund has posted a positive gross performance of 5.26% during the reporting period. The fund's low duration and active credit management has shown increasing diversification effects, generated stable low-volatility returns, and established a lower correlation to other fixed income strategies. Despite a few macroeconomic and geopolitical uncertainties, the fund remains relatively constructive on the near-term outlook of corporate credit heading into the last quarter of 2019 and for 2020. Specifically, suppressed yield levels, central bank easing and tame inflation should keep demand for credit elevated. Further, the backdrop for creditworthiness remains supported by US fundamentals, healthy corporate profits and low borrowing costs. We expect that spreads will continue to grind moderately tighter towards the end of the year, with more upside in IG than in HY on a risk-adjusted basis. The fund continues to balance higher-quality carry trades with nimble credit selections given a renewed emphasis on fundamentals and deleveraging trends. Moreover, the fund focuses on performance preservation and capital conservation instead of recompression strategies in a year of broad-based positive returns. At the sector level, we prefer a positioning for carry in deleveraging credits and overweight to non-cyclical sectors.

### Credit Suisse (Lux) Global High Yield Bond Fund and Credit Suisse (Lux) High Yield USD Bond Fund

#### Market Review

Over the reporting period the high yield bond markets bounced back versus the previous year as Fed cut rates and investors went long duration. Overall yields have ticked down (with the 10-year down over 100 bps) since the previous year end. Inflows into the asset class remained steady, combined with strong issuance. To be precise, the asset class saw \$18.3 billion in inflows year-to-date for 2019. In comparison, there were \$34.4 billion in outflows for the same period in 2018. On the supply side of the equation, new issuance volumes were up materially led by refinancing volumes and M&A related activity. Default activity, as measured by JP Morgan, and including distressed exchanges, ended the period at 2.83% – up 77 basis points over the prior 12 months. Default activity has been higher than expected due to weakness in energy and metals & mining-related sectors. However, these numbers are still below long-term averages – a fact we expect to continue outside of certain secularly challenged industries.

#### Outlook

With expectations of a potential trade deal between the United States and China,

we believe the markets will likely experience continued volatility as White House rhetoric is carefully analyzed. We will continue to assess the lower quality assets that have lagged much of this year for investment opportunities. And if political uneasiness creates another pocket of weakness, we will likely view it as an opportunity to deploy cash at lower levels.

### Credit Suisse (Lux) Global Inflation Linked Bond Fund

During the last quarter of 2018 global equities posted sharp declines on persistent concerns over global trade and slowing economic growth. Bond yields were lower over the quarter, broadly reflecting increased risk aversion. Comments from Federal Reserve Chairman Jerome Powell indicated a slightly dovish shift though the Fed implemented the fourth rate rise of the year in December. As the new year started the Federal Reserve confirmed it would adjust planned interest rate hikes to compensate for deteriorating economic momentum. Indeed, the Fed settled further into its dovish stance as a number of indicators reflected slower economic growth. In late June, the Federal Reserve (the Fed) indicated that it might cut interest rates sooner than previously expected by removing the word 'patient' from its policy statement. It added that it would 'act as appropriate' to sustain economic expansion. After nine rate increases that began back in 2015, the Fed abruptly reversed the course in August and cut rates by 25 bps. The cut was in reaction to tariff uncertainty and slowing economic data. With inflation below target, the Fed felt a cut could support a continued expansion without raising inflation concerns. In September the Fed followed up with an additional 25 bps cut. In mid-September, the European Central Bank (ECB) delivered its biggest package of measures in three years, as it cut the deposit rate further into negative territory and restarted its bond-buying programme with €20 billion of open-ended monthly purchases. The central bank also eased lending terms for banks in the euro zone and implemented tiered interest rates in a bid to ease the pressure on their lending margins. The ECB's move to insulate European banks from the harmful consequences of negative interest rates caused investors to warm to the sector after months of shunning it, resulting in a bounce alongside other value stocks and economically sensitive areas of the market.

The market with the best performance, as measured by the Barclays World Government Inflation-Linked Bonds index (WGLLB, local return), was Italy (18.37%) followed by New Zealand (15.64%) and Australia (10.73%). The worst performing market was Japan (-0.53%) followed by France (1.37%). In relative terms (compared to nominal bonds of similar maturity), New Zealand was the best performing market with an outperformance of 6.10%.

The main positive performance contribution came from the synthetic inflation exposure through corporate bonds and inflation swaps, as credit spreads tightened over the reporting period. The exposure to corporate bonds was held more or less steady at roughly 15%. From an overall duration standpoint the subfund was actively positioned around benchmark duration. More recently the subfund is overweight in duration terms compared to the benchmark.

### Credit Suisse (Lux) Latin America Corporate Bond Fund

Credit Suisse (Lux) Latin America Corporate Bond Fund was launched on 07.10.2019.

### Credit Suisse (Lux) US Corporate Bond Fund

The reporting period started with global credit spreads widening in late 2018, reaching the highest level since 2016, and inflation expectations dropping globally. The FED sharply reversed its interest rate policy and has cut the interest rate three times by 0.25% in July, September and October 2019. Consequently, interest rates dropped globally and credit spreads tightened significantly. Furthermore, the ECB eased its monetary policy by extending its assets purchasing program and cutting the deposit rate in September. Especially in Europe, the reporting period was characterized by weakening economic indicators, such as slowing growth and inflation persistently below trend.

During the last 12 months the Fund showed a positive performance in absolute terms, and was in line with its benchmark on a relative basis. On the rate side, the fund started the period with a short duration relative to the benchmark, and gradually increased the duration and thus its interest rate sensitivity over the past twelve months. Despite a few macroeconomic and geopolitical uncertainties, the fund remains relatively constructive on the near-term outlook of corporate credit heading into the last quarter of 2019 and for 2020. Specifically, suppressed yield levels, central bank easing and tame inflation should keep demand for credit elevated. Further, the backdrop for creditworthiness remains supported by US fundamentals, healthy corporate profits and low borrowing costs.

In accordance with the regulatory requirements the leverage is calculated by way of the sum of the notional values of the derivatives. The sum of the notional values takes into account the absolute values of notional values of all the financial derivative instruments used by the Subfund. Henceforth the level of leverage is an indicator of the intensity of the use of financial derivative instruments within the Subfund and is not an indicator of the investment risks in relation to those derivatives because it does not take into account any netting or hedging effects. In fact derivatives used to offset the risks linked to other transactions are contributing to an increase of the leverage determined via the sum of the notional values. For an indicator of the overall risk of the Subfund the investor should refer to the information in the KIID. The level of leverage reached may vary over time and it may be higher than the expected level.

**Remuneration**
