Gross performance⁴ (20.04.2015 - 31.07.2019)

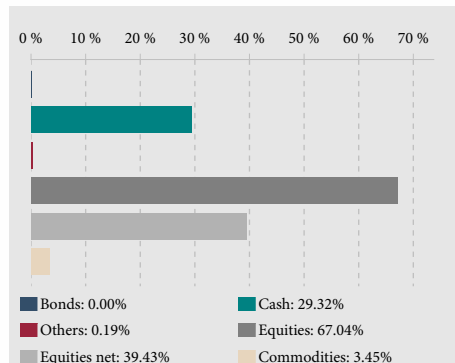

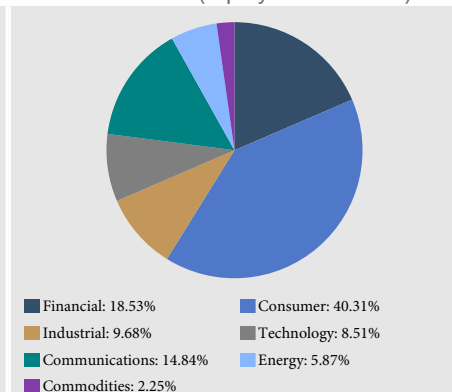
