Objectives and Investment Policy

- The aim is to provide capital growth and income on your investment over time.
- The Fund employs a Total Return strategy which has a flexible allocation across the global bond universe and currency markets. Through seeking multiple sources of return the strategy aims, over an investment cycle, to achieve risk-adjusted returns above those of the investment universe.
- You should be aware that your capital is at risk and there is no guarantee of stable growth over any time period.
- The Fund will normally invest at least 70% of its assets, either directly or through the use of derivatives, in high and lower quality bonds (types of debt securities) and other similar securities. These securities will be denominated in developed and emerging markets currencies.
- The Fund may invest up to 10% of its assets in Chinese onshore bonds through the China Interbank Bond Market (CIBM).
- The Fund may invest up to 49% of its net assets in cash, cash instruments and/or money market instruments.
- The Fund may invest up to 20% of its assets in debt whose income comes from regular payments such as loan or mortgage repayments (Asset Backed Securities and Mortgage Backed Securities).
- The Fund may invest up to 10% of its assets in debt issued by a single lower quality government.
- The Fund may invest up to 10% of its assets in contingent convertible securities (CoCos).
- The Fund may invest up to 10% of its assets in funds (including other funds of HSBC Global Investments Funds).
- The Fund may use derivatives for hedging, cash flow management and investment purposes.
- The reference currency of the Fund is USD. The reference currency of this share class is USD.
- The Fund is actively managed and is not constrained by a benchmark.
- Income is reinvested.
- You may sell your investment on most working days.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within a period of 3 years.

Why is this Fund in this specific category?

This Fund is classified in category 3 because its price or simulated data has shown low to medium fluctuations historically.

Material risks not fully captured by the Risk and Reward Indicator:

- CoCo Bond Risk** Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.
- Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- Credit Risk** A bond or money market security could lose value if the issuer's financial health deteriorates.
- Default Risk** The issuers of certain bonds could become unwilling or unable to make payments on their bonds.
- Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.
- Emerging Markets Risk** Emerging markets are less established, and often more volatile, than developed markets and involve higher risks, particularly market, liquidity and currency risks.

- Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.

Charges

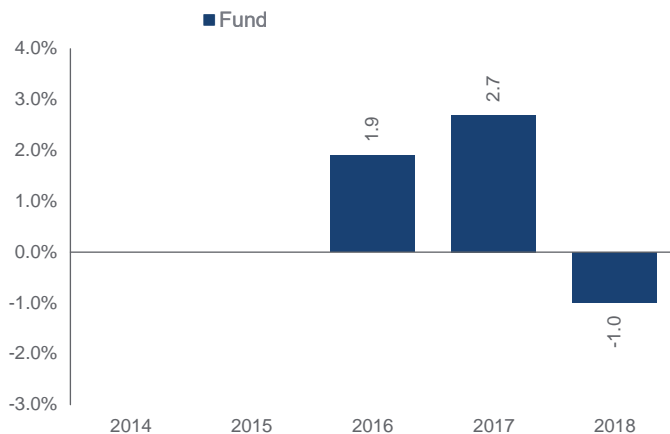
