Objectives and investment policy

This actively managed sub-fund aims to achieve the highest possible capital growth over the long term.

- It mainly invests in equities and equity-like securities. It may invest up to 20% via Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect in China A-Shares. It may also hold cash.
- The sub-fund mainly invests in securities of companies around the world that contribute to sustainable economic activity and are leaders within their sector.
- The investment decision-making process pursued by the portfolio manager of the Sub-Fund is based on fundamental analysis of the companies belonging to the investment universe. A significant part of this process is based on the proprietary "smart data approach" which uses and combines a large set of fundamental company data servicing as a decision base for the portfolio manager in its stock selection and portfolio monitoring process.


