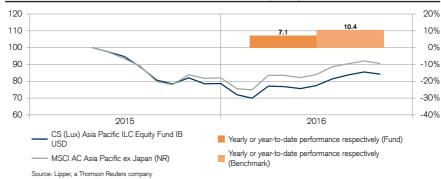

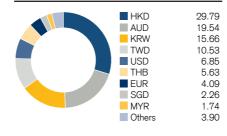
Net performance in USD (rebased to 100) and yearly performance 2)

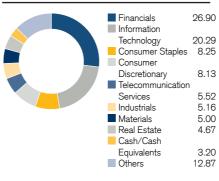
