# Objectives and Investment Policy

The Fund seeks to achieve medium-term capital gains in the Net Asset Value by implementing a dynamic and highly flexible asset allocation strategy using all types of asset classes. The Fund will have a target risk profile between global shares and global bonds. The Fund can invest directly or indirectly (through funds) in shares, bonds, real estate, commodities, currencies, cash and other asset classes. The Fund may invest in derivatives for hedging and investment purposes, Exchange Traded Funds and Exchange Traded Notes.


It is actively managed and as such may invest in securities that are not included in the index which is Cash Index EURIBOR 3 Months (EUR) RI.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Credit Risk</u>: This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- <u>Liquidity Risk:</u> This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- <u>Counterparty Risk</u>: This risk is associated with the ability of a counterparty in an Over The Counter financial transaction to fulfil its commitments like payment, delivery and reimbursement.
- Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- <u>Derivatives Risk</u>: When investing in over the counter or listed derivatives, the Fund
  aims to hedge and/or to leverage the yield of its position. The attention of the
  investor is drawn to the fact that leverage increases the volatility of the subfund.
