(ISIN: LU1165444743) Multifunds Moderate (the 'Fund') is a Sub-Fund of Bankinter International Fund Sicav (the 'Company'). Lemanik Asset Management S.A. is the Management Company (the 'Management Company') to the Fund.

Objectives and Investment Policy

- The Fund is actively managed and it's objective is to provide longterm positive returns above a benchmark that is composed of 25% Eurostoxx + 15% S&P 500 +5% Topix +5% Lyxor ETF MSCI Emerging Markets + 50% Barcap Global Agg Total Return Index Value Hedge EUR.
- To achieve this objective, the Fund may gain principally exposure
 to any of the following financial instruments through the
 investment in UCITS and UCIs: any type of Transferable
 Securities including equity and fixed income securities, Money
 Market Instruments and other UCITS and UCI eligible assets
 (including but not limited to indices on commodities).
- The Fund will invest a minimum of 50% of its assets in other funds. The management company and/or investment management entity of these funds can belong, without limitation, to the Bankinter Group.
- If the Fund does not invest through the above mentioned funds,

it may also gain exposure either directly or indirectly on an ancillary basis to the aforementioned financial instruments by the use of Financial Derivative Instruments (instruments whose prices are dependent on one or more underlying assets 'FDIs'). The Fund invests in FDIs in order to reduce the possibility of financial losses or to achieve higher gains.

- The Fund may invest up to 50% of its assets in equities or other funds whose investment strategy is mainly focused in equities.
- Sale of shares in the Fund can be made on any business day.
- The Fund does not intend to distribute dividends. Any income arising from the Fund's investments is reinvested and reflected in the value of your shares. However, the Annual General Meeting of shareholders may decide to distribute such income.
- Recommendation: this Fund may not be appropriate for investors who plan to withdraw their money within three to five years.


