Fund description

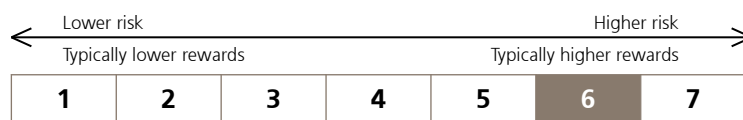

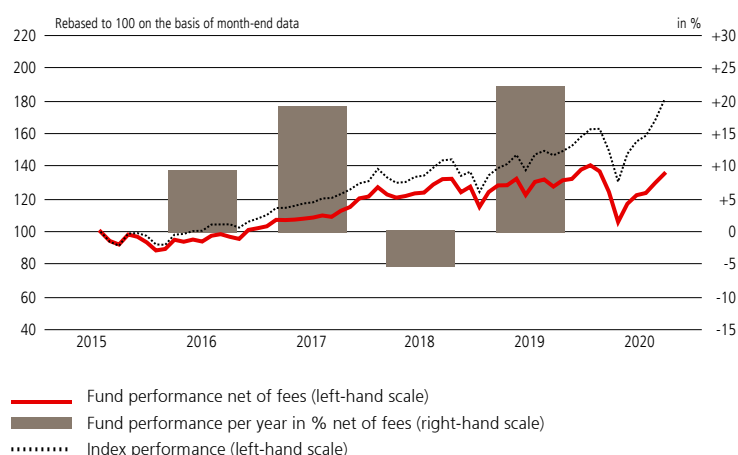
