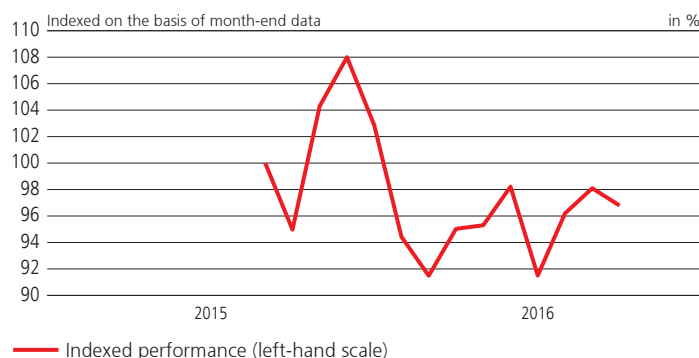
## UBS German High Dividend

- The fund offers a diversified portfolio across capitalization levels and sectors.
