- The exchange rate risk between USD and CHF is largely hedged.

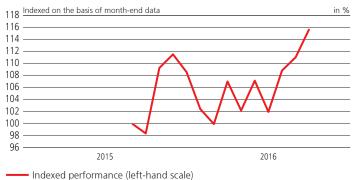
