(ISIN:IE00BYVDZF50) Man GLG Global Sustain Equity (the 'Fund') is a sub-fund of GLG Investments plc (the 'Company'). GLG Partners Asset Management Limited, part of Man Group plc, is the Manager of the Company.

Objectives and investment policy

- The Fund is a global equities strategy that seeks long term gains by investing primarily in listed or traded shares (or related instruments) of issuers which stand to benefit economically from sustainability themes.
- The Fund defines sustainability as the investment required to address demographic and environmental change. As such, there will be an emphasis on investment in securities of companies with exposure to sustainability themes.
- The Fund may also invest in other asset classes, including debt securities, currencies, deposits and other funds. The Fund may increase its holdings in cash and other liquid assets in times of market turbulence.
- In the interest of liquidity, the Fund will invest primarily in companies which have a medium to large issued share capital and will have a global focus.
- The Fund may use financial derivative instruments (instruments whose price are dependent on one or more underlying assets, 'FDI') to achieve the investment objective, for hedging anticipated movements in a market or security, or where it is more economically effective than directly holding the underlying asset. The Fund is not expected to have an increased market exposure (leverage) as a result of such investments.
- The Fund may actively use FDI to provide investors with the currency risk associated with the underlying investments of the Fund, or of an appropriate benchmark.
- Any income earned on investments will be added to the value of investors' shares and investors can buy and sell their shares on each dealing day of the Fund.


