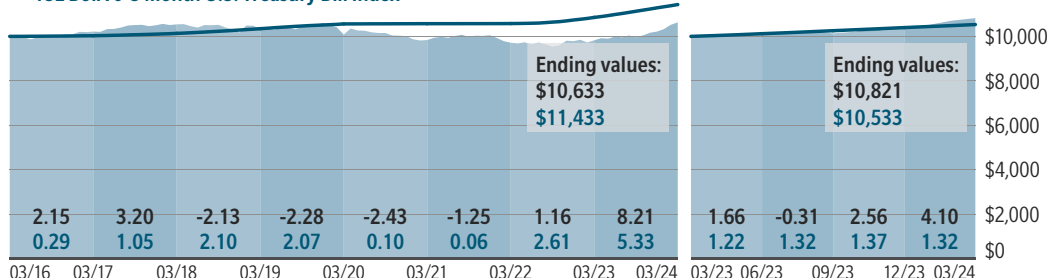

Important Data Methodologies
