#### **Fund description**

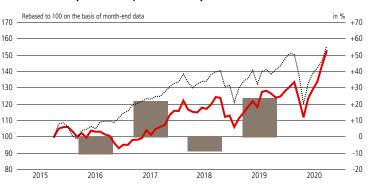
- Actively managed equity fund that invests globally in high conviction companies.
