# Objectives and Investment Policy

**Investment objective**: The objective of the Sub-Fund is to outperform its benchmark by investing on international capital markets and through the selection of, among others, companies involved in technology sectors or related to advanced analytics technologies.

Benchmark index: The benchmark index of the Sub-Fund is the MSCI World Index, calculated with net dividends reinvested. The benchmark index will be expressed in the Class currency.

The benchmark index serves only for comparison purposes. The Sub-Fund is actively managed.

Investment policy: The Investment Manager will systematically include environmental, social and governance (ESG) factors in their financial analysis in order to select the highest-rated companies.

At least 90% of the companies in the portfolio will have an ESG rating. At the end of this process, the Sub-Fund will have an ESG rating that is greater than that of its investment universe.

Furthermore, the security selection process also includes a negative filter to exclude companies that contribute to the production of controversial weapons in compliance with international conventions in this area as well as companies that are exposed to activities related to thermal coal or tobacco in accordance with the exclusion policy of Edmond de Rothschild Group, which is available on its website: https://www.edmond-de-rothschild.com/en/Pages/Responsible-investment.aspx, more specifically on the Sub Fund's transparency code.

The Sub-Fund Classifies as Article 8(1) SFDR as it promotes a combination of ESG characteristics, although no reference benchmark has been designated for the purpose of attaining the environmental or social characteristics.

Environmental, social and governance (ESG) criteria are one of the components subject to management and are factored in the final investment decision, although their weighting is not defined beforehand.

In view of its ESG strategy, the Sub-Fund promotes environmental characteristics but does not invest in environmentally sustainable economic activities. The investments underlying this financial product do not take into account the EU criteria for environmentally sustainable economic activities, in the context of the Taxonomy Regulation.

The Sub-Fund invests at least 51% of its net assets in securities issued by companies involved in technology sectors or related to advanced analytics technologies. Between 75% and 110% of the Sub-Fund's net assets will be exposed (directly or indirectly) to the international equity markets and other assimilated securities.

The Sub-Fund may invest, up to 30% of its net assets, in China A Shares via the Shanghai Hong Kong Stock Connect program.

For cash management purposes, the Sub-Fund may invest up to 25% of its net assets in transferable debt securities, Money Market Instruments and Money Market Funds.

The Sub-Fund may use financial derivative instruments to achieve its investment objective.

#### The recommended minimum investment period is 5 years.

Frequency of share buying or selling: Every Luxembourg and France bank business day except for Good Friday, 24 December (Christmas Eve) and the days on which the French markets are closed (official calendar of Euronext Paris S.A.) and the US markets are closed (official calendar of NYSE) for orders received by the transfer agent no later than 12:30 p.m. (Luxembourg time) one business Day prior to the applicable Value Day.

### Risk and Reward Profile

#### Significant risks not taken into account in this indicator:

Credit risk: When a significant level of investment is made in debt securities.

<u>Liquidity risk</u>: The markets for some securities and instruments may have limited liquidity. This limited liquidity could be a disadvantage to the Sub-Fund, both in the realisation of the prices quoted and the execution of orders at desired prices.

<u>Impact of techniques such as derivative contracts</u>: The use of derivatives instruments can infer a decrease of the asset more significant than the decrease of the invested underlying assets or markets.

<u>Counterparty risk</u>: Where a Fund is backed by collateral or has significant investment exposure through contracts with a third party.

Operational risk: The Sub-Fund may suffer losses due to the failure of operational processes, including those related to the safekeeping of assets.

The occurrence of any of these risks may negatively impact the net asset value.

#### Charges taken from the Fund under certain specific conditions

#### Performance fee

The performance fee is set at 15% and is calculated by comparing the Sub-fund's share performance with that of an indexed reference asset, over the relevant Calculation Period. This fee is due even in the case of a reduction in the Net Asset Value provided that the decrease in Net Asset Value is less than the decrease in the benchmark index. The calculation method is described in the prospectus (outperformance model 2).

Payable annually on December 31.

Charges and fees are paid to cover the operating costs of the Sub-Fund, including the cost of marketing and distributing share classes. These costs reduce the potential growth of your investment.

Investors may obtain the actual amount of entry and exit charges from their advisor or distributor. In certain cases you might pay less.

The ongoing charges figure is based on the last year's expenses, for the year ending in December 2021. This figure may vary from year to year. It excludes performance fees and intermediary fees except entry and exit charges paid by the Sub-Fund when buying or selling units and/or shares of another UCI.

The performance fee paid for the preceding exercise closing on December 2021 represents 0.04% of net assets.
