### Man Numeric RI US Large Cap Equity Class I H EUR Shares

(ISIN:IE00BYYK0692) Man Numeric RI US Large Cap Equity (the 'Fund') is a sub-fund of Man Funds plc (the 'Company'). Man Asset Management (Ireland) Limited, part of Man Group plc, is the Manager of the Company.

### Objectives and investment policy

- The Fund aims to earn a return on investments greater than the returns available from investments in the S&P 500 Index by providing long only exposure primarily to equity securities listed or domiciled in the United States. This approach uses computerised processes to identify potential investment opportunities. However, the final decision on whether to invest is made by the investment manager.
- The computerised processes primarily aim to allocate assets to underlying strategies which seek to identify and exploit mispriced stocks and to analyse the actions of various market participants to forecast their stocks' momentum, direction and earnings.
- The Fund may invest in financial derivative instruments (ie instruments whose prices are dependent on one or more underlying assets, "FDI"), stocks, bonds, other investment funds and American, European and Global depositary receipts. Stocks will be listed, will primarily have a large market capitalisation and may be issued across all industrial sectors. The Fund may also invest in money market instruments and cash, government debt instruments and other liquid assets for cash management purposes.
- The Fund typically applies an exclusion list of controversial stocks or industries (e.g. tobacco or cluster munitions) and will consider environmental, social and governance factors as part of its stock selection process.
- Benchmarks. The Fund is actively managed. The Fund does not intend to track the S&P 500 Index and is not constrained by it. The Benchmark is being used by the Fund for risk management purposes to ensure that the Fund is managed in a manner consistent with its investment objective and risk profile. The risk management function of the Investment Manager will perform additional monitoring of positions in the fund relative to weights in the benchmark. Relative weights will be assessed with

- reference to a threshold which may be updated from time to time. Other risk monitoring may include tracking error and or relative Value at Risk (VaR) versus the Benchmark as well as relative sector weights versus the Benchmark. While the Fund will focus on individual issuers that may or may not belong to the Benchmark, such investment may be in different weights than those used by the Benchmark. The above factors, considered together, may influence the extent to which the Portfolio deviates from the Benchmark and such deviation may be material. The Benchmark is also used for performance comparison purposes.
- The Fund may actively use FDI to achieve the investment objective, for hedging against anticipated movements in a market or a security, or where it is more economically effective than directly holding the underlying asset.
- FDI may allow the Fund to obtain market exposure in excess of the value of the Fund's assets (leverage). However the occurrence of leverage is not expected to materially increase the overall volatility of the Fund.
- The Fund will use FDI to provide investors with a similar return to any share class issued in the working currency of the Fund (US Dollars).
- Any income earned on investments will be added to the value of investors' shares and investors can buy and sell their shares on each dealing day of the Fund.
