#### Objectives and Investment Policy

**Investment Objective:** The Sub-Fund seeks to achieve a return in the Reference Currency in line with prevailing money market rates whilst aiming to preserve capital consistent with such rates and to maintain a high degree of liquidity.

**Investment Policy:** The Sub-Fund will invest its assets in short term GBP-denominated Debt Securities issued by the UK government excluding local governments and agencies and Reverse Repurchase Agreements. Such Reverse Repurchase Agreements will be fully collateralised by GBP-denominated Debt Securities issued by the issuers described above.

The Sub-Fund may have exposure to investments with zero or negative yields in adverse market conditions.

The weighted average maturity of the Sub-Fund's investments will not exceed 60 days and the initial or remaining maturity of each Debt Security will not exceed 397 days at the time of purchase.

In addition to receiving a favourable assessment of their credit quality pursuant to the Management Company's Internal Credit Procedures, government Debt Securities with a long-term rating will be rated at least "A" and government Debt Securities with a short-term rating will be rated at least "A-1" by Standard & Poor's or otherwise similarly rated by another rating agency.

The Sub-Fund may also invest in unrated government Debt Securities of comparable credit quality to those specified above for government Debt Securities with a long-term rating.

The Sub-Fund aims to maintain a "AAA" rating, or equivalent, on the Sub-Fund as assigned by at least one rating agency.

This Sub-Fund qualifies as a "Public Debt Constant Net Asset Value Money Market Fund" in accordance with Regulation (EU) 2017/1131 of the European Parliament and of the Council of 14 June 2017 on Money Market Funds as may be amended or replaced from time to time and therefore will comply with these guidelines.

**Redemption and Dealing:** Shares of the Sub-Fund may be redeemed on demand, with dealing normally on a daily basis.

Benchmark: Overnight GBP LIBID.

The benchmark is a point of reference against which the performance of the Share Class may be measured. The Sub-Fund is actively managed.

Distribution Policy: This Share Class will normally pay dividends.


