Objectives and investment policy

The fund is actively managed without reference to an index.


The Fund seeks to increase the value of its assets over the medium term by taking advantage of market movements and/or volatility. It invests in all types of asset classes and keeps volatility at a medium level. The targeted maximum annual volatility is 7%.

The investment team applies also BNP PARIBAS ASSET MANAGEMENT Sustainable Investment Policy, which takes into account Environmental, Social and Governance (ESG) criteria at each step of the investment process of the Fund.

Incomes are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days) as described in the prospectus.

Risk and reward profile

• Why is the Fund in this specific category?

- The risk category is justified by the active investment in different asset classes while seeking to maintain the risk profile between predefined boundaries.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Credit Risk</u>: This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- <u>Counterparty Risk</u>: This risk is associated with the ability of a counterparty in an Over The Counter financial transaction to fulfil its commitments like payment, delivery and reimbursement.
- Operational and Custody Risk: Some markets are less regulated than most of the international markets; hence, the services related to custody and liquidation for the subfund on such markets could be more risky.
- <u>Derivatives Risk</u>: When investing in over the counter or listed derivatives, the Fund aims to hedge and/or to leverage the yield of its position. The attention of the investor is drawn to the fact that leverage increases the volatility of the subfund.
