

## KEY INVESTOR INFORMATION

This document provides you with key investor information about this fund. It is not marketing material. The information is required by law to help you understand the nature and the risks of investing in this fund. You are advised to read it so that you can make an informed decision about whether to invest.

PGIM US Corporate Bond Fund (the “Fund”),  
a sub-fund of PGIM Funds plc (the “Company”)  
(ISIN: IE00BFLQZQ24) EUR-Hedged I Accumulation Class (the “Class”)

### Objectives and Investment Policy

The Fund aims to outperform the Barclays US Corporate Investment Grade Bond Index on a total return basis. While pursuing this objective the Fund will employ a “socially responsible” investment mandate as described in the Fund’s supplement.

The Fund will primarily invest in fixed income securities listed or traded on stock exchanges globally which are rated investment grade, or, if not rated, determined by the investment manager to be of comparable quality to securities so rated. The Fund may also invest in U.S. Treasury and agency securities, municipal securities, asset-backed securities, commercial mortgage backed securities, capital securities and money market or short term bond funds.

The Fund’s below investment grade holdings may not exceed 5% of its net asset value. In addition no more than 5% of the net asset value of the Fund may be invested in securities that are not rated by a rating agency. The Fund may use, for investment or hedging purposes, exchange traded and over-the-counter derivatives (financial contracts whose prices are dependent on one or more underlying assets), including without limitation, futures and options, credit default swaps, credit default swap index (CDX) and interest rate swaps. The Fund may not be leveraged in excess of 100% of its net asset value, through the use of derivatives.

The Fund refers to the Barclays US Corporate Investment Grade Bond Index as its benchmark, however, the investment manager has discretion over the investments of the Fund.

It is not currently anticipated that dividends will be declared in respect of the Class. Net investment income attributable to the Class is expected to be retained by the Fund, which will increase the net asset value per share of the Class.

Portfolio transaction costs, which are paid by the Fund in addition to the costs set out under “Charges for this Fund” below, may have a material impact on the performance of the Fund. Investors can buy and sell their shares on each business day of the Fund. The Fund may not be appropriate for investors who plan to sell their shares within the short term.

The shares are denominated in Euros, and the investment manager aims to hedge the currency exposure of the shares as against the US Dollar. The base currency of the Fund is the US Dollar.

The Fund’s risk category of 3 has been calculated using simulated historical data which may not be a reliable indicator of the Fund’s future risk profile.

The risk rating of the Fund is calculated using a standard methodology used by all UCITS funds, and shows where the Fund ranks in terms of its relative risk and potential return based on past share price fluctuation. **Socially Responsible Investment:** The Fund may achieve lower returns than an equivalent fund which does not pursue a socially responsible mandate.
