### **Objectives and investment policy**

The Fund aims to generate long-term capital appreciation primarily through long and short investments in equity securities listed on one of the major U.S. stock exchanges.

The Fund pursues a value oriented strategy by buying the securities of companies the Investment Manager believes are undervalued and shorting the securities of companies it believes are overvalued. Generally, the cheaper a company appears to the Investment Manager, the larger allocation it receives on the long side. On the short side, the more expensive a company appears to the Investment Manager, the larger short allocation it receives.

To achieve its investment objective, the Fund has flexibility to invest in a wide range of instruments including, but not limited to, common stocks, preferred stocks, convertible securities, equity-related instruments, warrants, swaps and other derivative instruments.

Investment decisions are based upon the Investment Manager's proprietary methodology, under which the Investment Manager analyzes companies taking into account various factors, such as recurring earnings, capital efficiency and valuation.

The currency of the Fund is USD and your shares will be denominated in EUR. Your shares will be hedged with the aim of protecting them from exchange rate fluctuations between their denominated currency and the currency of the Fund.

Your shares are non-distributing (i.e. any income arising from your shares will be included in their value).

You may redeem your shares on demand on any Luxembourg, London and United States banking day.


