#### **Objectives and investment policy**

The Fund aims to generate long-term capital appreciation through investments primarily in global equity securities and related instruments. The investment manager pursues a long/short strategy utilising an investment process that includes seeking to identify thematic investment opportunities that occur over longer periods of time and that in the opinion of the Investment Manager are either undervalued or overvalued by the market because of pricing inefficiencies.

To achieve its investment objective, the Fund has flexibility to invest in a wide range of instruments including, but not limited to, common stocks, preferred stocks, equity-related instruments, ETFs, FX Forwards, swaps, options and other derivative instruments.

Investment decisions are based upon the Investment Manager's research analysis including a top-down macroeconomic analysis (where the Investment Manager will analyze fundamental changes (like global growth or monetary policy) impacting companies) as well as a bottom-up fundamental equity research analysis (where the Investment Manager will identify companies based on specific characteristics). Based on such analysis, the Investment Manager will then determine the investment theme of the Fund.

The currency of the Fund is the USD and your shares will be denominated in EUR. Your shares will be hedged with the aim of protecting them from exchange rate fluctuations between their denominated currency and the currency of the Fund.

Your shares are non-distributing (i.e. any income arising from your shares will be included in their value).

You may redeem your shares on demand on any Luxembourg, London and United States banking day.

The Fund is rated 5 due to the nature of its investments which include the following risks:

- Equity risk the risk that the value of equities and equity-related securities within the Fund may be affected by stock market movements.
- Derivative risk the Fund may use derivatives for investment purposes. Derivatives are highly sensitive to changes in the value of the asset on which they are based, which may result in greater fluctuations in the value of the Fund. The impact to the Fund can be greater where derivatives are used in an extensive or complex way.
- Leverage risk the Fund may operate with additional leverage. Leverage
  occurs when the economic exposure created by the use of derivatives is
  greater than the amount invested. Leverage makes the Fund more
  sensitive to certain market or interest rate movements and may cause
  above-average volatility and risk of loss.

The following are additional risks which are not captured in the risk category:

• Counterparty risk – the risk that the other party to a transaction with the Fund may fail to fulfil its contractual obligations and may expose the Fund to financial losses.

The charges you pay are used to pay the costs of running the Fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.




