Man GLG European Mid-Cap Equity Alternative Class IN H SEK Shares

(ISIN:IE00BWBSFQ76) Man GLG European Mid-Cap Equity Alternative (the 'Fund') is a sub-fund of Man Funds VI plc (the 'Company').

Man Asset Management (Ireland) Limited, part of Man Group plc, is the Manager of the Company.

Objectives and investment policy

- The Fund seeks to provide an attractive risk-adjusted total return, through appreciation and income. The Fund will seek to achieve this return through investment primarily in shares, share-like instruments and financial derivative instruments or 'FDI' (ie instruments whose prices are dependent on one or more underlying assets) of companies listed in Europe or whose business is primarily in Europe, with market capitalisation of between €500 million and €15 billion. The Fund may invest up to 20% in emerging markets.
- The Fund promotes, among other characteristics, environmental and social characteristics within the meaning of Article 8 of the Sustainable Finance Disclosure Regulation (SFDR). The Investment Manager will apply an exclusion list of controversial stocks or industries which may be related to arms and munitions, nuclear weapons, tobacco and coal-oriented activities. In addition the Investment Manager will typically exclude companies that are determined to be in non-compliance with the United Nations Global Compact.
- The Fund may pursue a 'long-short' strategy whereby, in addition to buying and holding assets, it may use FDI to take 'short' positions where the Fund may make money in respect of issuers whose securities it believes to be overvalued or likely to fall in value.
- In addition to the above, the Fund may also invest in a number of other assets including other funds, debt securities, cash and other liquid assets. Debt securities can be issued by either government or corporate entities and will have an investment grade rating. The Fund may increase its holdings of cash and other liquid assets in times of market turbulence.
- Benchmarks. The Fund is actively managed; no benchmark is used as a universe for selection or for performance comparison purposes.
- The Fund may actively use FDI to achieve the investment objective, for hedging a given instrument or against anticipated movements in a market or other sector or where it is more cost effective than directly holding the underlying asset. The use of FDI may multiply the gains or losses made by the Fund on a given instrument or on its investments generally. FDI may allow the Fund to obtain market exposure in excess of the value of the Fund's assets (leverage).
- The extensive use of FDI, and the fact that FDI may only require a small upfront payment, may mean the Fund is consistently required to hold a substantial portion of its assets in bank deposits and other money market securities.
- The Fund's reference currency is EUR. This share class is denominated in SEK. The Fund will use financial derivatives to the extent reasonably possible with the aim of protecting investors against EUR / SEK currency fluctuations.
- Any income earned on investments will be added to the value of investors' shares and investors can buy and sell their shares on each dealing day of the Fund.

- The Fund will be exposed to credit risk on counterparties with which it trades in relation to on-exchange traded instruments such as futures and options and where applicable, 'over-the-counter' ("OTC", "non-exchange") transactions. OTC instruments may also be less liquid and are not afforded the same protections that may apply to participants trading instruments on an organised exchange.
- Liquidity characteristics of non-exchange listed investments can be irregular,

- The Fund will invest financial derivative instruments ("FDI") (instruments whose prices are dependent on one or more underlying asset) to achieve its investment objective. The use of FDI involves additional risks such as high sensitivity to price movements of the asset on which it is based. The extensive use of FDI may significantly multiply the gains or losses.
 - The Fund's use of FDI may result in increased leverage which may lead to significant losses.
 - The Fund is a specialist geographic regional fund which, as a result, may carry greater risk than a more internationally diversified portfolio.
 - The value of investments designated in another currency may rise and fall due to exchange rate fluctuations. Adverse movements in currency exchange rates may result in a decrease in return and a loss of capital. 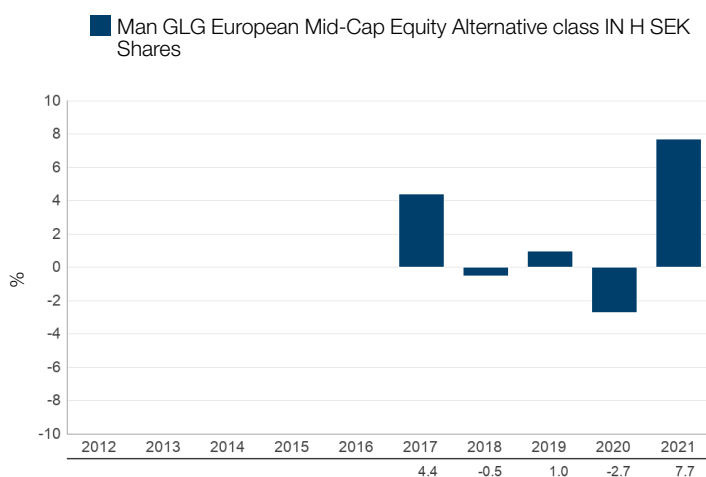
