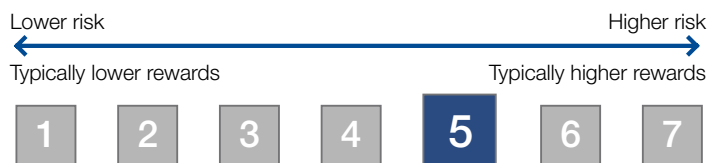
(ISIN:IE00BYM0LH90) Man GLG Unconstrained Emerging Equity (the 'Fund') is a sub-fund of Man Funds VI plc (the 'Company').

Man Asset Management (Ireland) Limited, part of Man Group plc, is the Manager of the Company.

Objectives and investment policy

- The Fund seeks to provide capital gains in the medium to long-term. The Fund will seek to achieve this return through investment primarily in shares of companies listed in emerging market countries worldwide. The Fund may also invest in companies listed in developed markets, typically where they have an economic exposure to emerging markets. The Fund may invest up to 100% in emerging markets. The Investment Manager selects the companies in which to invest on the basis of a detailed screening criteria which includes requiring a high quality of business prospects, management and financial strength and an analysis of expected future value of the companies.
- The Portfolio will seek to outperform the Morgan Stanley Capital International (Emerging Markets) Index (Total Return Net Dividend) "MSCI EM Index (TRND)" (BBG ticker NDUEEGF), over the medium and long-term.
- In addition to the above, the Fund may also invest in a number of other assets including global currencies and other funds. The Fund may also invest in money market instruments, debt securities, cash and other liquid assets. Debt securities can be issued by either government or corporate entities and may be rated either investment grade or non-investment grade. No more than 30% will be invested in sub-investment grade bonds. The Fund may increase its holdings of cash and other liquid assets in times of market turbulence.
- The Fund will primarily apply a long investment strategy, however, it may also take short positions using FDI's (ie instruments whose prices are dependent on one or more underlying assets 'FDI') for hedging, efficient portfolio management and investment purposes, which shall not typically exceed 25% of the portfolio NAV.
- The Fund may actively use FDI to achieve the investment objective, for hedging a given instrument or against anticipated movements in a market or other sector or where it is more cost effective than directly holding the underlying asset. The use of FDI may multiply the gains or losses made by the Fund on a given instrument or on its investments generally.
- FDI may allow the Fund to obtain market exposure in excess of the value of the Fund's assets (leverage).
- The Fund may actively use FDI to provide investors with the currency risk associated with the underlying investments of the Fund, or of an appropriate benchmark.
- Investment in the Fund is suitable for investors seeking long-term capital growth with an investment horizon of at least five years.
- Any income earned on investments will be added to the value of investors' shares and investors can buy and sell their shares on each dealing day of the Fund.

Risk and reward profile

- Emerging markets experience specific risks due to increased volatility, illiquidity, political and economic instability, market turmoil, settlement risk and relatively weak regulatory standards.
- The use of FDI involves additional risks: (i) FDI may be highly sensitive to price movements of the asset on which they are based; (ii) a counterparty to a non-exchange traded FDI may not meet its payment obligations in the event of default; (iii) the use of FDI may result in increased leverage. 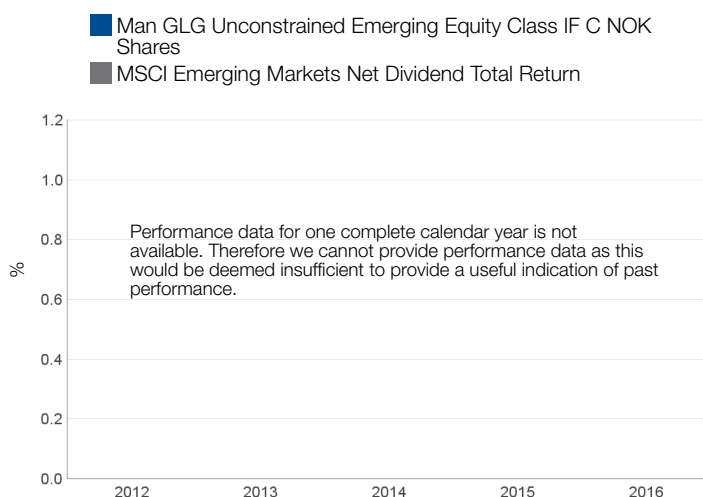
