A sub-fund of **HSBC Global Investment Funds** (the "UCITS"), managed by HSBC Investment Funds (Luxembourg) S.A.

### Objectives and investment policy

- ▶ The aim is to provide capital growth and income on your investment over time.
- ▶ The fund will invest primarily in high quality bonds (types of fixed income securities) or similar securities which are denominated in US Dollars.
- ▶ The fund will invest in bonds or similar securities issued or guaranteed by companies, governments and government related agencies.
- ▶ The fund will invest primarily in bonds or similar securities issued in developed markets and denominated in developed market currencies.
- ▶ The fund may invest up to 50% of its assets in Asset Backed Securities (ABS), including Mortgage Backed Securities (MBS). ABS and MBS are types of debt securities the repayments of from which come from loans or mortgages.
- ▶ The fund may invest up to 10% of its assets in contingent convertible securities (CoCos).
- ▶ The fund may invest up to 10% of its assets in other open-ended funds, including other funds of HSBC.
- ▶ The fund may use derivatives to help meet its investment objectives.
- ▶ The fund may also use derivatives for hedging or efficient portfolio management purposes (such as to manage risks or costs or to generate additional capital or income).
- ▶ The fund is actively managed and does not track a benchmark. Consideration may be given to a reference benchmark when selecting investments. The reference benchmark for the fund is Bloomberg Barclays US Aggregate.
- ▶ You may sell your investment on any working day by submitting an application to the Administrator before the dealing deadline.
- ▶ Income is distributed.
- ▶ Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

#### More about this rating

The rating is based on price volatility over the last five years, and is an indicator of absolute risk. Historical data may not be a reliable indication for the future. #### Why is this fund in category 3?

Fixed income securities are more risky than money market instruments given increased credit and interest rate risk. However, debt securities are not exposed to equity risk and are therefore less risky than equity securities.

#### Risks materially relevant not adequately captured by the SRRI

- ▶ **Exchange Rate Risk** Changes in currency exchange rates could reduce or increase investment gains or investment losses, in some cases significantly.
- ▶ **Counterparty Risk** The possibility that the counterparty to a transaction may be unwilling or unable to meet its obligations.
- ▶ **Liquidity Risk** Liquidity Risk is the risk that a Fund may encounter difficulties meeting its obligations in respect of financial liabilities that are settled by delivering cash or other financial assets, thereby compromising existing or remaining investors.
- ▶ **Operational Risk** Operational risks may subject the Fund to errors affecting transactions, valuation, accounting, and financial reporting, among other things.
- ▶ **Derivatives Risk** Derivatives can behave unexpectedly. The pricing and volatility of many derivatives may diverge from strictly reflecting the pricing or volatility of their underlying reference(s), instrument or asset.
- ▶ **Investment Leverage Risk** Investment Leverage occurs when the economic exposure is greater than the amount invested, such as when derivatives are used. A Fund that employs leverage may experience greater gains and/or losses due to the amplification effect from a movement in the price of the reference source.
- ▶ **Interest Rate Risk** When interest rates rise, bond values generally fall. This risk is generally greater the longer the maturity of a bond investment and the higher its credit quality.
- ▶ **Default Risk** The issuers of certain bonds could become unwilling or unable to make payments on their bonds.
- ▶ **Credit Risk** A bond or money market security could lose value if the issuer's financial health deteriorates.
- ▶ **CoCo Bond Risk** Contingent convertible securities (CoCo bonds) are comparatively untested, their income payments may be cancelled or suspended, and they are more vulnerable to losses than equities and can be highly volatile.

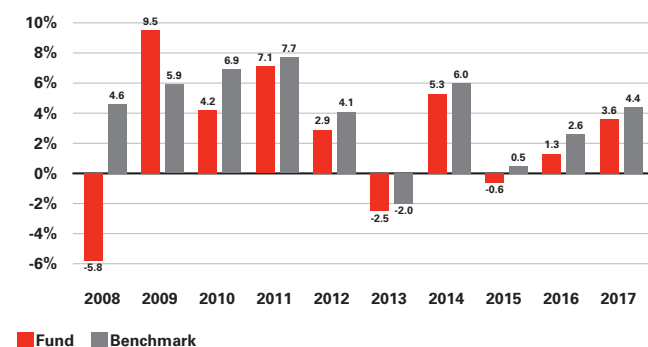
The Entry and Exit charges shown are the maximum that may be charged. In some cases you may pay less. You can obtain the actual charges from your financial adviser.
