Objective and Investment Policy

Investment Objective

The objective of the Sub-Fund is to achieve long-term capital growth by investing in Asia-Pacific companies with above average yield and/or seeking growth in dividend.

Typical investors would seek long-term capital growth measured in USD from an actively managed portfolio of listed equity, equity-related securities and derivatives instruments.

Investment Policy

The Investment Manager will seek to achieve the objective of the Sub-Fund by investing at least 70% of its net assets in equities (including REITs) and equity-related instruments issued by Asia-Pacific all cap companies, which, in the Investment Manager's opinion, show above average yield and/or seeking growth in dividend.

Out of the 70% limit, the Sub-Fund may invest up to 30% of its net assets in Chinese A shares listed in the Shanghai Hong-Kong Stock Connect.

Investment decisions are based on a combination of macroeconomic, thematic approach and company specific analysis notably on free cash flow generation, dividend yield and dividend growth.

The stock selection process relies mainly on a rigorous analysis of the companies' business model, quality of management, dividend pay-out, earnings prospects and overall risk return profile.

The Sub-Fund may invest up to 20% of its net assets in convertible bonds and straight bonds.

The Sub-Fund may invest in Money Market Instruments and exchange-traded funds (ETFs).

The Sub-Fund will invest not more than 10% of its net assets in units of UCITS and/or other UCIs.

For efficient portfolio management purposes both for hedging and investment purposes, this Sub-Fund may use derivative instruments within the limits set forth in the section "Investment Restrictions".

Sub-Fund Currency

The reference currency of the Sub-Fund is USD.

Investment Horizon

This Sub-Fund may not be suitable for investors who plan to withdraw their contribution within 8 years.

Processing of subscription and redemption orders

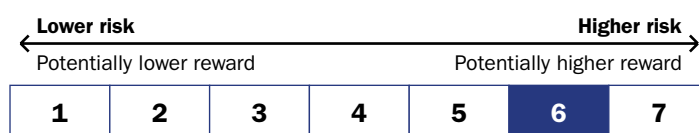
The subscription, conversion or redemption orders must be received by the Registrar and Transfer Agent on any Valuation Day no later than 3 p.m. Luxembourg time. Orders will be processed at the Net Asset Value applicable to the following Valuation Day. The investor's attention is drawn to the existence of potential additional processing time due to the possible involvement of intermediaries such as Financial Advisers or distributors.

The Net Asset Value of this Sub-Fund is calculated on a daily basis.

Income

For Capitalisation share classes (Cap), the dividend is reinvested.

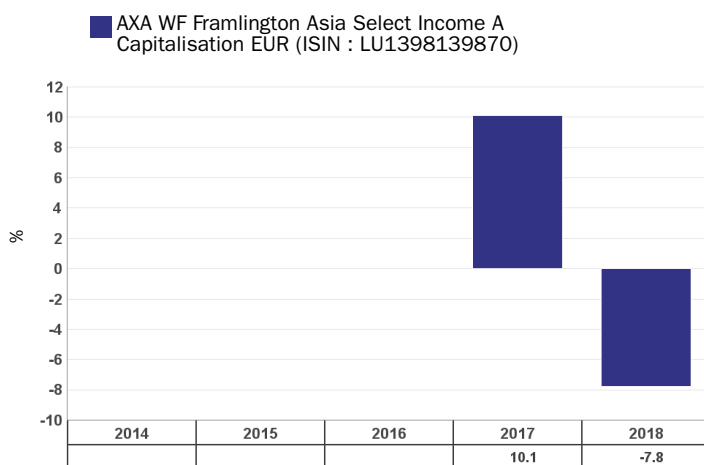
