Objective and Investment Policy

Investment Objective

The Sub-Fund seeks to provide long-term capital growth, measured in USD, from a portfolio of listed equity and equity related securities of companies that create financial and societal value by fostering gender diversity and leveraging on the increasingly important economic role of women.

Investment Policy

The Sub-Fund will seek to achieve its objectives by investing at least two thirds of its total net assets in equities and equity-related instruments issued by all cap companies worldwide which (i) are leaders in the reduction of gender-gap and foster diversity, (ii) have a high representation of women in management and leadership and/or (iii) demonstrate a strong commitment to empower women in their board and management according to the "United Nations Women Empowerment Principles" and implement women friendly policies.

Investment decisions are based on a combination of macro-economic, sector and company specific analysis. The securities selection process relies on a rigorous analysis of the companies' business model, management quality, growth prospects and risk/return profile, with a focus on medium to longterm benefits from the companies which demonstrates a strong commitment to promote women leadership. The process also relies on responsible investments filters and analysis as well as impact appraisal, monitoring and measurement to verify and demonstrate that the desired outcome could be attained.

There is no predetermined geographical asset allocation and the Sub-Fund may invest its nets assets in either developed or emerging markets.

The Sub-Fund may also invest up to $1/3\ \text{of}$ its net assets in Money Market Instruments.

Within a limit of 200% of the Sub-Fund's net assets, the investment strategy may be achieved by direct investments and/or through derivatives. Derivatives may also be used for hedging purposes.
