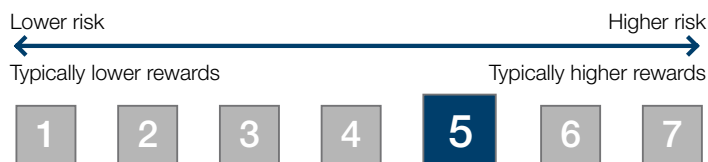
(ISIN:IE00BZ607S50) Man GLG European Equity Alternative (the 'Fund') is a sub-fund of Man Funds VI plc (the 'Company').

Man Asset Management (Ireland) Limited, part of Man Group plc, is the Manager of the Company.

### Objectives and investment policy

- The Fund seeks to provide investors with positive returns by investing primarily in listed shares and related instruments of shares listed in Europe, or of issues which derive a substantial part of their revenue from activities in Europe.
- The Fund may also invest in issuers and markets outside Europe and in other asset classes. These asset classes include, but are not limited to, currency, debt and interest rates globally and other funds. The Fund may increase its holdings in cash and other liquid assets in times of market turbulence.
- The Fund may invest up to 50% of its Net Asset Value in emerging markets. The Fund is, however, managed to be market neutral (meaning it will seek to achieve returns regardless of whether markets are rising or falling) with tight risk constraints such that any such allocation to emerging markets may result in a limited directional exposure (ie exposure to the direction of movement of value of positions). The emerging market exposure will not exceed 15% of the gross Fund value (ie the absolute value of all long and short positions in the Fund).
- Debt securities may be issued by any government, company or international agency and are not subject to a minimum rating requirement.
- The Portfolio's investment, directly, or indirectly through the use of derivatives, in fixed-income securities listed or traded on Recognised Markets in Russia shall not exceed 20% of the Net Asset Value of the Portfolio.
- The Fund will pursue a 'long-short strategy' whereby, in addition to buying and holding assets, it may use financial derivative instruments (ie instruments whose prices are dependent on one or more underlying assets, 'FDI') extensively to achieve its investment objectives or to take 'short' positions where the Fund may benefit from a fall in value of the underlying asset.
- Benchmarks. The Fund is actively managed; no benchmark is used as a universe for selection or for performance comparison purposes.
- The Fund may actively use FDI to achieve the investment objective, for hedging a given investment or against anticipated movements in a market or other sector or where it is more cost effective than directly holding the underlying asset. The use of FDI may multiply the gains or losses made by the Fund on a given investment or on its investments generally.
- FDI may allow the Fund to obtain market exposure in excess of the value of the Fund's assets (leverage).
- The extensive use of FDI, and the fact that FDI may only require a small upfront payment, may mean the Fund is consistently required to hold a substantial portion of its assets in bank deposits and other money market securities.
- The Fund will use FDI to provide investors with a similar return to any share class issued in the working currency of the Fund (EUR).
- Income generated by the Fund will be distributed to investors who have elected for distribution payments and investors can buy and sell their shares on each Dealing Day of the Fund.

### Risk and reward profile

#### The following risks may not be fully captured by the risk and reward profile:

- Emerging markets experience specific risks due to increased volatility, illiquidity, political and economic instability, market turmoil, settlement risk and relatively weak regulatory standards.
- The Fund will be exposed to credit risk on counterparties with which it trades in relation to on-exchange traded instruments such as futures and options and where applicable, 'over-the-counter' ("OTC", "non-exchange") transactions. OTC instruments may also be less liquid and are not afforded the same protections that may apply to participants trading instruments on an organised exchange.
- The Fund will invest financial derivative instruments ("FDI") (instruments whose prices are dependent on one or more underlying asset) to achieve its investment objective. The use of FDI involves additional risks such as

high sensitivity to price movements of the asset on which it is based. The extensive use of FDI may significantly multiply the gains or losses.

- Liquidity characteristics of non-exchange listed investments can be irregular, and may result in higher than anticipated costs to liquidate the investment.
- The Fund's Investment Manager relies on internally derived qualitative and quantitative trading models and algorithms. These quantitative trading models and algorithms may rely on data that is internally derived or provided by a third party. If a model or algorithm or the data consumed by these models or algorithms prove to be incorrect or incomplete, the Fund may be exposed to potential losses. The calculations and output of a models or algorithm can be impacted by unforeseen market disruptions and/or government or regulatory intervention, leading to potential losses.
- The Fund is a specialist geographic regional fund which, as a result, may carry greater risk than a more internationally diversified portfolio.
- The value of investments designated in another currency may rise and fall due to exchange rate fluctuations. Adverse movements in currency exchange rates may result in a decrease in return and a loss of capital. It may not be possible or practicable to successfully hedge against the currency risk exposure in all circumstances.
- The Fund's use of FDI may result in increased leverage which may lead to significant losses.
- The currency hedging used for this share class to minimise the effect of certain exchange rate fluctuations may not be completely successful and currency hedging transactions will involve counterparty risk.
- The Fund is subject to normal market fluctuations and the risks associated with investing in international securities markets and therefore the value of your investment and the income from it may rise as well as fall and you may not get back the amount originally invested.
- There is no guarantee that the Fund will achieve its investment objective.

## Charges

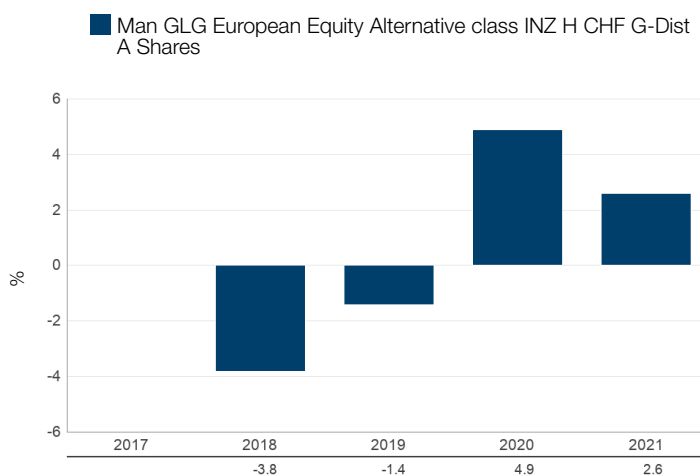
