Objective and Investment Policy

Investment Objective

The Sub-Fund seeks to achieve long term capital growth measured in Euro by investing in large, medium and small capitalisation companies domiciled or listed in Italy.

Investment Policy

The Sub-Fund is actively managed in order to capture opportunities in Italian equity markets. Investment decisions are based on a combination of macroeconomic, sector and company specific analysis. The share selection process relies on a rigorous analysis of the companies' business model, quality of management, growth prospects and overall risk return profile.

The Sub-Fund invests at least 75% of its assets in equities, equivalent securities, investment certificates and cooperative investment certificates issued by companies having their registered office in the European Economic Area (i.e. securities or rights eligible to the French Plan d'Epargne en Actions - PEA).

The Śub-Fund shall also comply with investment criteria in order to qualify as a piani individuali di risparmio a lungo termine (PIR) Sub-Fund for plans opened until 31 December 2018 pursuant to Law n° 232 of 11 December 2016.

Specifically, at all times the Sub-Fund shall invest at least 70% of its net assets in securities and rights issued by companies

(i) domiciled and/or listed in Italy or in an EU or European Economic Area member state and have a permanent establishment in Italy, and

(ii) not engaged in activities such as renting, buying, selling, developing, managing or brokering real estate.

Among this limit and during a total of 2/3 of the calendar year, at least 30% must be issued by companies which are not listed in the FTSE MIB index or any other equivalent indices.

The Sub-Fund cannot invest more than 10% of its net assets in securities or rights issued or entered with the same company.

The Sub-Fund cannot invest in securities issued by companies which are not resident in countries that allow an adequate exchange of information with Italy.

The Sub-Fund will invest not more than 10% of its nets assets in units of UCITS and/or other UCIs.

Within the limit of 200% of the Sub-Fund's net assets, the investment strategy may be achieved by direct investments and/or through derivatives. Derivatives may also be used for hedging purposes.

Income

For Capitalisation share classes (Cap), the dividend is reinvested.

Sub-Fund Currency

The reference currency of the Sub-Fund is EUR.

Investment Horizon

This Sub-Fund may not be suitable for investors who plan to withdraw their contribution within 8 years.

Processing of subscription and redemption orders

The subscription, conversion or redemption orders must be received by the Registrar and Transfer Agent on any Valuation Day no later than 3 p.m. Luxembourg time. Orders will be processed at the Net Asset Value applicable to such Valuation Day. The investor's attention is drawn to the existence of potential additional processing time due to the possible involvement of intermediaries such as Financial Advisers or distributors.

The Net Asset Value of this Sub-Fund is calculated on a daily basis.


