## Objectives and Investment Policy

The Fund seeks to increase the value of its assets over the medium term by investing in shares issued by Australian companies, and/or companies operating in this country.

It is actively managed and as such may invest in securities that are not included in the index which is S&P/ASX 200 (RI).

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days).

The risk category is justified by the investment mainly in Stocks and Shares, the value of which can fluctuate considerably. These fluctuations are often amplified in the short term.

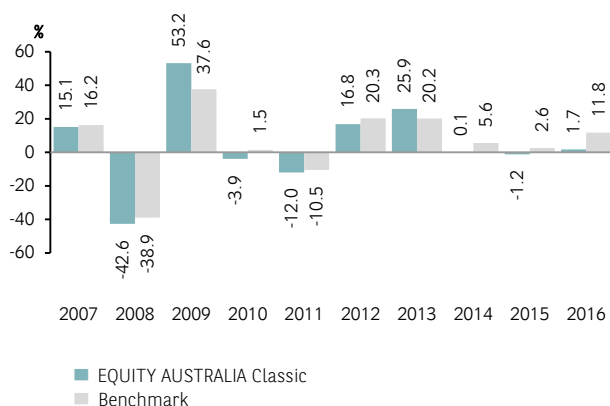
The **ongoing charges** figure is based on past expenses determined as of 30 November 2016
