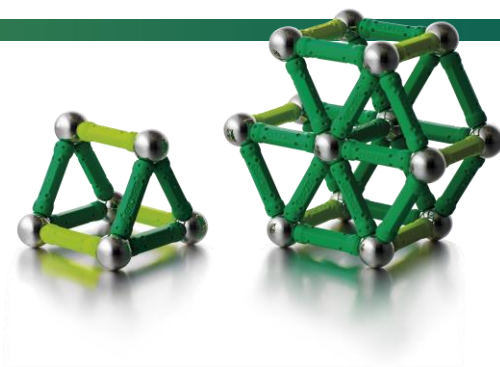

### FUND OBJECTIVE

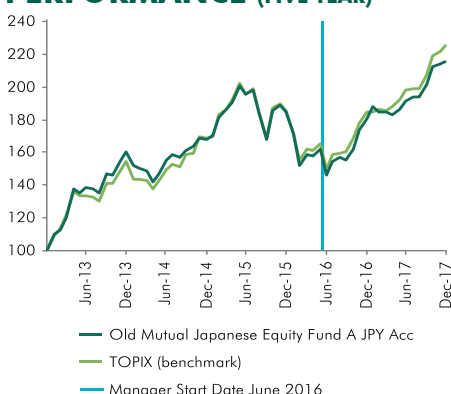
