INVESTMENT OBJECTIVE

Santander Short Duration Euro generates returns through investing in fixed income. The Fund invests mainly in Government bonds with a minimum rating of A-1 / P-1 by major rating agencies at the time they are acquired and money market and cash instruments in Euros with a 10% limit in deposits. The average duration of the portfolio will be approximately three months. The Sub-Fund may use derivatives with a view to reducing the risk of investment positions or for efficient portfolio management purposes or as a part of the investment strategy.

MONTHLY STRATEGY

We maintain the entire portfolio invested in German debt, sidestepping market volatility. The ECB is maintaining its expansive monetary policy at least through September 2018. We look forward to the economic forecasts in March, when there could be news. Germany's 2-year bond is trading at -0.55%, and non-core countries logged a negative performance, with Italy, Portugal and Spain logging returns of -0.20%, -0.05% and -0.21%, respectively.

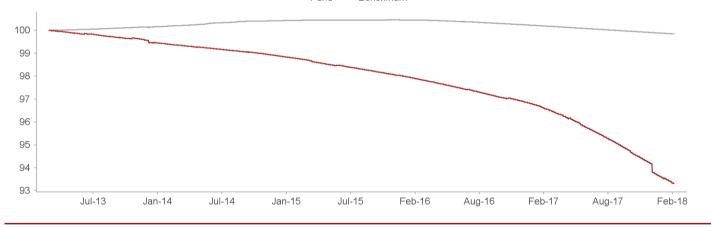
