### Objective and investment policy

**Objective:** The fund aims to grow capital over five years or more by investing mainly in a range of company shares from across Europe, excluding the UK.

**Core investment:** At least 80% of the fund is invested in the company shares of European companies. Currently, the fund is invested in the shares of a limited number of companies.

**Other investments:** The fund also invests in companies outside Europe, but only if these companies earn most of their revenue from business activities within Europe.

**Strategy in brief:** The fund manager selects stocks based on in-depth analysis of individual companies, taking a long-term investment view of three years or more. The fund manager seeks to invest in companies with sustainable competitive advantages, which have the opportunity to reinvest their capital at high rates of return. A company's strategy around the allocation of capital is central to the investment process. The fund usually holds shares in fewer than 50 companies.

**Performance measurement:** The fund is actively managed. The FTSE World Europe ex UK Index is a point of reference against which the performance of the fund may be measured.

#### Other information

The fund manager has the freedom to decide which investments should be held in the fund.

You can buy and sell shares in the fund on any business day. Provided we receive your instructions before 12 noon, shares will be bought at that day's price.

Any income from the fund will be rolled up into the value of your investment.

In addition to the charges set out in the charges section, the fund will incur portfolio transaction costs which are paid from the assets of the fund. These can be higher when investing outside Europe.

### Risk and reward profile

#### The main risks that could affect performance are set out below:

- This fund holds a relatively small number of investments and, as a result, may experience larger price rises and falls than a fund which holds a larger number of investments.
- Changes in currency exchange rates will affect the value of your investment.
- Where market conditions make it hard to sell the fund's investments at a fair price to meet customers' sale requests, we may temporarily suspend dealing in the fund's shares.
- Some transactions the fund makes, such as placing cash on deposit, require the use of other financial institutions (for example, banks). If one of these institutions defaults on their obligations or becomes insolvent, the fund may incur a loss.

## Charges

The charges shown in the table are used to pay the costs of running the fund, including the costs of marketing and distributing it. These charges reduce the potential growth of your investment.


