Directors' Report to Shareholders

Market Review

As far as the outlook for 2015 is concerned, there was considerable growth optimism around in the autumn of last year. Consensus expectations in October 2014 for 2015 global GDP growth were about 3.7%. However, like in previous years, this optimism had to be downgraded as the year under review progressed. As 2015 draws to a close, projections have consolidated around 3.0% - mainly because emerging market growth disappointed in the last 12 months, and US growth did not manage to accelerate.

In the emerging countries the first three quarters of 2015 were characterised by worries about China which is still in a long-term slowdown scenario as the administration is changing the focus of the country's business model. Rather than relying strongly on exports and capital spending which suffered from weakening demand in the industrial countries, the Chinese government is aiming to foster domestic growth, with an emphasis on the service sector and consumption. While this appears to be a very sensible strategy in general, it implies less growth in the transition phase. Consequently, official data show Chinese growth in Q3 2015 dropping below 7% for the first time since 2009. Many observers believe that the published 6.9% over-stated the underlying trend, and that activity is even weaker. This will particularly be the case in the "old economy", i.e. heavy industry and manufacturing. However, the services sector is holding up reasonably well in China, preventing a deeper drop in overall activity.

The US economy failed to deliver the growth acceleration many had expected. Rather, the second and third quarter of 2015 brought a significant slowdown in GDP growth. It was mainly the result of weakness in foreign trade due to sluggish demand from Asia and Latin America and the stronger US Dollar. However, capital spending also disappointed, not least due to frustration about lower energy prices by shale gas producers and other utilities. Japan and the UK as well missed economic forecasts that apparently had been too optimistic before 2015 started.

Against this sobering global backdrop, the euro zone economy held up relatively well. Owing to its trade exposure, Germany suffered from weaker demand of emerging economies, most notably China and Russia, the latter also reflecting a sanction-related shortfall. Nevertheless, many of the peripheral economies recovered. Spain was a particularly positive surprise, and even Italy managed to top cautious growth forecasts as some of the reforms of recent years began to bear fruit and unemployment started to fall.

The improvement in the euro zone's economic fortunes is, of course, not least a result of the ECB's aggressive policy easing. The Asset Purchasing Program (APP), the ECB's version of quantitative easing, coupled with a negative deposit rate and other accommodating measures, pushed euro area bond yields to record lows in the first quarter of 2015. At the trough, the entire German bund yield curve was negative up to a maturity of nine years, and periphery spreads fell to multi-year lows.

But in spite of promises by ECB president Mario Draghi to even intensify his efforts if circumstances warranted it, yields staged a temporary recovery later in the year, making 2015 one of the most difficult years for fixed income investors. Our explanation for this feature is the growing awareness of a major divergence of policies on both sides of the Atlantic. For some time, markets had expected the US Federal Reserve to announce their first rate hike already in September. Although it was eventually postponed until December, the emergence of different directions of monetary policies of the most important central banks caused increasing nervousness and led to the rise in euro area sovereign bond yields in the summer.

Market Outlook

Many of the drivers of 2015 are expected to prevail in 2016. In terms of monetary policy, the ECB has made it clear that it will continue its APP until at least March 2017. And unless unexpected shocks to the world or the US economy break the favourable trend of the US labour market, the Fed will probably guide its policy rates gradually higher. There is some potential for surprise concerning the extent of tightening in the US. The Fed's own projections suggest 100 basis points in four moves while the market is anticipating only two to three rate hikes. But the general pattern of very gradual tightening appears relatively certain.

Only few forecasters expect a major trend change in growth of the largest economies. China will continue to rebalance its economy. Hence, any sign of strength in its manufacturing sector would be a positive surprise. But services sector resilience and more stimulus from the People's Bank of China which could exert further gradual downward pressure on the exchange rate are expected to make the restructuring of the economy manageable so that GDP growth should remain above 6%. Recent cautiously positive signs from selected Japanese indicators suggest that Asia as a whole should stabilise and perhaps even start contributing more to global GDP growth – helped by ongoing monetary stimulus and the increasingly close trade relations within the region and with the US as the Trans-Pacific Trade Partnership (TPP) takes effect.

A more positive development is also expected from Russia. If oil prices do not fall further and if the sanctions due to the Ukraine conflict are not being intensified, the deep recession might end in the second half of 2016. Moreover, if the sanctions were to be lifted, even only partly, this would provide a boost to the economy.

Other regions are expected to fare less well. Especially Latin America is still in a recession, led by Brazil, and there are not too many signs of improvement. However, the emerging and developing economies in aggregate are expected to recover in 2016, and to start contributing a little bit more to global GDP growth.

This is likely to support the euro area which, in addition, will continue to benefit from continued ultra-aggressive ECB policy and a weaker euro on average next year. In the absence of major shocks, Germany should manage to stabilise its net trade position. In addition, solid wage and employment growth in the euro area's largest economy should result in healthy consumption growth.

Spain should remain on a growth trajectory, but political uncertainty, among others, might moderate the pace somewhat. Coupled with moderate progress in the growth trends of France and Italy, this is expected to lead to a slight acceleration of euro area aggregate GDP growth. For 2016, we forecast 1.7%, up from 1.5% in the preceding year.

Financial Market Impact

Given expected Fed tightening, there is hardly any downside for bund yields in 2016. However, any increase in euro zone government bond yields should be limited due to ongoing ECB purchases. The divergence of monetary policies makes yield forecasts very uncertain.

As the worst fears of uncontrollable consequences of Fed tightening are over, emerging market outflows are likely to wane, revealing recovery potential in both EM fixed income and equity markets. However, this will apply selectively only, to economically sound countries.

Given our expectation of a gradually improving global economic backdrop, ongoing policy stimulus from the ECB, the benefits of low energy prices and pent-up demand in many former crisis countries, we continue to be cautiously optimistic for euro area equity markets which we expect to outperform most other global peers.

Fund Review and Important Information to Shareholders

The BNY Mellon Compass Fund comprises 12 active sub-funds as at 31 October 2015, covering a range of equity and bond products as well as certain appealing niche investments.

Both the Fund and the Management Company, BNY Mellon Fund Management (Luxembourg) S.A., are UCITS IV compliant.

New sub-funds, share classes and liquidations

During the reporting period, two new sub-funds were launched:

- BNY Mellon Compass Fund: Euro Credit Laufzeitfonds 2019 with effective date 3 December 2014
- BNY Mellon Compass Fund: Multi Asset Absolute Return Fund with effective date 25 June 2015.

The Board of Directors resolved to terminate the sub-funds:

- BNY Mellon Compass Fund: ABS Fund with effective date 3 December 2014,
- BNY Mellon Compass Fund: Global Emerging Market Fund with effective date 31 July 2015,
- BNY Mellon Compass Fund: U.S. Investment Grade Corporate Bond Fund 1-5 Years with effective date 11 May 2015.

The total net assets of these sub-funds had decreased to a level which made it increasingly difficult to operate the product in an economically efficient manner and which necessitated an economic rationalisation.

Subsequently to the reporting period the Board of Directors also resolved to terminate the BNY Mellon Compass Fund: Global Opportunistic Fixed Income with effective date 16 November 2015.

New Prospectus during the financial year

One revised prospectus was issued during the period under review.

The prospectus dated "June 2015" entered into force including the new sub-funds: the "BNY Mellon Compass Fund: Euro Credit Laufzeitfonds 2020", the "BNY Mellon Compass Fund: Multi Asset Absolute Return Fund" and "BNY Mellon Compass Fund: Crossover Credit Fund" in addition to the following changes:

- 1. Amendment of the risk-benchmarks of "BNY Mellon Compass Fund-Euro Corporate Bond Fund" and "-Euro High Yield Bond Fund".
- 2. Invest up to 10% in contingent convertibles for "Compass-Euro Corporate Bond Fund", "-Euro High Yield Bond Fund", "-Global High Yield Bond Fund", "-Euro Credit Short Duration Fund", "-Multi Asset Absolute Return Fund", "-Crossover Credit Fund", "-Global Emerging Markets Bond Fund".
- Various editorial amendments through the prospectus.

Registrations for distribution

The Fund is totally or partly registered for distribution in Austria, Chile, Finland, France, Germany, Italy, Luxembourg, Norway, Peru, Portugal, Singapore, Spain, Sweden, Switzerland and in the UK.

Fund performance review*

During the period under review, the BNY Mellon Compass Fund total net assets decreased from EUR 2.4bn to EUR 2.1bn.

The assets of the "Euro Credit Laufzeitfonds 2019" and "Euro Small Cap Equity Fund" increased significantly.

In terms of performances, all sub-funds were in positive territories except for the "Eastern Europe Diversified Fund", the "Global Opportunistic Fixed Income", the "Global Emerging Markets Bond Fund" and the "Euro Corporate Bond Fund".

Within the range, the "Euro Small Cap Equity Fund" and the "Global High Yield Bond Fund" achieved the highest return over the period with respectively +24.9% and +8.9%. *

REPORT OF THE REVISEUR D'ENTREPRISES AGREE

Following our appointment by the annual general meeting of the Shareholders, we have audited the accompanying financial statements of BNY Mellon Compass Fund and each of its subfunds, which comprise the statement of net assets and the statement of investments and other net assets as at October 31st, 2015 and the statement of operations and the statement of changes in net assets for the year then ended, and a summary of significant accounting policies and other explanatory information.

Board of Directors of the SICAV responsibility for the financial statements

The Board of Directors of the SICAV is responsible for the preparation and fair presentation of these financial statements in accordance with Luxembourg legal and regulatory requirements relating to the preparation of the financial statements, and for such internal control as the Board of Directors of the SICAV determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

Responsibility of the Réviseur d'Entreprises agréé

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with International Standards on Auditing as adopted for Luxembourg by the Commission de Surveillance du Secteur Financier. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the judgement of the Réviseur d'Entreprises agréé, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the Réviseur d'Entreprises agréé considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.

An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the Board of Directors of the SICAV, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements give a true and fair view of the financial position of BNY Mellon Compass Fund and each of its sub-funds as of October 31, 2015, and of the results of their operations and changes in their net assets for the year then ended in accordance with Luxembourg legal and regulatory requirements relating to the preparation of the financial statements.

Other matter

Supplementary information included in the annual report has been reviewed in the context of our mandate but has not been subject to specific audit procedures carried out in accordance with the standards described above. Consequently, we express no opinion on such information. However, we have no observation to make concerning such information in the context of the financial statements taken as a whole.

Notes to the financial statements as at 31 October 2015

1. ORGANISATION

BNY Mellon Compass Fund (the "Company") is an open-ended investment company with variable capital (Société d'Investissement à Capital Variable, "SICAV") with multiple sub-funds organised as a Société Anonyme under the laws of the Grand Duchy of Luxembourg. The Company was incorporated in Luxembourg on 18 December 1998 for an unlimited period.

On 28 September 2001 the Company changed its name from WestLB Compass Fund to WestAM Compass Fund. On 29 May 2006 the Company changed its name from WestAM Compass Fund to WestLB Mellon Compass Fund. On 20 February 2013 the Company changed its name from WestLB Mellon Compass Fund to BNY Mellon Compass Fund.

The Company is registered as an undertaking for collective investment pursuant to Part I of the law of 17 December 2010, as amended and to the law of 10 August 1915, as amended.

Its initial Articles of Incorporation were published in the "Mémorial, Recueil des Sociétés et Associations" on 1 February 1999. The last amendment of the Articles has been endorsed by an extraordinary general meeting of shareholders as of 20 February 2013 and was published in the Mémorial on 29 April 2013. The Company is registered with the Registre de Commerce et des Sociétés of Luxembourg under number B 67 580.

2. SIGNIFICANT ACCOUNTING POLICIES

A) GENERAL

These financial statements are prepared in accordance with generally accepted accounting principles in the Grand Duchy of Luxembourg applicable to investment funds.

B) INVESTMENT VALUATION

In determining the value of the assets of the Company, each security which is quoted or dealt in on a stock exchange is valued at its latest available price on the stock exchange which is normally the principal market for such securities, and each security dealt in on an over-the-counter market is valued in a manner as near as possible to that for quoted securities.

The value of securities not quoted or dealt in on a stock exchange or an over-the-counter market, and of securities which are so quoted or dealt in but in respect of which no price quotation is available or the price quoted is not representative of the security's fair market value, is valued at fair value as determined in good faith pursuant to procedures established by the Board of Directors. This fair value policy makes it possible to value certain assets/debt securities on a daily basis by taking into account different items of information/price sources such as the performance of indices and prices received from brokers or databases or internal valuation models.

Short-term investments purchased and maturing within 90 days from the date of purchase are valued at amortised cost, which approximates market value.

C) CONVERSION OF FOREIGN CURRENCIES

The books and records of each sub-fund are denominated in the base currency of the corresponding sub-fund. Amounts denominated in other currencies are translated into the base currency on the following basis: (i) investment valuations and other assets and liabilities initially expressed in other currencies are converted each business day into the base currency on exchange rates prevailing on each business day; (ii) purchases and sales of foreign investments, income and expenses are converted into the base currency using currency exchange rates prevailing on the respective dates of such transactions.

Net realised gains and losses on foreign exchange represent: (i) foreign exchange gains and losses from the sale and holding of foreign currencies; (ii) gains and losses between trade date and settlement date on securities or derivatives transactions; (iii) gains and losses arising from the difference between amounts of dividends and interest or other income, respectively expenses recorded and the amounts actually received, respectively paid.

The resulting profits and losses on transactions are included in the Statement of Operations and Changes in Net Assets.

The reference currency of the combined statements is EUR.

The exchange rates applied as at 31 October 2015 are as follows:

D) SECURITIES TRANSACTIONS AND INVESTMENT INCOME

Securities transactions are recorded on a trade date basis. Dividend income is accrued on the ex-dividend date. Interest income is recorded on an accrual basis. Realised gains or losses are determined on the basis of the average cost of securities sold.

E) FORWARD CURRENCY EXCHANGE CONTRACTS, FINANCIAL FUTURES CONTRACTS, OPTION CONTRACTS AND SWAP CONTRACTS

The Company enters into forward currency exchange contracts, financial futures contracts, option contracts and swap contracts which, to varying degrees, represent a market risk in excess of the amount reflected on the Statement of Net Assets. The amount of the contracts represents the extent of the Company's participation in these financial instruments. Market risks associated with such contracts arise due to the possible movements in foreign exchange rates, indices, interest rates and security values underlying these instruments.

E) FORWARD CURRENCY EXCHANGE CONTRACTS, FINANCIAL FUTURES CONTRACTS, OPTION CONTRACTS AND SWAP CONTRACTS (Continued)

Other market and credit risks include the possibility that there may be an illiquid market for the contracts, that a change in the value of the contracts may not directly correlate with changes in the value of underlying currencies, indices, or securities, or that the counterparty to a contract defaults on its obligation to perform under the terms of the contract.

Forward Currency Exchange Contracts

A Forward Foreign Exchange Contract is an agreement to buy or sell a specific amount of foreign currency at a certain date, on or before a certain date. Outstanding Forward Currency Exchange Contracts are valued on 31 October 2015, by reference to the forward rate of exchange applicable to the maturity of the contracts. The unrealised gain or loss is shown in the Statement of Net Assets under "Net Unrealised Gain on Forward Currency Exchange Contracts" or "Net Unrealised Loss on Forward Currency Exchange Contracts".

Financial Future Contracts

A Future Contract is an agreement to buy or sell a standard amount of Financial Instrument at a final price and a fixed future date. Future Contracts are valued on 31 October 2015, which reflects the latest available price at close of business. The unrealised gain or loss is shown in the Statement of Net Assets under "Net Unrealised Gain on Financial Futures Contracts" or "Net Unrealised Loss on Financial Futures Contracts".

Options Contracts

Options are contractual agreements that convey the right, but not the obligation, for the purchaser either to buy or sell a specific amount of a financial instrument at a fixed price, either at a fixed future date or at any time within a specified period. Options contracts are valued on 31 October 2015 and the market value is shown in the Statement of Net Assets under "Options Purchased Contracts" under Assets. Written option contracts are valued on 31 October 2015, and the market value is shown in the Statement of Net Assets under "Options Written Contracts" under Liabilities.

Swaptions

The company may use Options on Swaps ("Swaptions"). A Swaption is an option granting its owner the right but not the obligation to enter into an underlying swap. There is no outstanding Swaptions as at 31 October 2015.

Interest Rate Swaps

An Interest Rate Swap is a bilateral agreement in which each of the parties agree to exchange a series of interest payments (usually fixed/floating) based on a notional amount that serves as a computation basis and that is usually not exchanged. Interest Rate Swaps are valued on 31 October 2015, at their market value. The valuation method involved a current value of each interest rate and capital series converted into the currency of the Company on the closing date. The result of these revaluations together with any interest receivable/payable in relation to interest swaps on 31 October 2015, is shown in the Statement of Net Assets, under "Net Unrealised Gain on Interest Rate Swap Contracts" or "Net Unrealised Loss on Interest Rate Swap Contracts".

Credit Default Swaps

A Credit Default Swap is a credit derivate transaction in which two parties enter into an agreement, whereby one party pays the other a yearic payment for the specified life of the agreement. The other party makes no payment unless a credit event, relating to a predetermined reference asset, occurs. If such an event occurs, the party will then make a payment to the first party, and the swap will terminate. Credit Default Swaps are valued at their market value. The valuation method involves the current value of the interest rate series and the current value of the credit spread traded on the market converted into the currency of the Fund on the closing date. The result of these revaluations, together with any interest receivable/payable related to the Credit Default Swaps on 31 October 2015, is shown in the Statement of Net Assets under "Net Unrealised Gain on Credit Default Swap Contracts" or "Net Unrealised Loss on Credit Default Swap Contracts".

Total Return Swaps

A Total Return Swap is a transaction in which the buyer receives the performance of an underlying asset and in return the buyer pays funding costs and generally, an arrangement fee. The underlying asset may be, but not limited to, a specific security, basket of securities, other instruments and index. Total Return Swap contracts are valued by reference to the mark to market value based on the market value of the underlying asset. The unrealised gain or loss is shown in the Statement of Net Assets under "Unrealised Gain on Total Return Swap Contracts" or "Unrealised Loss on Total Return Swap Contracts".

F) REVERSE REPURCHASE AGREEMENTS

Reverse repurchase agreements are similar in effect to a loan collateralized by the underlying securities. A reverse repurchase agreement is an agreement under which an assigner sells securities to another person (the assignee) whereby the assigner agrees to repurchase them at a specified time and at a specified price. The assignee agrees to retrocede these securities at a specified time and at a specified price. The Company is the assignee.

F) REVERSE REPURCHASE AGREEMENTS (Continued)

Reverse repurchase agreements are valued at cost expressed in the original currency, whatever the market value of the underlying securities is. Accrued interest since the purchase date is included in "Interest Receivable, Net" in the Statement of Net Assets.

On 31 October 2015, the Company was not committed into any Reverse Repurchase Agreement.

G) SECURITIES LENDING

The Company may lend portions of its securities portfolio to third parties. Such lending may only be effected via recognised clearing houses, or through the intermediary of prime financial institutions that specialise in such activities and in the modus specified by them. Such transactions may not be entered into for longer than 30 days. If the loan of securities exceeds 50% of the securities portfolio of the sub-fund concerned, it may only be effected on condition that is possible to terminate the loan contract with immediate effect. The Directors will ensure that revenues arising from securities lending arrangements and the division thereof are in accordance with usual market practice and that the Company retains an appropriate share thereof. A significant proportion of the income generated from the securities lending program is credited to participating sub-funds, with a portion of the income being paid to JPMorgan Chase Bank for its role as securities lending agent for the Company.

Income received from securities lending has been recognised in the Statement of Operations under "Other Income".

5. TAXATION

A) TAXE D'ABONNEMENT

The Company, in regards to Class C and Class D Shares are currently liable in Luxembourg to a tax of 0.05% per annum of its Net Asset Value, such tax being payable quarterly on the basis of the value of the net assets of the relevant classes of each sub-fund at the end of the relevant calendar quarter.

With regard to Class A, rf-A, rf15-A, B, rf-B, rf15-B, X-A and X-B Shares of all the sub-funds, the Company is liable to a tax of 0.01% per annum of its Net Asset Value, such tax being payable quarterly on the basis of the value of the aggregate net assets of the relevant classes of each sub-fund at the end of the relevant calendar quarter.

B) PROVISION FOR FOREIGN TAXES

Capital gains, dividends and interest on securities received from other countries may be subject to withholding or capital gains taxes imposed by such countries. It is the Company's policy to provide for any potential liability to foreign capital gains and income taxes.

6. TRAILER FEES AND REBATES

As part of marketing the Company in Switzerland, reimbursements may be made from the management fee received – included in accordance with the SFAMA (Swiss Funds & Asset Management Association) definition – to the following institutional Investors owning Company's shares for economic third parties:

- authorised distributors and distributors exempted from the authorisation requirement,
- sales partners placing the Company's shares exclusively with institutional investors with professional treasury facilities.
- sales partners placing the Company's shares exclusively with their clients on the basis of a written and remunerated discretionary asset management mandate.

7. TRANSACTION COSTS

The transaction costs are costs incurred by the sub-funds in connection with transactions on securities, futures and options. They consist of commissions and taxes relating to these transactions.

All shares in the Company are in registered form. Notices of all general meetings are sent to the Shareholders at their addresses in the register of Shareholders at least eight days prior to the meeting. Such notices include the agenda, specify the time and place of the meeting and the conditions of admission and refer to the requirements of Luxembourg law with regard to the necessary quorum and majorities required for the meeting.

The accounting year of the Company commences on the 1 November of each year and terminates on the 31 October of the following year.

APPENDIX 4

RISK MEASUREMENT AND CALCULATION OF GLOBAL EXPOSURE (UNAUDITED)

Calculation model for Global Exposure - Value-at-risk (VaR)

In accordance with the items a) to d) of point 5 of Box 22 of ESMA Guidelines 10-788:

- Risks covered by the model: Market Risk (in accordance with point 1 of Box 16 of ESMA Guidelines 10-788)
- **Methodology of the model:** The relative VaR calculation is based on either a Monte Carlo-simulation or the parametric / Variance-Covariance model. The absolute VaR calculation is based on Monte Carlo-simulation.
- Mathematical assumptions and foundations and data used: The underlying data has a history of a one year for relative or one month for absolute VaR. It is weighted with a decay factor of 0.94. The calculation results in a 10-day relative VaR with a confidence level of 99% and a 20-day absolute VaR with a confidence level of 99%.

The VaR calculations are validated by daily backtestings and stress tests.

Calculation standards used in the relevant VaR model

With reference to point 2 of Box 15 of ESMA Guidelines 10-788, the calculation standards used in the relative and absolute VaR model are as follows: One-tailed confidence interval of 99%.

Holding period equivalent to 10 days for relative VaR or 20 days respectively for absolute VaR (according to point 3 of Box 15 of ESMA Guidelines 10-788, the holding period can be different from the default holding period of one month if the holding period does not exceed one month).

Effective observation period of one year (250 business days) for the sub-funds the relative VaR is calculated for. Effective observation period of one month (20 business days) for the sub-fund the absolute VaR is calculated for. Daily data set updates.

Daily calculation.

Reference portfolio

The reference portfolios are determined on the basis of the investment strategies stipulated in the prospectus of the respective UCITS. All reference portfolios defined for the UCITS are leverage-free benchmarks customary in the market, reflecting the investment strategy which the UCITS is pursuing. The benchmark is a standardization that serves as the basis for a reference portfolio for the relative VaR approach.

Level of Leverage

In line with Boxes 24 and 25 of ESMA Guidelines 10-788, UCITS using the VaR approach should monitor and disclose leverage levels.

Leverage is calculated as the sum of the notionals of the derivatives used and does not take into account any netting or hedging arrangements.

Since the VaR approach does not directly limit the level of leverage, there is a possibility of higher leverage levels. It is however not expected that the level of leverage of any sub-fund will exceed 300% under normal market circumstances. The level of leverage may vary substantially over time.
