## Objectives and investment policy

- The aim is to provide capital growth of your investment over time.
- The fund will invest normally at least 90% of its assets in equity securities (i.e. shares) of companies of any size that are based in or which carry out most of their business in emerging markets.
- The fund will invest directly in shares of companies based in India.
- Investments in Chinese equities include China A-shares and China B-shares with a maximum exposure of 40% of the fund's assets. The fund may invest up to 30% of its assets in China A-shares through the Shanghai-Hong Kong Stock Connect and have up to 30% of its assets exposed to China A-shares indirectly through China A-shares Access Products ("CAAP").
- The fund invest up to 15% of its assets in a combination of participation notes and convertible securities.
- The fund may invest up to 10% of its assets in real estate investment trusts ("REITS").
- The fund may invest up to 10% of its assets in funds (including other funds of HSBC Global Investments Funds).
- The fund may use derivatives for hedging and cash flow management.
- The fund is actively managed and does not track a benchmark. Consideration may be given to a reference benchmark when selecting investments. The reference benchmark for the fund is MSCI Emerging Markets Net.
- The reference currency of the fund is USD. The reference currency of this share class is USD.
- Income is distributed.
- You may sell your investment on any working day by submitting an application to the Administrator before the dealing deadline.
- Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

#### More about this rating

### Why is this fund in category 6?

Emerging markets are at an early stage of development and typically experience higher levels of return fluctuation than well-established economies. Political and economic challenges may temporarily result in illiquid markets and higher volatility in prices and currencies.

# Risks materially relevant not adequately captured by the SRRI

- **Exchange rate risk** Investing in assets denominated in a currency other than that of the investor's own currency perspective exposes the value of the investment to exchange rate fluctuations.
- Liquidity risk Liquidity is a measure of how easily an investment can be converted to cash without a loss of capital and/or income in the process. The value of assets may be significantly impacted by liquidity risk during adverse market conditions.
- **Emerging market risk** Emerging economies typically exhibit higher levels of investment risk. Markets are not always well regulated or efficient and investments can be affected by reduced liquidity.


