### Objectives and Investment Policy

The Fund belongs to the category of short term money market funds as defined by ESMA. It seeks to achieve a return in line with prevailing money market rates while aiming to preserve capital consistent with such rates and to maintain a high degree of liquidity.

The Fund is not a guaranteed product. There is no currency exposure, other than to the EUR.

It is actively managed against the Cash index EONIA (RI).


The Fund may also use financial derivative instruments (interest rate swaps) for hedging purpose only. The impact of these financial derivative instruments will be taken into account for the calculation of the weighted average maturity (interest rate risk) of the fund. These financial derivative instruments will be used in line with the money market investment strategy of the sub-fund.

It invests in securities of high credit quality. The Management Company performs its own documented assessment of the credit quality of money market instruments that allows it to consider a money market instrument as high quality.

Income are systematically reinvested.

Investors are able to redeem on a daily basis (on Luxembourg bank business days)

## Risk and Reward Profile

- Why is the Fund in this specific category?
   This risk category is justified by the investment in Money Market instruments and Short term Bonds that have a low volatility.
- The higher the risk, the longer the recommended investment horizon.

Other risks materially relevant to the Fund which are not adequately captured by the indicator are described below:

- <u>Credit Risk</u>: This risk relates to the ability of an issuer to honour its commitments: downgrades of an issue or issuer rating may lead to a drop in the value of associated bonds.
- Liquidity Risk: This risk arises from the difficulty of selling an asset at a fair market price and at a desired time due to lack of buyers.
- <u>Counterparty Risk</u>: This risk is associated with the ability of a counterparty in an Over The Counter financial transaction to fulfil its commitments like payment, delivery and reimbursement.
- <u>Derivatives Risk</u>: When investing in over the counter or listed derivatives, the Fund
  aims to hedge and/or to leverage the yield of its position. The attention of the
  investor is drawn to the fact that leverage increases the volatility of the subfund.
