## **Objective and Investment Policy**

#### **Investment Objective**

The Sub-Fund seeks to achieve long term capital growth measured in Euros by investing mainly in listed equity issued by companies engaged in the real estate sector, domiciled or exercising the main part of their activities in Europe.

#### **Investment Policy**

The Sub-Fund is actively managed to capture opportunities in the Regulated European real estate markets. Investment decisions are based on a combination of macroeconomic and industry analysis and share selection. The share selection process relies mainly on a rigorous analysis of the companies' business model, the quality of the management, growth prospects, the nature of the underlying assets and the overall risk return. The Sub-Fund invests permanently at least two thirds in transferable securities issued by companies engaged in the real estate industry, domiciled or which exercise the predominant part of their economical activities in Europe.

The Sub-Fund may invest in equity securities of any market capitalisation (including small and micro-sized companies).

Within the limit of 200% of the Sub-Fund net assets, the investment strategy may be achieved by direct investments and/or through derivatives. Derivatives may also be used for hedging purposes.

#### Income

For Capitalisation share classes (Cap), the dividend is reinvested.

The reference currency of the Sub-Fund is EUR.




