BPI Global Investment Fund is managed by Caixabank Asset Management Luxembourg S.A.

### Objectives and investment policy

The investment objective of the Sub-Fund is to provide Unitholders with long-term capital appreciation through the investment in a diversified portfolio of mainly equity securities issued by companies of the European Union, Switzerland or Norway, with no specific focus on any economic sector of activity.

The Sub-Fund aims to produce returns by investing in multiple asset classes including equity securities, common stocks, preferred stocks, warrants, securities convertible into common stock or other securities indexed to stocks of companies. The target medium annual value of the equity securities referred to above will be equal or superior to two thirds of the medium net asset value of the Sub-Fund for the same period.

The Sub-Fund may also use Derivatives for the purposes of hedging and efficient portfolio management. The Sub-Fund will not enter into funded and unfunded total return swaps.

The Sub-Fund will not enter into SFTs. Should the Sub-Fund enter into SFTs in the future, the Prospectus will be amended accordingly prior to such use.

The Sub-Fund may also hold ancillary cash.

The Sub-fund pursues an actively-managed investment strategy.

The Sub-fund refers to the following Benchmark: MSCI Europe Total Return Net Index.

The benchmark is indicated for information purposes only, and the Fund manager does not intend to track it or to limit the Sub-fund's portfolio to the constituents of the Benchmark. The Fund can deviate from this benchmark.

The Benchmark is solely used as a reference to compare the performance of the Sub-fund. The Sub-fund's investment objective is not to track the performance of the Benchmark.

The base currency of the Sub-Fund is the EUR.

BPI Europa – I units are non-distributing: any income generated by the Sub-Fund is reinvested to grow the value of units of the Sub-fund.

**Recommendation**: this fund may not be appropriate for investors who plan to withdraw their money within 3 to 5 years.


