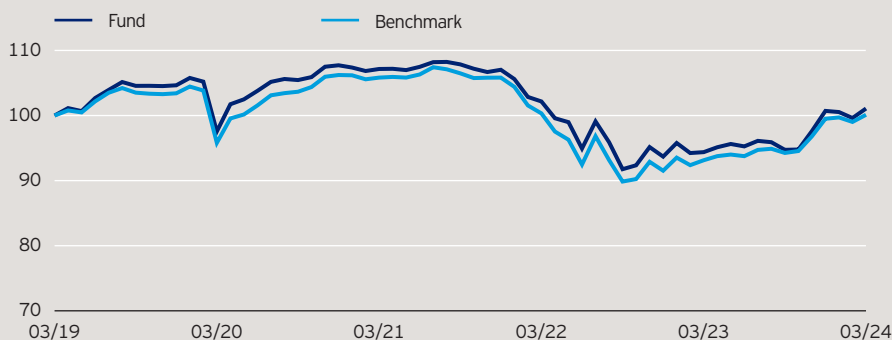

Fund Strategy

The fund holds a diversified portfolio of investment grade bonds with a small allocation to non-financial corporate high yield bonds. The largest allocation by sector remains financials with further notable holdings in non-financial hybrid bonds (bonds that have some equity like characteristics). To benefit from the additional yield available the fund also has an allocation to US dollar denominated bonds. The currency exposure from these bonds is hedged back to euros.

Past performance does not predict future returns. The performance period shown here starts on the last day of the first indicated month and ends on the last day of the last indicated month.

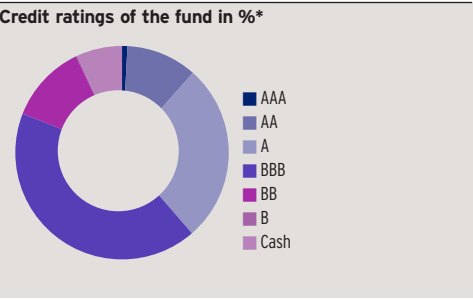

The wording of international sanctions is something that we pay particular attention to as there are occasions where sanctions can exist in limited form, for example allowing investments in the secondary market.
