A sub-fund of **HSBC Global Investment Funds** (the "UCITS"), managed by HSBC Investment Funds (Luxembourg) S.A.

### Objectives and investment policy

- ▶ The aim is to provide capital growth and income on your investment over time.
- ▶ The fund will invest normally at least 90% of its assets in equity securities (i.e.. shares) in companies of any size that are based in or which carry out most of their business in BRIC countries. BRIC countries are Brazil, Russia, India and China (including Hong Kong SAR).
- ▶ Investments in Chinese equities include China A-shares and China B-shares with a maximum exposure of 50% of the fund's assets. The fund may invest up to 40% of its assets in China A-shares through the Shanghai-Hong Kong Stock Connect and have up to 30% of its assets exposed to China A-shares indirectly through China A-shares Access Products ("CAAP").
- ▶ The fund may invest up to 10% of its assets in funds (including other funds of HSBC Global Investments Funds).
- ▶ The fund may use derivatives to meet its investment objectives.
- ▶ The fund may use derivatives for hedging and cash flow management.
- ▶ The fund is actively managed and does not track a benchmark. Consideration may be given to a reference benchmark when selecting investments. The reference benchmark for the fund is 25% MSCI Brazil Net 25% MSCI China Net 25% MSCI Russia Net and 25% MSCI India Net.
- ▶ The reference currency of the fund is USD. The reference currency of this share class is USD.
- ▶ Income is rolled up into the value of your investment.
- ▶ You may sell your investment on any working day by submitting an application to the Administrator before the dealing deadline.
- ▶ Recommendation: this fund may not be appropriate for investors who plan to withdraw their money within a period of 5 years.

#### More about this rating

#### Why is this fund in category 6?

Emerging markets are at an early stage of development and typically experience higher levels of return fluctuation than well-established economies. Political and economic challenges may temporarily result in illiquid markets and higher volatility in prices and currencies.

#### Risks materially relevant not adequately captured by the SRRI

- ▶ **Exchange rate risk** Investing in assets denominated in a currency other than that of the investor's own currency perspective exposes the value of the investment to exchange rate fluctuations.
- ▶ **Liquidity risk** Liquidity is a measure of how easily an investment can be converted to cash without a loss of capital and/or income in the process. The value of assets may be significantly impacted by liquidity risk during adverse market conditions.
- ▶ **Derivative risk** The value of derivative contracts is dependent upon the performance of an underlying asset. A small movement in the value of the underlying can cause a large movement in the value of the derivative. Unlike exchange traded derivatives, over-the-counter (OTC) derivatives have credit risk associated with the counterparty or institution facilitating the trade.
- ▶ **Emerging market risk** Emerging economies typically exhibit higher levels of investment risk. Markets are not always well regulated or efficient and investments can be affected by reduced liquidity.
- ▶ **Operational risk** The main risks are related to systems and process failures. Investment processes are overseen by independent risk functions which are subject to independent audit and supervised by regulators.
- ▶ **Concentration risk** Funds with a narrow or concentrated investment strategy may experience higher risk and return fluctuations and lower liquidity than funds with a broader portfolio.

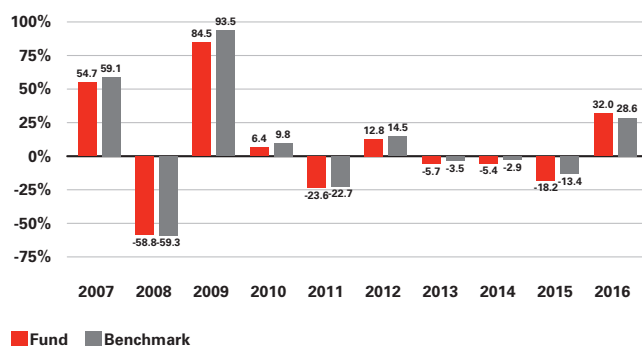
The Entry and Exit charges shown are the maximum that may be charged. In some cases you may pay less. You can obtain the actual charges from your financial adviser.
