

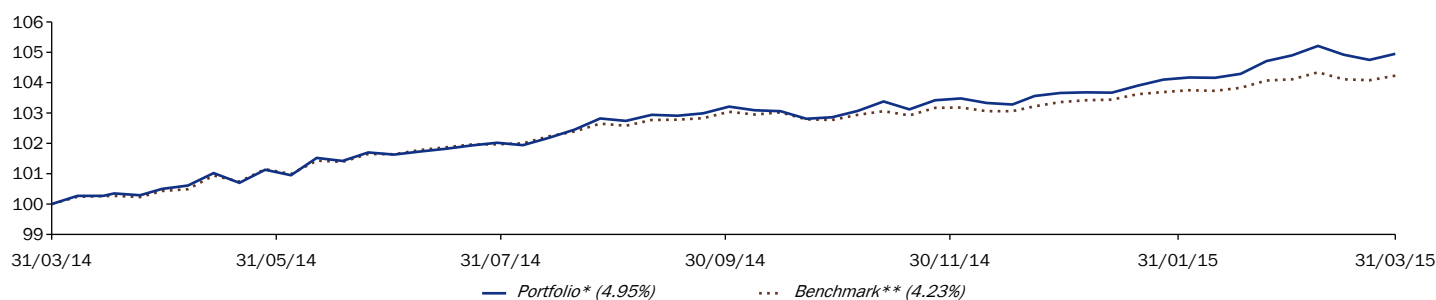

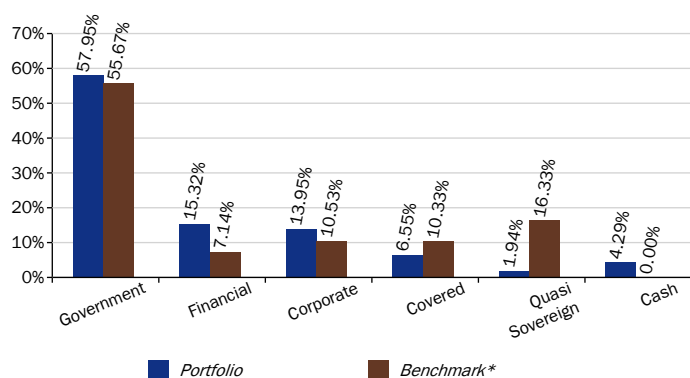

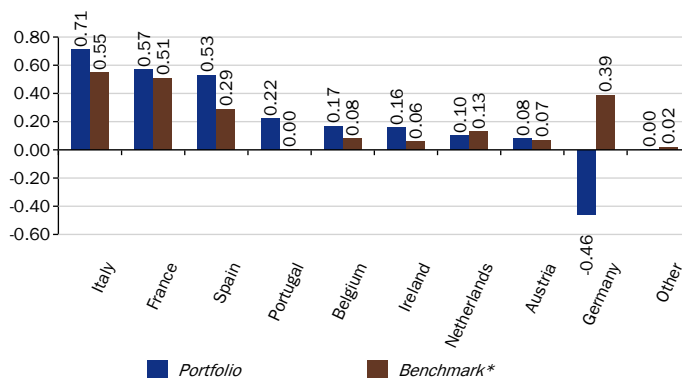

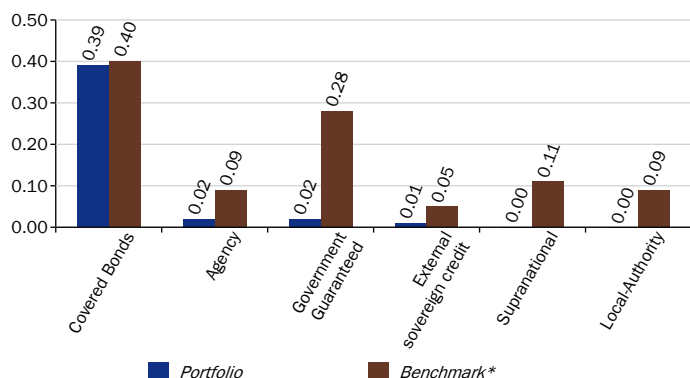
Asset class breakdown



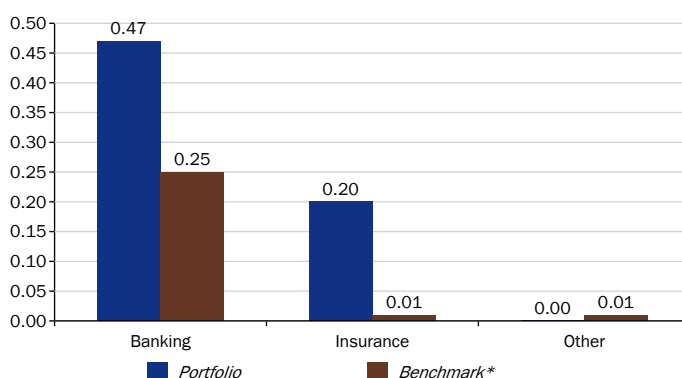
Contribution to duration of sovereign debt by country



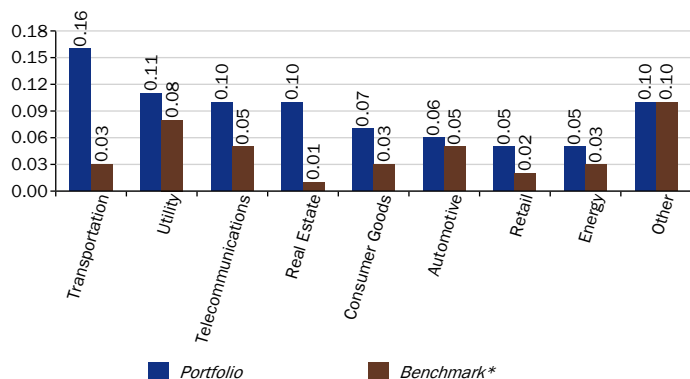
Contribution to duration of quasi sovereign debt by sectors



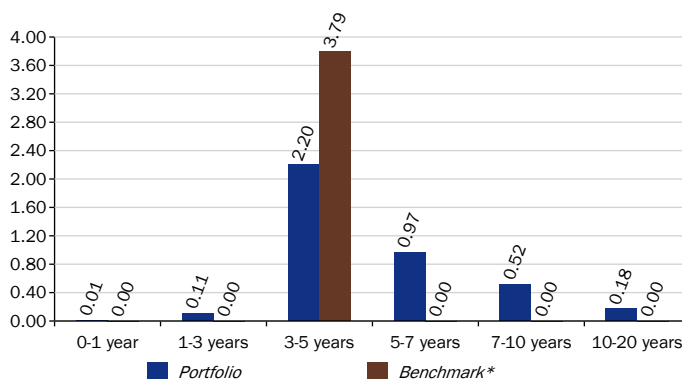
Contribution to duration of financial debt by sector

Contribution to duration by maturity

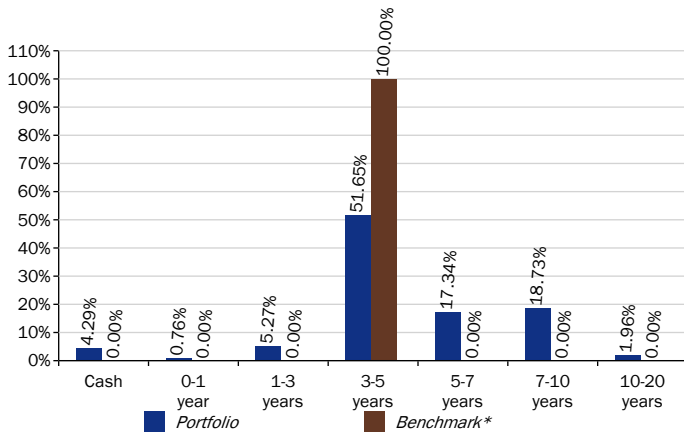

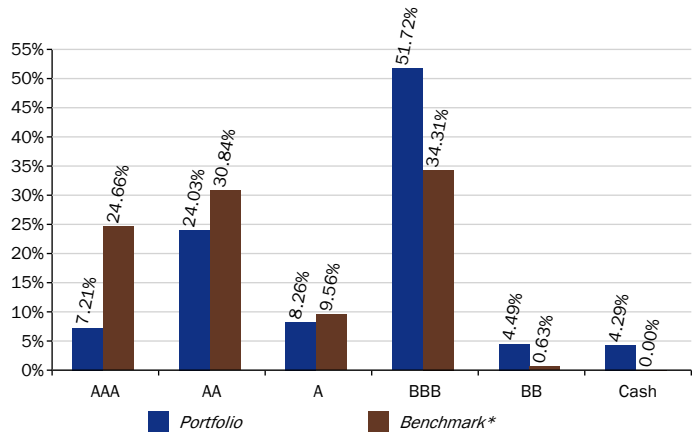

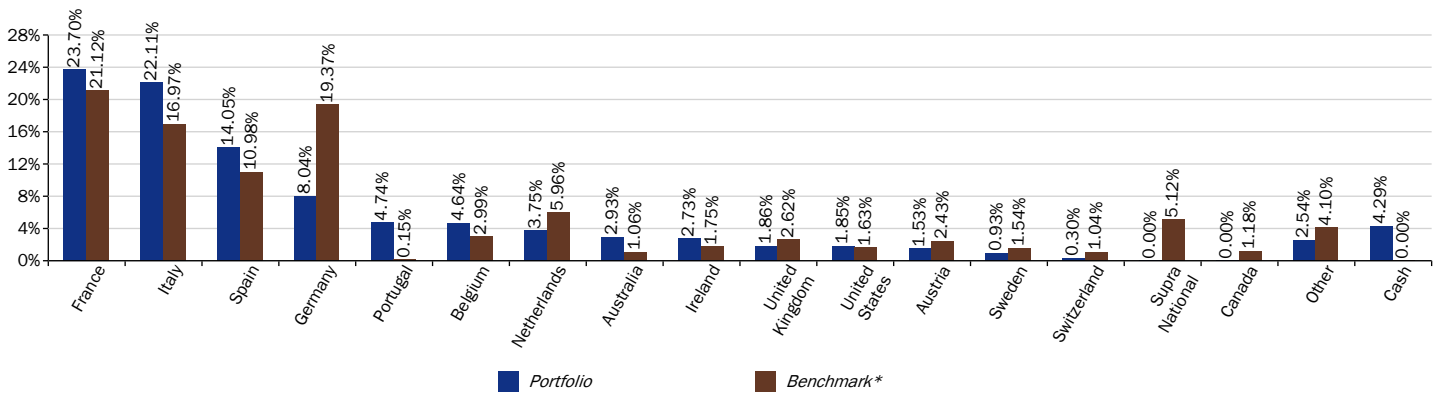
Maturity breakdown
