Objective and Investment Policy

Investment Objective

The Sub-Fund's investment objective is to seek performance by investing mainly in the emerging market universe and to a broader extent in bonds world wide, over a long term period.

Investment Policy

The Sub-Fund is actively managed in order to capture opportunities in emerging markets debt, while limiting its credit risk. The following investment decisions are undertaken after comprehensive macroeconomic and microeconomic analysis of the market:

- geographical allocation
- duration positioning (duration measures in numbers of years the portfolio's sensitivity to the interest rate variations)
- yield curve positioning (the yield curve illustrates the relation between investment term and bond yield)
- issuer selection

The Sub-Fund invests:

- at least two thirds of its assets in debt securities issued in emerging countries (Latin America, Eastern Europe, Asia, Africa, Middle East) by governments or quasi government issuers as well as private or public companies denominated in USD, Euro or local currencies
- up to one third of its assets in money market instruments
- up to 20% of its assets in debt securities denominated in local currencies, unhedged

The Sub-Fund may invest up to 5% of net assets in contingent convertible bonds (CoCos).

Within a limit of 200% of the Sub-Fund's net assets, the investment strategy may be achieved by direct investments and/or through derivatives, especially by entering into Credit Default Swaps. Derivatives may also be used for hedging purposes.

Income

For Capitalisation share classes (Cap), the dividend is reinvested.

Sub-Fund Currency

The reference currency of the Sub-Fund is USD.

Investment Horizon

This Sub-Fund may not be suitable for investors who plan to withdraw their contribution within 6 years.

Processing of subscription and redemption orders

The subscription, conversion or redemption orders must be received by the Registrar and Transfer Agent on any Valuation Day no later than 3 p.m. Luxembourg time. Orders will be processed at the Net Asset Value applicable to the following Valuation Day. The investor's attention is drawn to the existence of potential additional processing time due to the possible involvement of intermediaries such as Financial Advisers or distributors. The Net Asset Value of this Sub-Fund is calculated on a daily basis.


