Report of the Board of Directors

Macro-economic Background

The Global Economy and Financial Markets in 2018

When it rains, it pours: This was the lesson of 2018 which experienced two particularly painful risk averse episodes in early February and in the autumn. We had warned about a difficult year for asset returns, due to both a deteriorating growth-inflation mix and elevated asset price valuations, but things proved to be even worse than we expected for equities.

World growth eased off from 3.7% in 2017 to an estimated 3.6% in 2018 - a very moderate slowdown that nevertheless was enough to reduce investor confidence. We see five main forces behind the negative market reaction:

- 1) The strong and continued upward revisions in global growth in 2017 were followed by downward revisions in 2018, but, in addition to the level of growth, momentum is also important.
- 2) Some regions, like the euro area (EA) and China, slowed down more severely. EA growth eased from a whopping 2.5% in 2017 to an estimated 1.8% in 2018. This remains above potential, but a weak second half of the year (with growth of just +0.2% qoq) fanned fears of a harder landing. We should keep in mind, however, that the EA economy had to cope with the delayed effects of rising oil prices and a strengthening euro in 2017, as well as new emission regulations in 2018. Those drags should dissipate going forward.
- 3) There was great variety among regional growth rates in 2018, with President Trump's fiscal stimulus helping the US economy. This strengthened the US dollar, which in turn increased idiosyncratic disruptions in emerging markets (Turkey, Argentina).
- 4) The economic outlook was clouded by political tensions, including the trade war, heated discussions about the Italian budget, and difficult Brexit negotiations.
- 5) Last but not least, the US Federal Reserve (Fed) continued to normalize monetary policy, in particular raising its key rate four times to the 2.25-2.50% target range. It is not a coincidence that the two large equity sell-offs in 2018 occurred after 10-year Treasury yields increased significantly, while in December both equity prices and long-term government bond yields dropped simultaneously.

A rising tide lifts all boats: Years of very relaxed monetary policies had in fact raised all asset prices. 2018 will be remembered as the year when that tide started to recede, and asset prices reacted accordingly. A record share of asset classes recorded negative returns. The deterioration in the global cooperative stance further eroded the appetite for risk. The MSCI World, hedged in EUR, had enjoyed average returns of nearly 12% in the five-year period ending in 2017, but it lost 9.38% in 2018. Credit spreads also surged from record low levels. EUR Investment Grade spreads virtually doubled from the record lows of January to above 150bp. Likewise, EUR High Yield spreads doubled from the lows of Q4 2017 to above 500bp. This will provide better carry (cushion) going forward, but led to negative returns for the asset class in 2018. The 10-year BTP-Bund spread nearly tripled between April and November to more than 325bp, and then dropped to 250bp by year-end. Crude oil prices were another big mover mainly due to concerns of excess supply, with Brent first rising \$20 to above \$85/bbl and then plummeting below \$60/bbl. This should bolster global consumer trends in 2019. European corporations will also enjoy the delayed effects of a weaker currency, as the EUR/USD exchange rate dropped from 1.25 in February to less than 1.15 in December.

Economic Outlook 2019

We expect world growth to slow further in 2019, although moderately (3.2%). Growth should ease in the euro area from 1.8% to 1.0%, in China from 6.6% to 6.2%, and in the US from 2.9% to 2.3%. Note that the US will see a slowing, which is in sharp contrast to 2018 when the country single-handedly rescued global growth. President Trump's fiscal stimulus will, however, now run out of steam and he no longer has House support for substantial fiscal relief. The US economy will also face headwinds created by the rise of both interest rates and the US dollar in 2018. Rate-sensitive sectors, such as business investments and housing, are already showing signs of fatigue.

As its sharp divergence in economic performance ends or even reverses, the USD will lose strength. This should offer moderate support to emerging market assets, though the Chinese slowdown and the ongoing trade war will limit the upside.

The Fed should very cautiously continue to normalize policy and switch off the autopilot. In other words, it would become more data-dependent; we expect one hike in 2019. We expect the European Central Bank (ECB) to proceed also very cautiously with its exit strategy. QE is over, but the first rate hike is likely to come only at the very end of the year, after Draghi has left. The People's Bank of China (PBOC) should continue to ease prudently, mainly via further cuts in the required reserve ratio. Both the euro area and China will also deliver modest fiscal easing.

News related to the trade war suggests some progress in US-China negotiations. Given the upcoming 2020 elections, we suspect that President Trump cannot afford a full-blown, mutually destructive trade war. One (large) risk that recently become more probable is that he would instead turn to Europe and impose tariffs on automobiles, which would hit the German economy particularly hard. Our scenario also includes a Brexit deal and some de-escalation in the EU-Italy standoff. We nevertheless expect nervous trading up into the European elections in late May.

What about the impact on global financial assets? As the tide of relaxed monetary policy slowly ebbs, the outlook remains challenging. Furthermore, concerns about the age of the cycle will not disappear. Assuming the US economy grows, the cycle will celebrate its 10-year anniversary by mid-2019, matching the longest on record (1991-2001). This creates an asymmetry for risky assets, i.e. a limited upside and a larger downside.

Our scenario still predicts moderately positive (single digit) returns on equities. The late 2018 sell-off was exaggerated, especially in Europe, where economic confidence deteriorated. We see little value in government bonds, with 10-year Bund yields likely to gain approximately 50bp as net buying from the ECB ends. While credit markets look oversold, especially in Europe where spreads now appear too high as compared to the US, some further spread widening is likely over the year, amid fading central bank support and softer growth. One should, however, pay attention to the asymmetry since, once the US economy turns down (we do not see a recession around the corner), spreads may widen significantly.

Remuneration Policy

Generali Investments Luxembourg S.A. (the “Management Company”) has designed and implemented a remuneration policy which is consistent with and promotes sound and effective risk management by having a business model which by its nature does not promote excessive risk taking that is inconsistent with the risk profile of the SICAV. The Management Company’s remuneration policy integrates governance, pay structure and risk alignment rules that are designed to be consistent with the business strategy, objectives, values and interests of the Management Company, the SICAV and the shareholders of the SICAV, and includes measures to avoid conflicts of interest.

Description of the calculation of the remuneration and benefits

The amount of the fixed remuneration of the employees is determined in the respective individual contracts. The level of fixed remuneration may be, without being required thereto, oriented on the basis of market value and any other applicable standards, as for instance, a statutory minimum social wage or the indications of a collective bargaining agreement as it may be applicable from time to time.

The Management Company will, in principle, attribute to eligible employees, a variable compensation if the Management Company has made (for the concerned calendar/financial year) a gross profit, whereby the gross profit is determined at a stage before the payment of taxes and elements of the variable remuneration.

A specific personnel evaluation tool is used in order to determine the amount of variable remuneration to be attributed to each eligible employee. Performance criteria are established for each individual with goals according to performance, effectiveness and engagement perspectives.

Remuneration Committee

The Management Company has appointed a remuneration committee which reports to the Board of Directors of the Management Company.

Therefore the gross total remuneration paid during 2018 by the Company to the personnel involved in the management of the specific fund is equal to EUR 51,028.95 (gross total amount), split respectively into the fixed component equal to EUR 38,163.07 and in the variable component equal to EUR 12,865.88.

Euro Equity

For the management of the Euro Equity sub-fund, Generali Investments Partners S.p.A.'s structures are equal to 1.39 units expressed in terms of full time equivalent, whose gross overall remuneration is 0.41% of the gross total remuneration of the Company's staff. Therefore the gross total remuneration paid during 2018 by the Company to the personnel involved in the management of the specific fund is equal to EUR 153,647.10 (gross total amount), split respectively into the fixed component equal to EUR 106,571.31 and in the variable component equal to EUR 47,075.79.

Euro Equity Controlled Volatility

For the management of the Euro Equity Controlled Volatility sub-fund, Generali Insurance Asset Management S.p.A.'s structures are equal to 0.89 units expressed in terms of full time equivalent, whose gross overall remuneration is 0.24% of the gross total remuneration of the Company's staff. Therefore the gross total remuneration paid during 2018 by the Company to the personnel involved in the management of the specific fund is equal to EUR 89,510.76 (gross total amount), split respectively into the fixed component equal to EUR 63,816.16 and in the variable component equal to EUR 25,694.60.

Euro Future Leaders

Therefore the gross total remuneration paid during 2018 by the Company to the personnel involved in the management of the specific fund is equal to EUR 31,788.06 (gross total amount), split respectively into the fixed component equal to EUR 25,336.53 and in the variable component equal to EUR 6,451.53.

Euro Short Term Bond

For the management of the Euro Short Term Bond sub-fund, Generali Investments Partners S.p.A.'s structures are equal to 0.49 units expressed in terms of full time equivalent, whose gross overall remuneration is 0.10% of the gross total remuneration of the Company's staff. Therefore the gross total remuneration paid during 2018 by the Company to the personnel involved in the management of the specific fund is equal to EUR 38,201.69 (gross total amount), split respectively into the fixed component equal to EUR 29,612.04 and in the variable component equal to EUR 8,589.64.

Total Return Euro High Yield

For the management of the Total Return Euro High Yield sub-fund, Generali Investments Partners S.p.A.'s structures are equal to 1.02 units expressed in terms of full time equivalent, whose gross overall remuneration is 0.28% of the gross total remuneration of the Company's staff. Therefore the gross total remuneration paid during 2018 by the Company to the personnel involved in the management of the specific fund is equal to EUR 105,544.84 (gross total amount), split respectively into the fixed component equal to EUR 74,504.95 and in the variable component equal to EUR 31,039.89.

Absolute Return Credit Strategies

For the management of the Absolute Return Credit Strategies sub-fund, Generali Investments Partners S.p.A.'s structures are equal to 0.44 units expressed in terms of full time equivalent, whose gross overall remuneration is 0.08% of the gross total remuneration of the Company's staff. Therefore the gross total remuneration paid during 2018 by the Company to the personnel involved in the management of the specific fund is equal to EUR 31,788.06 (gross total amount), split respectively into the fixed component equal to EUR 25,336.53 and in the variable component equal to EUR 6,451.53.

Absolute Return Multi Strategies

For the management of the Absolute Return Multi Strategies sub-fund, Generali Investments Partners S.p.A.'s structures are equal to 0.44 units expressed in terms of full time equivalent, whose gross overall remuneration is 0.08% of the gross total remuneration of the Company's staff. Therefore the gross total remuneration paid during 2018 by the Company to the personnel involved in the management of the specific fund is equal to EUR 31,788.06 (gross total amount), split respectively into the fixed component equal to EUR 25,336.53 and in the variable component equal to EUR 6,451.53.

Global Multi Asset Income

For the management of the Global Multi Asset Income sub-fund, Generali Investments Partners S.p.A.'s structures are equal to 0.74 units expressed in terms of full time equivalent, whose gross overall remuneration is 0.19% of the gross total remuneration of the Company's staff. Therefore the gross total remuneration paid during 2018 by the Company to the personnel involved in the management of the specific fund is equal to EUR 70,269.86 (gross total amount), split respectively into the fixed component equal to EUR 50,989.62 and in the variable component equal to EUR 19,280.24.

Global Income Opportunities

For the management of the Global Income Opportunities sub-fund, the gross total remuneration paid during 2018 by Wellington Management International Ltd to the personnel (2 units) is equal to EUR 62,938.50, split into the fixed component equal to EUR 15,276.34 and into the estimated variable component equal to EUR 47,662.16.

Income Partners Asian Debt

For the management of the Income Partners Asian Debt sub-fund, the Income Partners Asset Management (HK) Limited's structures are equal to 37 units (number of personnel) expressed in terms of full time equivalent, whose gross overall remuneration is approximately 3.30% of the gross total remuneration of the Company's staff. Therefore the gross total remuneration paid during 2018 by the Company to the personnel involved in the management of the specific fund is equal to EUR 169,723 (gross total amount), split respectively into the fixed component equal to EUR 90,691 and in the estimated variable component equal to EUR 79,023.

Report of the Investment Managers

Equity sub-funds

The **Central & Eastern European Equity** sub-fund finished 2018 with a return of (14.25)% (class A Accumulation), below its benchmark (-10.55%). The sub-fund was exposed to Central and Eastern Europe countries (in particular Poland and Hungary) and to Turkey. Towards the end of the year, some exposure to Austria was added. For the sake of diversification, the sub-fund invested also into Czech Republic, Romania, Slovenia, Croatia and Austria. From a sectorial point of view, the sub-fund was mainly exposed to financials and energy. Despite underweighted position to economically and politically distressed countries in Q4, the portfolio was not able to eliminate the large decline from the first half of the 2018. In the last quarter, central European equities were preferred because of their relatively stronger macro fundament and stabilizing or even slightly improving corporate earnings. The equity exposure remained above 90% with exception of the very short periods in November and December when large inflows were received.

The **Euro Equity** sub-fund finished 2018 with a return of (15.17)% (class B Accumulation), below its benchmark (-12.72%). During the year, the portfolio was overweight in telecoms and healthcare. On the flipside, it was underweight on real estate, industrials, and financials and to a lesser extent on utilities, energy and technology. The sub-fund kept 2% to 8% cash in order to avoid market volatility. On geographical level, the sub-fund was particularly exposed to France whereas it had no exposure to Austria, Portugal nor Ireland. The stock picking in healthcare (Merck, Sanofi, Essilor), telecoms (Orange, Deutsche Telecom) and energy (Eni, Total) contributed the most to the performance, whilst industrials (Saint Gobain, Bouygues, Spie) and materials (Thyssen, Imerys) had a negative impact. In addition, some stock picking bets like Eni, L'Oréal, Vivendi, Safran and Carrefour have contributed strongly to the performance over the year. Compared to the benchmark, not having equities like Kering, Pernod Ricard and Wirecard contributed negatively to the performance.

The **Euro Equity Controlled Volatility** sub-fund finished 2018 with a return of (15.34)% (class A Distribution). The investment objective of the sub-fund is to generate equity like returns with a pre-defined volatility target of 12.5%. Portfolio allocation between risky assets and non-risky component is rule based: if the ex-ante EWMA volatility is below the target of 12.5%, the equity exposure is progressively increased. In periods of ex-ante EWMA volatility above the target, based on the investment strategy, equity exposure is progressively decreased (potentially down to zero) and funds are reallocated into cash and/or money market type of instruments. At sector level, the portfolio was particularly exposed to financial and consumer discretionary sectors, while utilities and communication services were kept underweight. At geographical level, Netherlands was preferred to Spain and Belgium. The cash equity portfolio maintained an ex-ante tracking error volatility below 2.0% with respect to the Euro Stoxx 50 Index during the reference period. During the year, equity exposure fluctuated between 80% and 125%.

The **Euro Future Leaders** sub-fund finished 2018 with a return of (21.73)% (class A Accumulation), below its benchmark (-18.42%). In 2018, European equity markets were driven mainly by short-term momentum and company valuation was not really taken into consideration, even though valuation based on a discounted cash-flow model, is key. In that context, the relative performance of the sub-fund was affected in 2018 by few stocks that sharply underperformed after a slight disappointment. It was the case of Atos (IT services), Imerys (mineral-based specialties), Prysmian (global leader in high voltage cable industry) or Kion (leader in industrial trucks), which are still considered as very attractive investment cases. The strategy consists of identifying and supporting companies that will establish and reinforce their leadership over the coming years. Currently, the preference is on one hand on companies offering a solid track-record, a predictable business model, and high visibility like Gerresheimer (global glass and plastic packaging producer for healthcare industry), Alten (R&D consulting), SGS (Testing Inspection Certification) and on the other hand, on companies with strong fundamentals and a very low valuation (Prysmian, Amundi, Atos).

The **European Equity Recovery** sub-fund finished 2018 with a return of (15.58)% (class A Distribution), below the Eurostoxx total return (-13.2%). The portfolio is composed of around 45 south European equities, purely selected through a stock picking process. This process focuses on companies' ability to generate cash flows after a recovery and/or a restructuring phase. As a pure bottom-up approach, the alpha generation relies solely on stock picking (as opposed to sector or geographical allocation for example). The strong annual performance of Almirall (+63% after a weak 2017) and Banco BPI (+25%) is to be highlighted. On the negative side, the sub-fund was hit by weak performance of Mota Engil (-56% over 2018 after a stellar 2017) and Salini (-55%). At the geographical level, the sub-fund was entirely exposed to Italy, Greece, Portugal and Spain. During the year, equity exposure fluctuated between 94% and 99%, the remaining being non-invested cash.

The **Global Equity** sub-fund finished 2018 with a return of (3.10)% (class A Distribution), above its reference benchmark (-4.11%). The sub-fund maintained a diversified exposure to global equity markets. The sub-fund closed 2018 being in the first quartile of its Morning Star category. The equity portfolio was concentrated mainly in the US and Europe (UK included). The sub-fund kept a more marginal exposure towards Japan and Canada. ETF positions were tactically added in order to take exposure towards some specific themes. From a geographical point of view, the sub-fund was aligned with its reference benchmark, with some preference towards the US. The sub-fund did not take exposure to the Hong Kong market. Concerning the sectorial exposure, financials and health care were the heaviest sectors, followed by IT and industrials. In terms of industries, the stance has been slightly countercyclical and pro-defensive. During the year, the portfolio was almost fully invested, with an equity exposure swinging between 90% and 100%. The sub-fund held a higher-than-usual cash buffer (~7%) in the last quarter to mitigate the spike in volatility.

The Board of Directors of the Fund resolved to terminate the sub-fund **Greater China Equity** with effect as of 12 March 2018.

The Board of Directors of the Fund resolved to terminate the sub-fund **Special Situation** with effect as of 17 May 2018.

The **SRI Ageing Population** sub-fund finished 2018 with a negative return of (8.47)% (class A Accumulation) in a difficult context for European equity markets, with MSCI Europe index generating (10.6)% return over the same period. The portfolio was rather concentrated with less than 60 portfolio lines at the end of the period and it was formed by selecting companies that: 1) Are socially responsible, according to our proprietary methodology. 2) Operate in segments that are expected to benefit from the megatrend of the ageing of the population 3) Being exposed to at least one of the three investment pillars (healthcare, pension & savings, consumers). 4) Operate solid business models with a strong cash generation ability and showing a decent upside potential on the sub-fund's discounted cash flow model. Due to the thematic nature of the sub-fund, the sector positioning was skewed towards certain industries such as healthcare (through pharmaceutical groups and providers of medical equipment and services), financials (mainly through life insurances and asset gatherers/managers), and consumer companies (through luxury and personal care groups). The weight of the three investment pillars at the end of the period stood at 33% for healthcare, 20% for pension & savings and 47% for consumers. At the geographical level, the sub-fund was particularly exposed to France, United Kingdom and Germany.

The **SRI European Equity** sub-fund finished 2018 with a return of (12.82)% (class A Accumulation), below its reference benchmark (-10.57%). The investment process remained focused on stock picking and based on a sector-agnostic approach with the objective of favouring stocks with robust and growing cash-flow generation abilities. The main negative contributors to the relative performance were companies which are non-compliant with the ESG criteria (absence of Novartis, Nestle, GSK, Sanofi, BP in portfolio explains around 130bp of underperformance) and asset managers such as Anima and Standard Life Aberdeen (down respectively 41% and 38% over the period) for which the financial environment was expected to drive future outflows. At the end of the year, the sub-fund was particularly exposed to consumer discretionary and healthcare at sector level, whilst underweight in consumer staples and utilities, and to France at the geographical level, with Switzerland and United Kingdom as underweight countries.

The Board of Directors of the Fund resolved to terminate the sub-fund **Asian Bond** with effect as of 12 March 2018.

The Board of Directors of the Fund resolved to terminate the sub-fund **Asian Credit** with effect as of 12 March 2018.

Bond/ Debt sub-funds

The **Central & Eastern European Bond** sub-fund finished 2018 with a return of (0.61)% (class A Distribution). The portfolio, focused on the CEE region, consists primarily of local currency government bonds (Poland, Czech Republic, Hungary and Romania). The sub-fund bears both foreign exchange (FX) and duration risk. The sub-fund's performance was impacted in Q2 by a spillover of negative sentiment from global emerging markets, thus ignoring decent fundamentals of CEE economies. This was seen as an opportunity and the significant inflow into the sub-fund (funds size increased from EUR 77 mio to 392 mio in July) was used as a chance to increase exposure to local currency bonds and almost eliminate EUR denominated bonds of CEE governments. The sub-fund performance recovered significantly in the second half of the 2018 benefiting from both appreciation of currencies and declining yields. The sub-fund will continue its strategy to benefit from convergence of CEE countries via appreciation of the currencies' FX and higher carry of the local government bonds.

The **Convertible Bond** sub-fund finished 2018 with a return of (5.85)% (class A Accumulation). The portfolio had a selective approach in terms of credit quality, with a bias on issuer with strong fundamentals. For this reason, the sub-fund kept a defensive profile in terms of credit exposure. Along the year, the delta of the sub-fund (equity sensitivity) was in the 40%-20% range. Equity sensitivity was managed actively to optimize the convexity of the product and to protect the sub-fund from the unfavourable market conditions. The sub-fund continued to be diversified in terms of sector and country allocation with an average of 60 positions. The main exposure by country were Germany and France, whilst the most represented sectors are industrials and real estate. The convertible bucket in USD was in the 10%-20% range.

The **Euro Bond** sub-fund finished 2018 with a return of +0.57% (class A Accumulation), below its benchmark (1.00%). During the year, the portfolio's duration was below the reference benchmark; in detail, the duration was moved between 4.5 and 6.0 years, while the average benchmark's duration was around 7.5 years. The portfolio underweighted the rates of all core countries of Eurozone; on average it under invested the short-medium maturities of core countries with negative yields, while the exposure to the longer maturities was closer to neutral. The peripheral countries (Italy, Spain and Portugal) were overweight during the year. The exposure to Italian BTPs was moderately long up to May, with an overweight to short-medium maturities and underweight to longer maturities (10+ years). After the sharp increase of Italian rates in May and the higher observed level of volatility, the investments in Italian bonds were managed in a more tactical way, moving the duration between neutral and overweight. The portfolio was invested also in inflation-linked bonds and had no credit exposure. It used futures on rates for hedging purposes or managing the exposure to interest rate risks.

The **Euro Bond 1-3 Years** sub-fund finished 2018 with a return of (0.10)% (class A Accumulation) overperforming its benchmark by 0.02%. During the year, the portfolio's duration was managed between neutral and below the reference benchmark; in detail, the duration moved between 1.2 and 1.9 years, while the average benchmark's duration was around 1.9 years. The portfolio underweighted the rates of all core countries of Eurozone; on average it under invested the short-medium maturities of core countries with negative yields but it was exposed to longer maturities outside the benchmark. The portfolio overweight peripheral countries (Italy, Spain and Portugal) during the year. The exposure to Italian BTPs was moderately long up to May, with an overweight to short-medium maturities. After the sharp increase of Italian rates in May and the higher observed level of volatility, the portfolio invested in BTP was managed in a more tactical way, moving the duration between neutral and overweight. It was invested also in inflation-linked bonds and had no credit exposure. It used futures on rates for hedging purposes or managing the exposure to interest rate risks.

The **Euro Bond 3-5 Years** sub-fund finished 2018 with a return of (0.44)% (class A Distribution), below its benchmark (-0.05%). During the year, the portfolio's duration was managed below the reference benchmark; in detail the duration between 2.0 and 3.3 years, while the average benchmark's duration was around 3.7 years. The portfolio underweighted the rates of all core countries of Eurozone; on average it under invested the short-medium maturities of core countries with negative yields while it was exposed to longer maturities outside the benchmark. The portfolio overweight peripheral countries (Italy, Spain and Portugal) during the year. The exposure to Italian BTPs was moderately long till May, with an overweight to short-medium maturities. After the sharp increase of Italian rates in May and the higher observed level of volatility, the portfolio invested in BTP was managed in a more tactical way, moving the duration between neutral and overweight. It also invested in inflation-linked bonds and had no credit exposure. It used futures on rates for hedging purposes or managing the exposure to interest rate risks.

The **Euro Corporate Bond** sub-fund finished 2018 with a return of (3.23)% (class A Accumulation), below its benchmark (-1.25%). It has been a quite difficult year for corporate bonds in general, that returned very negative absolute and excess return figures. Just for reference, the benchmark's return was 2.49% lower than a generic index of government bonds. Main detractors to relative performance were the overweight to subordinated bonds, in particular corporate hybrids and insurance (two of the best segments of previous years), and a short duration bias maintained along the course of the year in line with a house view of increasing core interest rates that finally never materialized. The dispersion of returns among sectors and issuers also contributed to the negative performance of the sub-fund and provided a very challenging environment for implementation of bond picking framework.

The **Euro Corporate Short Term Bond** sub-fund finished 2018 with a return of (1.15)% (class A Accumulation), below its benchmark (-0.24%). It has been quite a difficult year for corporate bonds in general, that returned both very negative absolute and excess return figures. The short end of the curve was not immune to this even if the benchmark was at least able to close flat in terms of excess returns against a generic index of government bonds. Main detractors to relative performance were subordinated bonds' overweight, in particular corporate hybrids and insurance (two of the best segments of previous years), and a short duration bias maintained along the course of the year in line with a house view of increasing core interest rates that finally never materialized.

The dispersion of returns among sectors and issuers also contributed to the negative performance of the sub-fund and provided a very challenging environment for implementation of bond picking framework.

The **Euro Covered Bond** sub-fund finished 2018 with a return of +0.26% (class B Accumulation), in line with its reference benchmark (+0.26%). The sub-fund duration has been actively managed and its positioning has changed across the year, moving from a slightly overweight duration vs. benchmark as of 31/12/2017 (4.94 years vs. 4.59 years benchmark) to a gradual underweight duration vs benchmark as of 31/12/2018 (4.05 years vs. 4.60 years benchmark). Regarding the geographical positioning, a constant overweight on European peripheral countries was kept (namely Spain and, in a second degree, Italy). In addition, an overweight in Australia and underweight on European core countries (namely France, Germany and Netherlands) was kept. The geographical positioning was driven by an opportunistic basis. Most of the sub-fund exposure was in covered bonds. However, a tactical position in Italian sovereign bonds was opened additionally to benefit from relevant yield component.

The **Euro Short Term Bond** sub-fund finished 2018 with a return of (0.50)% (class A Accumulation), below its benchmark (-0.26%). During the year, the portfolio's duration was managed between 0.1 and 0.9 years. It was mainly invested in short-medium maturities (up to 3 years) of Italian bonds. The portfolio was also invested in other peripheral countries (Spain and Portugal). The exposure to Italian BTP was moderately long up to May, with an overweight to short-medium maturities. After the sharp increase of Italian rates in May and the higher observed level of volatility, the portfolio invested in BTP was managed in a more tactical way. It was invested also in inflation-linked bonds and had no credit exposure. It used futures on rates for hedging purposes or managing the exposure to interest rate risks.

The **Total Return Euro High Yield** sub-fund finished 2018 with a return of (3.08)% (class A Accumulation). The portfolio was built following a bottom-up approach with a relative preference for issuers with clear fundamental triggers over the short to medium-term and bonds exposed to the front-end of the maturity curve with the objective of getting a constant stream of self-generating cash flows at portfolio level. As a complement to the focus on Euro-denominated high yield assets, some satellite strategies such as emerging markets and US high yield were implemented along the year. Albeit not the primary source of risk, duration was kept relatively low and actively managed during the year. To control volatility and drawdown upon negative risky assets, the bond portfolio was often overlaid with macro hedges.

Absolute Return sub-funds

The **Absolute Return Credit Strategies** sub-fund finished 2018 with a return of (2.27)% (class A Distribution). In 2018, fixed income markets experienced two particularly painful risk-off episodes - in early February and during Q4. There were already expectations of a difficult year for asset returns, due to both a deteriorating growth-inflation mix and elevated asset price valuations but it proved even worse than expected. The sub-fund tried to mitigate the negative effects of such market movements by maintaining a low spread duration stance and playing defensively on high yields, where some shorts using credit derivatives were maintained. On currencies, the sub-fund positively surfed the USD rally, also because this was one of the few asset classes posting positive returns over the course of the year. Approaching year-end, we have increased the pure cash holdings to about 15%, limiting the exposures to financial markets and any possible asset class.

The **Absolute Return Multi Strategies** sub-fund finished 2018 with a return of (4.47)% (class A Accumulation). The sub-fund benefited from its flexible asset allocation to navigate between risk-on and risk-off environments. Overall, the sub-fund maintained a slight overweight towards risky asset classes. During 2018, it was underweight in government bonds, slightly underweight in credit (investment grade and high yield) and overweight in equity. The allocation to government bonds changed during the year. The sub-fund started the year with an underweight in this asset class. The allocation was increased during 2018 due to a slowing pace of global growth, leading the Central Banks to be more dovish and pushing the yield to a lower level (after a spike during the year). Regarding credit, the allocation has been decreasing during 2018. The limited upside for this asset class during the last phase of the economic cycle pushed to maintain a low allocation toward this asset class. The same rationale occurred for the high yield exposure. For equity, the exposure was decreased during the year. In 2018, a geographical reallocation occurred, as the European exposure was trimmed, and the US exposure was increased due to having a more robust growth. In Europe, the increase in political risks after the populist victory in Italian elections decreased the confidence in this geographical area. Due to the potential trade war between the US and China, the allocation towards Emerging Markets was decreased during the year. However, at the year-end, it was reallocated to a higher level. The level of cash has been increasing during the year in order to protect the returns in a more volatile environment.

Multi-Asset Sub-fund

The **Global Multi Asset Income** sub-fund finished 2018 with a return of (9.04)% (class A Distribution). The sub-fund benefited from its flexible asset allocation to navigate between risk-on and risk-off periods. During 2018, the average weights by asset class were the following: 1) Sizeable underweight in government bonds (-7% on average), 2) In credit, investment grade and high yield were slightly underweighted (-4% and -8% on average respectively), 3) overweight in equity (+6% on average). The sub-fund started the year with a strong underweight in government bonds (-13%), the allocation has then been increased during 2018 and finished overweighted at the year-end (+3%). This move was due to a slowing pace of global growth, leading the Central Banks to be more dovish, consequently pushing the yield to a lower level (after a spike during the year). Regarding credit, the allocation has been decreased during 2018 (from 8% to 5%), constantly staying below the strategic asset allocation (with a maximum exposure of 9% vs a strategic weight at 10%). The limited upside for this asset class during the last phase of the economic cycle pushed to maintain a low allocation toward this asset class. The same rationale occurred for the high yield exposure, which decreased from 26% to 17%). The highest point of allocation stood at 27%, below the strategic weight of 30%. On equity, the exposure has been strongly decreasing (from 41% to 34%) during the year. At the lowest point of the year, the sub-fund allocated 30% of its exposure to equity markets (that is also the Strategic weight). During the year, a geographical reallocation occurred, as the European exposure has been trimmed, and the US exposure has been increased, as the growth is more robust in this part of the world. In Europe, the increase of political risks after the populism victory in Italian elections pushed the confidence in this geographical area lower. The allocation towards Emerging Markets has been decreasing during the year due to US-China trade tension. At the year-end, it was reallocated to a higher level. The level of cash has been increasing during the year in order to protect the return in a more volatile environment. In addition, some put spreads were implemented to deliver positive returns during sell-off markets.

Sub-funds dedicated to Generali Group

Global Income Opportunities

The Board of Directors of Generali Investments SICAV resolved to merge the Corporate Opportunities sub-fund into Corporate Opportunities Higher Quality (renamed “Global Income Opportunities”) on 28 September 2018.

For the first three quarters of 2018, the **Corporate Opportunities** sub-fund posted a return of 0.73% (class A Distribution). Top sector exposures in the portfolio included investment grade banks and energy and high yield communications. The key contributors to absolute performance included high yield communications, consumer non-cyclicals and technology. The portfolio's 45% allocation to high yield was the largest sector contributor to performance. At the geographical level in the EMD sector, top exposures were in China and Mexico; and the portfolio was invested in USD-denominated securities only.

For the first three quarters of 2018, the **Corporate Opportunities Higher Quality** sub-fund posted a return of 0.15 % (class A Distribution). Top sector exposures in the Portfolio included investment grade banks, energy, and communications. The key contributors to absolute performance included high yield consumer non-cyclicals, energy and technology. The portfolio's 19% allocation to high yield was the largest sector contributor to performance. At the geographical level in the EMD sector, top exposures were in China and Mexico; and the portfolio was invested in USD-denominated securities only.

The **Generali Global Income Opportunities** sub-fund finished 2018 with a return of (2.35)% (class A Distribution). Top sector exposures in the portfolio included investment grade banks, communications, and REITs. Positive contributors to absolute performance included investment grade banks and REITS, and taxable municipals. Detractors to absolute performance included high yield energy and capital goods companies. At the geographical level in the EMD sector, top exposures were in U.S., Mexico and China; and the portfolio was invested in USD-denominated securities only. In December, collateralized loan obligations (CLOs) were added to the portfolio. The team also began evaluating GBP and EUR denominated securities.

The Board of Directors of the Generali Investments SICAV resolved to terminate the sub-fund **Finisterre Long Only EM Fund** with effect as of 9 February 2018.

The **Income Partners Asian Debt** sub-fund finished 2018 with a return of (4.42)% (class A Distribution). The sharp correction in prices of non-investment grade bonds (2-5 points) and longer dated investment grade bonds were the primary drivers of the negative performance in 2018. The sub-fund continued to maintain a well-diversified Asian credit portfolio, with 92 holdings as of year-end. At the geographical level, the sub-fund was particularly exposed to China and Indonesia. The sub-fund increased exposure in property developers for tactical purposes, as the sector provides higher risk reward. As of year-end, the portfolio's duration stood at 4.1 years and a portfolio YTM of 5.5% respectively.

Independent Auditor's Report

To the Shareholders of Generali Investments SICAV

Opinion

We have audited the financial statements of Generali Investments SICAV (the "SICAV") and of each of its sub-funds, which comprise the statement of net assets and the portfolio as at December 31, 2018 and the statement of operations and changes in net assets for the year then ended, and the notes to the financial statements, including a summary of significant accounting policies.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

In connection with our audit of the financial statements, our responsibility is to read the other information and, in doing so, consider whether the other information is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If, based on the work we have performed, we conclude that there is a material misstatement of this other information, we are required to report this fact. We have nothing to report in this regard.

Notes to the Financial Statements as at December 31, 2018

1. Organisation

GENERALI INVESTMENTS SICAV (the "SICAV") is an investment company, qualifying as a "Société d'Investissement à Capital Variable" incorporated on March 14, 2002 for an unlimited duration pursuant to the law of August 10, 1915 on commercial companies, as amended, and under part I of the Luxembourg law of December 17, 2010 on undertakings for collective investment, as amended. The SICAV is registered at the Luxembourg Commercial Register under the number B86432 and is established at 60, avenue J.F. Kennedy L-1855 Luxembourg.

The SICAV has an umbrella structure and on December 31, 2018, the number of activated sub-funds in the SICAV amounted to twenty-three. The total net asset value of the SICAV decreased by EUR 794 million from EUR 9,543 million as at the end of 2017 to EUR 8,749 million as at the end of 2018. Generali Investments Luxembourg S.A., a limited liability company, "société anonyme", having its registered office at 4, rue Jean Monnet L-2180 Luxembourg has been designated to serve as Management Company of the SICAV.

The Management Company has been designated as management company of the following mutual funds: GENERALI KOMFORT, GENERALI FONDSSTRATEGIE AKTIEN GLOBAL, GENERALI BELGIUM FCP-FIS, VOBA FUND, GP & G FUND, GENERALI BELGIUM REAL ESTATE FCP-SIF, GENERALI DIVERSIFICATION, GENERALI INVESTMENTS GLOBAL SOLUTIONS FUND, DIV TAUX, GENERALI AKTIVMIX DYNAMIK PROTECT 80, GENERALI REAL ESTATE MULTI-MANAGER ASIA FUND S.C.Sp - RAIF, GENERALI SPECIAL SITUATIONS FUND S.C.Sp, RETAIL ONE FUND, and of the following "Sociétés d'Investissement à Capital Variable": GENERALI MULTI PORTFOLIO SOLUTIONS SICAV and GENERALI SMART FUNDS; as well as the Alternative Investment Fund Manager (AIFM) of GENERALI EUROPE INCOME HOLDING S.A. and GENERALI REAL ESTATE ASSET REPOSITIONNING S.A..

The SICAV may issue different classes of shares (class A-B-C-D-E-G-R-Z), as determined by the Board of Directors of the SICAV, which may differ inter alia in their fee structure and distribution policy applying to them. These classes of shares are sub-divided into accumulation of income or distribution of income categories. Classes of shares A, B, C and G are reserved for institutional investors and classes of shares D and E for retail investors.

Class of shares A is reserved only for investments made by the Insurance Companies of Generali Group and also for other investors designated by the Board of Directors of the SICAV.

Class of shares G is reserved only for investments made by the institutional investors approved by the Board of Directors of the SICAV. Class of shares R is reserved to investors in certain jurisdictions and are either themselves or their appointed nominees registered holders of R shares.

Class of shares Z is reserved only for Investments made by the investment funds of Generali Group and also for other investors designated by the Board of Directors of the SICAV.

Classes of shares in currencies other than the base currency of a sub-fund are available for the sub-fund Global Income Opportunities. The hedged shares are covered largely by hedging financial instruments. The objective of the hedging of financial instruments is to cover the exchange-related risks between the currency of a sub-fund and the share's currency. The shares hedged against currency risk are denominated with the letter “H”.

The investment policy of the SICAV is to invest in a range of diversified securities, conforming to the investment policy of each particular sub-fund, with the objective of long term capital growth.

2. Summary of significant accounting policies

Presentation of the financial statements

The SICAV's financial statements are prepared in accordance with the Luxembourg regulations relating to undertakings for collective investment in transferable securities.

a) Securities portfolio

The value of financial assets listed on an official stock exchange or dealt in on another regulated market is determined according to their last available price, or in the event that there should be several such markets, on the basis of the latest available price on the main market for the relevant asset.

In the event that the assets are neither listed on a stock exchange nor dealt in on another regulated market or if the price as determined above is not representative of the fair market value in the opinion of the Board of Directors of the SICAV, the value of such assets shall be assessed on the basis of their foreseeable sales prices estimated prudently and in good faith by the Board of Directors of the SICAV.

All investments with a known short term maturity date may be valued by using the amortised cost method. This involves valuing an investment at its cost and thereafter assuming a constant amortisation to maturity of any discount or premium, regardless of the impact of fluctuating interest rates on the market value of the investments. The Board of Directors of the SICAV will continually assess this method of valuation and recommend changes, where necessary, to ensure that the relevant sub-fund's investments are valued at their fair value as determined in good faith by the Board of Directors of the SICAV. If the Board of Directors of the SICAV believes that a deviation from the amortised cost per share may result in material dilution or other unfair results to shareholders, the Board of Directors of the SICAV shall take such corrective action, if any, as they deem appropriate to eliminate or reduce, to the extent reasonably practicable, the dilution or unfair results.

Units or shares issued by open-ended investment funds are valued at their last available net asset value per share/unit or in accordance with the below paragraph where such securities are listed.

Shares or units in exchange traded funds which are listed or quoted on a recognised securities exchange are determined according to their last available price.

b) Cash at bank

The value of any cash on hand and broker accounts are deemed to be the full amount thereof, unless in any case the same is unlikely to be paid or received in full, in which case the value thereof is arrived at after making such discount as may be considered appropriate in such case to reflect the true value thereof.

c) Conversion of items expressed in foreign currencies

The SICAV's financial statements are expressed in EUR. Net assets of each sub-fund expressed in foreign currencies are therefore converted and combined in EUR at the exchange rate in force at the close of the financial year.

Transactions and acquisition costs denominated in foreign currencies are converted into the accounting currency of each sub-fund based on the exchange rate in force on the date of the transaction or acquisition. Assets and liabilities denominated in foreign currencies are converted into the accounting currency of each sub-fund based on the exchange rate in force at the end of the financial year. Any resulting gains or losses are recognised in the Statement of Operations and Changes in Net Assets.

d) Dividend and interest income

Dividend income is accounted for on an ex-dividend basis, net of withholding tax. Interest income is recognised on an accrual basis. The tax reclaim amounts received are recorded in the Statement of Operations and Changes in Nets Assets in the account Net dividends.

e) Allocation of costs and expenses

Specific costs or expenses are charged to each sub-fund. Non-specific costs and expenses are usually distributed between the sub-funds in proportion to their respective net assets.

f) Financial future contracts

Open financial future contracts are valued at their last known price on the valuation date or on the closing date. The unrealised appreciation or depreciation on financial futures is disclosed in the accounts. (Note 8)

g) Forward foreign exchange contracts

Outstanding forward foreign exchange contracts are valued at the closing date by reference to the rate of exchange applicable to the outstanding life of the contract. The unrealised appreciation or depreciation on forward foreign exchange contracts is disclosed in the accounts. (Note 9)

h) Options

Options are valued at their last known price on the valuation date or on the closing date. The unrealised appreciation or depreciation on options is disclosed in the accounts. (Note 11)

i) Credit default swaps

A credit default swap is a credit derivative transaction in which two parties enter into an agreement, whereby one party pays the other a fixed periodic coupon for the specified life of the agreement. The other party makes no payments unless a credit event, relating to a predetermined reference asset or basket of assets, occurs. If such an event occurs, the party will then make a payment to the first party, and the swap will terminate. The credit default swaps are revalued at each net asset value calculation. The unrealised appreciation or depreciation on credit default swaps is disclosed in the accounts. (Note 10.1)

j) Contracts for difference

Contracts for difference ("CFDs") are over-the-counter financial contracts used to gain exposure to fluctuations (positive or negative depending on the direction of the transaction) in financial instruments, baskets of financial instruments or indices without having to own or borrow the underlying financial instruments.

CFDs are valued by reference to the market value of the underlying assets, taking into account the costs inherent to the transaction. Realised profits or losses and the resulting variation in unrealised profits or losses are included in the statement of operations and changes in net assets. (Note 10.2)

k) Total Return Swaps

A total return swap is a bilateral agreement in which each party agrees to exchange payments based on the performance of an underlying instrument (security, commodity, index,..) thereof for a fixed or variable rate. The total performance will include gains and losses on the underlying, as well as any interest or dividend during the contract period according to the type of underlying. The total return swaps are revalued at each net asset value calculation. The unrealised appreciation or depreciation on total return swaps is disclosed in the accounts. (Note 10.3)

l) Transaction costs

The transaction costs, i.e. fees charged by the brokers and the Custodian for securities transactions and similar transactions are recorded separately in the Statement of Operations and Changes in Net Assets in the account "Transaction costs".

m) Securities lending

The SICAV may lend portions of its securities portfolio to third parties. In general, lendings may only be effected via recognised clearing houses, or through the intermediary of prime financial institutions that specialise in such activities and in the modus specified by them. The income earned from the securities lending program is detailed in the Statement of Operations and Changes in Net Assets in the account "Net Securities lending income". (Note 14)

3. Determination of net asset value of shares

The net asset value as presented in the annual report was calculated based on valuation prices as at on December 31, 2018.

The net asset value per share of each class of shares in each sub-fund is determined by dividing the value of the total net assets of that sub-fund properly allocable to such class by the total number of shares of such class outstanding on such valuation day.

4. Taxation

The SICAV is registered in Luxembourg and as a result, is exempt from tax except for the “taxe d’abonnement”. Under current legislation, institutional classes of shares (classes A, B, C, G, R and Z) or monetary sub-funds are subject to a tax rate of 0.01% per annum, those reserved to retail investors (classes D and E) are subject to a tax rate of 0.05% per annum. The tax is calculated and payable quarterly on the net assets of the SICAV at the end of the relevant quarter.

The value of assets represented by investments in other Luxembourg UCIs/UCITS which have already been subject to the “taxe d’abonnement” is exempt.

5. Management fees

The SICAV pays for the various sub-funds and by class of shares an annual aggregate fee (the “Aggregate Fee”) accrued on each valuation day as a percentage of the net assets and payable quarterly in arrears. The Aggregate Fee may be used to pay the Management Company for the portfolio management, the Investment Managers, any Distributors and/or any permanent representatives in places of registration of the SICAV or any sub-fund.

The Management Company is entitled to receive an administrative fee for all its administrative activities at an annual rate of 0.10% of the net assets accrued on each valuation day and payable monthly in arrears.
