Objectives and investment policy


El Fondo trata de incrementar el valor de sus activos a medio plazo invirtiendo en acciones emitidas por empresas de Rusia o que operen en dicho país.

El equipo de inversiones aplica asimismo la Política de inversión sostenible de BNP PARIBAS ASSET MANAGEMENT, que tiene en cuenta los criterios ambientales, sociales y de gobernanza (ESG, por sus siglas en inglés) en cada etapa del proceso de inversión del Fondo, incluidos, entre otros, la reducción de las emisiones de gases de efecto invernadero, el respeto de los derechos humanos o el respeto de los derechos de los accionistas minoritarios. Una estrategia extrafinanciera puede incluir limitaciones metodológicas, como el riesgo de inversión ESG definido por el gestor de activos. Los criterios ambientales, sociales y de gobernanza (ESG) contribuyen a la toma de decisiones del gestor, pero no constituyen un factor determinante.

Los ingresos se reinvierten sistemáticamente.


