## What is this product?

Type: Debt security

Objectives: ETFS GBP Daily Hedged Physical Gold is designed to enable investors to gain exposure to the gold spot

price with a daily currency hedge against movements in the GBP/USD exchange rate by tracking the MS Long Gold British Pound Hedged Index (the "Index"). The product reflects the performance of the underlying spot price such that, for example, if the spot price were to rise in value by 5% over a period, the product would increase in value by 5% over that same period (before fees, expenses and adjustments) and if the spot price were to fall in value by 5% over a period, the product would fall in value by 5% over that same period (before fees, expenses and adjustments). The product is an exchange traded product ("ETP"). Securities in this ETP are structured as debt securities and not as shares (equity). They are traded on exchange just like shares in a company. This ETP is backed by physical allocated Gold held by an independent custodian, JPMorgan Chase Bank, N. A. and, in order to gain the currency hedge, swaps with Morgan Stanley &Co. International plc. The payment obligations of the swap counterparty to the Issuer are settled in physical gold which is also held in a segregated account with the custodian. Only metal that conforms with the London Bullion Market Association's (LBMA) rules for Good Delivery for gold and silver can be accepted by the custodian. Each physical bar is

segregated, individually identified and allocated.
